We have performed an audit of the accompanying financial statements of Porter Automotive Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Porter Automotive Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Porter Automotive Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was formed on January 1, 1990 for the benefit of the employees of William H. Porter, Inc., RCP III, L.L.C. T/A Porter Nissan Infiniti, RCP IV, L.L.C. T/A Porter Ford and Affordable Rental Car, L.L.C. (the "Employer"). The Plan is a "salary reduction plan". It is also called a "401(k) plan". The Plan is subject to the Employee Retirement Income Security Act of 1974 and all requirements of Section 401(k) of the Internal Revenue Code. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Participation

Employees who are 21 years of age and older are eligible to participate in the Plan on January 1, April 1, July 1, or October 1 following the consecutive 12 month period (commencing on the employee's date of hire or anniversary date thereof) during which the employee worked at least 1,000 hours. Effective January 1, 2024, all long term part time employees who are at least 21 years of age, and have worked between 500 to 1,000 hours in 2021, 2022, and 2023 are eligible to contribute as a part of the SECURE ACT 2.0. Individuals who are union employees, non-resident aliens, employees acquired in a code Section 410(b)(6)(c) transaction, or leased employees are not eligible to participate in the Plan.

Contributions

Employees may choose to make contributions to the Plan on a pre-tax basis, an after-tax basis or a combination of the two up to the IRS maximum allowable amount. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Each employer will make a contribution equal to 25% of the first 6% of each participant's contribution on salaries and wages. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollovers). Employers may, at their discretion, make a profit sharing contribution to the Plan. There was no profit sharing contribution made as of December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Forfeitures

Forfeitures are used to reduce employer contributions for a succeeding Plan year. Forfeitures were not used to reduce employer contributions in 2024. Forfeitures in the amount of \$1,924 and \$1,646 were available at December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and with an allocation of (a) the employer's contribution, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Vesting

Participants are fully (100%) vested in all participant salary reduction amounts and related earnings. Employer contributions and related earnings are subject to a vesting schedule based upon the participant's years of service as follows:

<u>YEARS OF VESTING SERVICE</u>	<u>VESTED PERCENTAGE</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Participants shall be fully vested in their entire account upon the attainment of age 65 or upon their death or disability prior to termination.

Investment Options

The Plan offers various pooled investment options in which a participant may elect to invest. A participant may change their investment option specification with respect to contributions to be made in the future and with respect to amounts already in their Individual Account by giving notice of the change to the Plan using either an automated phone line or the internet.

Payment of Benefits

Upon retirement (age 65 or later), disability, or death, the participant will receive 100% of their account balance in the form of a lump sum or in the form of installments over a period of years. If the participant's employment terminates for reasons other than retirement, disability, or death, they will be entitled to receive only their vested percentage of their account balance at time of break in service and the remainder of their account will be forfeited. Funds are available with certain constraints under the Plan's hardship withdrawal provision. The Plan permits participants to request an in-service distribution while still employed if they (1) have attained age 59 ½; (2) reached normal retirement age or; (3) have been determined to be disabled.

Participant Notes Receivable

Participants may borrow from their fund accounts; however, the maximum amount of all loans outstanding cannot exceed the lesser of (a) 50% of a Participant's vested interest in the Plan or (b) \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes Fund. Loan terms may not exceed 60 months unless for the purchase of a principal residence of the Participant. Loans bear an interest rate equal to the prime rate plus one percentage point. The minimum amount of any new loan is \$1,000. Principal and interest are paid ratably through payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments in Pooled Separate Accounts (an investment option in a group annuity contract with an insurance company) are valued at the net asset value per share computed for each mutual fund. In the computation of net asset values, securities held by the various funds are valued at prices which equal or approximate market value (quoted market prices). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investments in Guaranteed Interest Accounts (an investment option in a group annuity contract with an insurance company) are valued at the account balance in the insurance company's general account where the funds are held similar to a money market fund except for a guaranteed principal and interest rate.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. A loan is in default when a scheduled installment has not been received by the last day of the calendar quarter following the calendar quarter in which the last scheduled installment payment was due. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

The Plan is funded through employee and employer contributions to a pension fund (trust) managed and operated by an insurance company custodian. Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from the participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan for Controlled Group of Companies Under Common Control

William H. Porter, Inc., RCP III, L.L.C T/A Porter Nissan Infiniti, RCP IV, L.L.C. T/A Porter Ford and Affordable Rental Car, L.L.C. are participant employers in a plan of a controlled group of companies under common control named the Porter Automotive Group 401(k) Plan. Since benefits are payable to participants from the Plan's total assets without regard to contributions by each participant's employer, the Plan has single reporting requirements.

Subsequent Events

The Plan evaluated subsequent events, in accordance with accounting principles generally accepted in the United States of America through July 3, 2025, the date that the financial statements were available to be issued.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The following unaudited information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan.

NOTE 4 - INVESTMENTS

Group Annuity Contract with Insurance Company

The Plan entered into a group annuity contract with John Hancock Life Insurance Company. John Hancock Life Insurance Company maintains the contributions in pooled separate accounts, guaranteed interest accounts, and cash accounts and are invested as follows:

- 1) Pooled Separate Accounts invest solely in units of various mutual funds.
- 2) Guaranteed interest accounts invest solely in the John Hancock Stable Value Guaranteed Income Fund. Assets held in the John Hancock Stable Value Guaranteed Income Fund earn interest on the principal, less any applicable contract or participant-level record keeping charges for the duration the contributions remain in the investment option. Interest rates are established every January 1 and July 1 and will generally be valid for six months. All regular ongoing contributions and contributions already invested in the fund will earn the declared interest rate until the next rate reset. The interest rate will never be less than 1%. The fund is held in the John Hancock General Account, a well-diversified portfolio of investment-grade fixed income investments. This fund is not considered to be fully benefit-response.
- 3) Cash accounts are used to temporarily hold unallocated contributions and forfeitures and are held in the John Hancock General Account.

NOTE 5 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices to active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 5 - FAIR VALUE MEASUREMENT - CONTINUED

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts represents an investment option in a group annuity contract with an insurance company with underlying mutual funds as investments. Unit value is calculated based on the observable Net Asset Value (NAV) of the underlying mutual funds. The NAC is based on the value of the underlying assets owned by the Mutual Fund, minus its liabilities, and then divided by the number of units outstanding.

Guaranteed Interest Accounts represents an investment option in a group annuity contract with an insurance company and is valued at the account balance in the insurance company's general account where the funds are held similar to a money market fund except for a guaranteed principal and interest rate.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, each participating employer has the right under the Plan to discontinue its contributions at any time and the plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 7 - TAX STATUS

The Employer has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document and is relying on the sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the sponsor and the Plan administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan has adopted the provisions of Accounting for Uncertainty in Income Taxes. The standard clarifies the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribes a threshold of more-likely-than-not for recognition of tax benefits of uncertain tax positions taken or expected to be taken in a tax return. The standard also provides related guidance on measurement, derecognition, classification, interest and penalties, and disclosure.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risks, market risks, credit risks and other economic factors. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
