NOTES TO FINANCIAL STATEMENTS YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Regal Plastic Supply Company (the “Company”) 401k Profit Sharing Plan and Trust, (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions, which is available from the Plan Administrator.

Effective January 2023, the Plan changed its custodian, recordkeeping functions and investment options to Newport Group. Plan assets transferred to the new custodian were transferred into funds comparable to those offered by the previous custodian. The conversion initiated a blackout period beginning January 4, 2023 and continuing through February 3, 2023. During this period, funds could not be applied to the employee selected funds with the custodian or withdrawn from the plan until the custodian could accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, and the contributions were deposited and held in the income fund until the completion of the blackout period. At the end of the blackout period, such funds were transferred to the investment options requested by each participant.

- a. General – The Plan is a defined contribution plan covering all full-time employees of the Regal Plastic Supply Company (the “Company”) who have at least six months of service and are 20½ years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. Contributions – Each year, participants may contribute 1% up to 100% of their gross earnings on a tax deferred basis subject to the maximum allowable deferral contribution as defined in the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions as well as the Company’s contribution into various mutual fund investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Employer matching contributions are determined annually and are at the discretion of the Plan sponsor. The Employer made a discretionary match of 75% of participant contributions up to 4% of eligible compensation during the years ending December 31, 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.
- c. Participant accounts – Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

- d. Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service or meeting other criteria as set forth in the Plan documents. In addition, employees become fully vested upon their normal retirement date.
- e. Payment of benefits – Upon termination of service, an employee may elect to receive either a lump-sum amount equal to the value of his/her account or one of several types of annuities.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½. The Company may also authorize certain withdrawals from a participant's account in the event of proven financial hardship.

- f. Forfeited accounts – Forfeitures are first used to reduce employer administrative expenses and then used to reduce future employer contributions as defined by the Plan.
- g. Participant loans – Participant loans are not permitted under the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- a. Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting.
- b. Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c. Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- d. Payment of benefits – Benefits are recorded when paid.
- e. Administrative expenses – Certain expenses of maintaining the plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.
- f. Excess contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.
- g. Subsequent events – The Plan has evaluated subsequent events through the date of the Independent Auditors' Report, the date which the financial statements were available for issue.

3. INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (the Custodian of the Plan).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer, and certain others. As such, transactions conducted by or with these parties qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. PLAN TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there

are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. EXCESS CONTRIBUTIONS PAYABLE

The Plan failed the Average Deferral Percentage (ADP) test for the 2023 plan year. The accompanying statements of net assets available for benefits include \$189 as of December 31, 2023, in excess participant contributions payable to participants related to these issues. The excess contributions payable balance was returned by the Plan to the participants in 2024.

11. PROHIBITED TRANSACTIONS

The Company failed to remit to the Plan certain participant contributions within the period prescribed by the Department of Labor's (DOL) regulations in 2024 totaling \$20,431. Delays in remitting contributions to the Plan were due to administrative errors and constitute prohibited transactions. The Company intends to reimburse the Plan for lost income once the amount has been computed. The Company does not believe the corrective payments due to the Plan will be material.

12. SELF-CORRECTION PROGRAM

During 2024, the Plan discovered that certain employer matching contributions for the year ended December 31, 2023, were calculated incorrectly. The company corrected this error, in accordance with the provision of the IRS's Employee Plans Compliance Resolution System. The additional amount required for the correction (\$2,442), was recorded as another employer contribution in 2023, and the Company reimbursed the Plan in 2025.
