Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

NOTE 1 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Cinfed Credit Union 401(k) Plan (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, includes various risks, such as interest rate, credit and overall market volatility. Market risk includes global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

NOTE 1 SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Related Party Transactions / Expenses

Certain administrative functions are performed by the officers or employees of Cinfed Credit Union (the "Plan Sponsor" and "Company"). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events subsequent to the balance sheet date through September 4, 2025, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company, except co-op students, interns, and seasonal employees whose regularly scheduled service is less than 1,000 hours. Employees become eligible after 90 days of employment and after reaching age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

With respect to employee contributions, participants may contribute up to 100% of compensation, as defined by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 in 2024). The Plan has an Eligible Automatic Contribution Arrangement ("EACA") and Qualified Automatic Contribution Arrangement ("QACA"), whereby any participants without an existing salary reduction agreement will be subject to the EACA/QACA and 6% will automatically be withheld from their compensation and remitted to the Plan. The Plan also has an automatic increase of the EACA/QACA. Beginning January 1, 2020 and each subsequent first day of the Plan year, any participants included in the EACA/QACA will be subject to automatic deferral percentage increases of 1% up to a maximum of 10%.

The Plan permits catch-up elective deferrals for participants over 50 years of age subject to Internal Revenue Code limitations (\$7,500 in 2024).

CINFED CREDIT UNION 401(K) PLAN

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Contributions (Continued)

The Company makes a QACA safe harbor employer matching contribution equal to 100% of the first 4% of eligible compensation the participant contributes to the Plan, plus 50% of the next 2%. The Company also has the ability to make an additional discretionary contribution to the Plan. No discretionary contribution was made in 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant's Account

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, including rollovers, plus actual earnings thereon. Participants vest 100% in their QACA Safe Harbor contributions and additional matching contributions after two years of service. With respect to any nonelective contributions, participants vest 33% after two years of service, 67% after three years of service, and 100% after four years of service.

Forfeitures

Forfeitures of the Plan are intended to pay plan expense or reduce future employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,710 and \$2,359, respectively. During 2024, \$3,322 was used to reduce employer contributions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum, equal installments, or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits. Participants may also take an in-service distribution from their matching account if they have attained age 55 and have four years of service.

Notes to Financial Statements (Continued)

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits (Continued)

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their elective deferrals (excluding earnings) necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code. Hardship distributions may only be taken from a participant's elective deferral account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balances. The loans are secured by the balance in the participant's account and bear interest equal to the prime rate at the time of the loan initiation plus 1%. The interest rate on loans outstanding ranges from 9.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Loan payments are made through payroll deductions in equal installments over a period that may not exceed fifteen years for the purchase of a primary residence and five years for other loans from the date the loan was made. Participant loans outstanding as of December 31, 2024 and 2023 was \$208,584 and \$152,219, respectively.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes to Financial Statements (Continued)

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

Mutual funds: Valued using quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

The following information provided by Empower Trust Company, LLC, the custodian of the Plan, for the years ended December 31, 2024 and 2023 was certified by them to be complete and accurate with respect to the following:

- (a) The assets held at December 31, 2024 and 2023, as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) for the year ended December 31, 2024.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion from the Internal Revenue Service ("IRS") dated November 14, 2022, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since the determination letter was received. The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax exempt as of the financial statement date.

NOTE 7 FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit responsive investment contract ("FBRIC") with Empower Life & Annuity Insurance Company ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

NOTE 7 FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

Under certain circumstances Empower may terminate the contract, causing a loss of interest adjustment that would limit the Plan's ability to transact at contract value. Those events include: 1) the contract holder adopts and amendment to the Plan or operates the Plan in a manner which is unacceptable to Empower; 2) the contract holder fails to comply with any provision continued in the contact; 3) the Plan fails to qualify or becomes disqualified under Internal Revenue Code 401(a), as amended; 4) the total amount of deposits received by Empower in the preceding twelve months is less than \$25,000; 5) the sum of all participant annuity account values falls below \$25,000; 6) the contract holder fails to make deposits which have been deducted from participant's paychecks within 30 days following the end of the month in which such deduction was made; 7) transfers to investment vehicles outside the group annuity contract exceed the limitations provided under the contact; 8) Empower may terminate the group annuity contact if the Plan Sponsor ceases doing business; or 9) this group annuity contact shall terminate if there are no remaining participant annuity accounts. The Plan administrator does not believe that the occurrence of any such event is probable.

NOTE 8 SUBSEQUENT EVENTS

The plan was amended on January 1, 2025, to increase the safe harbor matching contribution to 100% of a participant's elective deferrals that do not exceed 6% of the participant's compensation.
