Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Meadows Farms, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1. Description of Plan

The following description of the Meadows Farms, Inc. (“Company”) 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 1985. The Plan has been amended and restated throughout the years to comply with tax legislation. An employee must complete 1,000 hours of service and be age eighteen or older to be eligible for an employee deferral. Eligible employees can enter the Plan quarterly. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, subject to an indexed maximum as allowed under the Internal Revenue Code, to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. Participant contributions are subject to statutory limitations.

The Plan provides an auto-enrollment contribution, whereby, all newly eligible participants are automatically enrolled with a deferral rate of 3%, unless the participant makes an election to change. Automatically enrolled participants will have their contributions invested in a designated investment until changes are made by the participant.

Participants direct the investment of their contributions, as well as the Company’s contributions on their behalf, into various investment options offered by the Plan. Participants may change their investment options at any time.

The Company may also make matching contributions equal to a discretionary percentage determined by the Company’s Board of Directors. For the year ended December 31, 2024, the Company matched 25% of qualifying employee elective deferrals, not to exceed 15% of their compensation as defined in the Plan.

The Company may also make discretionary profit sharing contributions to the Plan as determined by the Company’s Board of Directors. For the year ended December 31, 2024, no discretionary profit sharing contributions were made.

Notes to Financial Statements

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's discretionary matching and discretionary profit sharing contributions, if applicable, and allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Participants forfeit their non-vested portion of their accounts after five consecutive one-year breaks in service. The forfeited amounts may be used to reduce employer matching contributions or pay administrative expenses. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated on the last day of the following Plan year as an additional employer contribution to active participants who have 1,000 hours of service for the plan year. There were \$20,779 and \$15 of forfeitures used to reduce employer contributions and administrative expenses, respectively, for the year ended December 31, 2024. At December 31, 2024 and 2023, there was a forfeiture balance of \$2,348 and \$1,554, respectively.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service. A participant is also 100% vested in the event of total disability or death or reaching normal retirement age of 60 or early retirement age of 55 with 6 years of vesting service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the amount of the participant's highest outstanding loan balance during the previous one-year period. Principal and interest are re-paid ratably through payroll deductions. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing local interest rates as determined by the Plan administrator.

Payment of Benefits

The Plan provides distribution of accumulated benefits upon death, separation of service, financial hardship, and retirement of participants. On termination of service due to death, disability, retirement or resignation, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. Otherwise, the participant's account balance will be paid out in the form of the life annuity if the participant is single or a qualified joint and survivor annuity if the participant is married.

Notes to Financial Statements

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Delinquent loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Notes to Financial Statements

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments. The amount reported as administrative expenses of the Plan are related to recordkeeping fees on participant loans and processing fees for certain benefit payments that are charged directly to the respective participant account.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – These investments are public investment vehicles valued using the Net Asset Value (NAV) provided by the Administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within level 1 of the valuation hierarchy.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund: Valued at NAV based on the investments and fully benefit responsive investment contracts held within the fund. NAV is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the fund can be redeemed at NAV as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes to Financial Statements

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of different levels.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer accounts.

Note 5. Information Certified by Custodians

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company. Net appreciation in fair value of the investments and dividends for the year ended December 31, 2024, was obtained, or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company and Principal Trust Company.

Note 6. Related Party Transactions

Certain Plan investments are managed by Principal Life Insurance Company, the custodian and record-keeper, therefore, these transactions qualify as party in interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan sponsored by Principal Life Insurance Company. The pre-approved plan provider has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting standards generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements.

Notes to Financial Statements

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.
