Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Family & Children Services, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

NOTE A – Plan Description

The following description of the Family & Children Services, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a contributory, defined contribution retirement plan available to eligible employees of Family & Children Services, Inc. (the Agency). The Agency is the Plan administrator. Employees are eligible to participate in the Plan immediately upon hire. However, for purposes of employer contributions made by the Agency, an employee must have obtained the age of 21, have completed 90 days of service, completed 1,000 hours of service during the Plan year, and be employed on the last day of the Plan year. Participants are eligible to receive employer contributions on the first of the month following the month participation requirements are met. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may specify whether their elective deferrals are to be pre-tax qualifying elective deferrals, Roth elective deferrals, or a specified combination. Participants may contribute the maximum percentage allowable to the extent such percentage does not exceed the annual dollar limits established by law. Participants may also contribute amounts representing distributions from other qualified plans.

The Agency may make a discretionary contribution to the Plan annually as determined by its board of directors. For 2024 and 2023, the Agency's contribution was 50% of the first 6% of the participant's compensation deferred.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Agency's contributions, and an allocation of net Plan earnings. Allocations are based on the participant's account balance as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may direct the investment of their account balances into various investment options offered by the Plan. Currently, the Plan offers a money market fund and mutual funds as investment options.

Vesting

Participants are immediately vested in their elective deferral contributions and any income or loss thereon. Vesting in the Agency's contributions and the earnings thereon is based on the years of continuous service. Participants vest in the Agency's contributions after three years of service. Participant accounts are distributed without regard to the vesting provisions in the event of death, permanent physical or mental disability, or early retirement as defined in the Plan.

Forfeitures

Forfeited, non-vested accounts totaled \$23,750 and \$4,489 at December 31, 2024 and 2023, respectively. The Plan allows the use of forfeitures to first pay administrative expenses of the Plan and, to the extent not exhausted for such expenses, to reduce employer contributions.

Participant Loans

Loans are not allowed under the Plan.

Payment of Benefits

Upon termination of employment, a participant, or a participant's beneficiary in the event of death, may receive the value of the vested interest in their account as a lump-sum distribution. If the vested benefit exceeds \$5,000, a participant, or a participant's beneficiary in the event of death, must elect a lump-sum distribution or installment payments. A joint and survivor annuity option is available for participants with balances transferred to this Plan from the former money purchase pension plans sponsored by the Agency or the Kalamazoo Consultation Center (merged into the Agency in a prior year).

Early withdrawals are allowed only in the event of an immediate financial hardship.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Agency or from Plan forfeitures. Administrative expenses including the amount paid by the agency and plan forfeitures totaled approximately \$43,000 and \$40,000 for the years ended December 31, 2024 and 2023, respectively.

NOTE B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair market value. Fair value is the price that would be received from an asset sale or paid to resolve a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of management’s estimates. These estimates affect the amounts reported in the financial statements and the disclosures provided. Actual results may differ from management’s estimates.

Payment of Benefits

Benefits are recorded when paid.

NOTE C – Investments

The Plan’s investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$1,074,327 and \$1,467,604 during the years ended December 31, 2024 and 2023, respectively.

NOTE D – Information Certified by the Plan’s Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Greenleaf Trust (the “Trustee”) has certified that the following data included in the accompanying financial statements and supplemental schedule of assets held at year-end are complete and accurate.

NOTE E – Fair Value Measurements

FASB codified accounting standards for *Fair Value Measurements* and established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds are valued at the net asset value (NAV) of shares held by the plan at year end. Money market funds can be readily converted to cash and are valued at the contract value that represents fair value.

NOTE F – Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provision of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable.

NOTE G – Income Tax Status

The Internal Revenue Service (IRS) ruled on August 7, 2001, that the Non-standardized Prototype 401(k) Profit Sharing Plan and Trust (the prototype plan of Greenleaf Trust upon which the Plan is based) qualifies under Section 401(a) of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to income tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification.

The Plan has been amended since receiving the ruling. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

NOTE H – Party-in-Interest and Reportable Transactions

Certain plan investments are managed by Greenleaf Trust who is the Plan custodian and, therefore, a party in interest. While most of the custodian's investment management fees are paid by the plan sponsor. The Plan, including through the application of forfeitures, paid the custodian \$43,045 and \$40,455 in the years ended December 31, 2024 and 2023, respectively. Additional fees were netted with investment income and paid through revenue sharing.

The United States Department of Labor requires all transactions in excess of 5% of the current value of the Plan's net assets for non-participant-directed investments to be disclosed separately in the financial statements as a reportable transaction. As the Plan's investments are participant-directed, there were no reportable transactions for the years ended December 31, 2024 and 2023.

NOTE I – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – Unallocated Contributions

The Company has contributed both the employee deferral and the Company match to the Plan as each payroll is processed. If an employee leaves employment prior to the end of the year and is not entitled to the Company matching contributions, those funds are maintained in the Plan in an unallocated account. Over the years, the unallocated funds have accumulated. The funds are to be used to reduce future Company contributions. The Company started using these funds during the year ended December 31, 2023. Amounts of the accumulated funds used to reduce Company contributions were \$91,002 and \$60,999 during the years ending December 31, 2024 and 2023, respectively. The remaining balance of the unallocated funds was approximately \$9,400 and \$94,000 at December 31, 2024 and 2023, respectively.
