### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Rite Aid Corporation 401(k) Plan for Collectively Bargained Associates (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



**NOTE 1 DESCRIPTION OF PLAN**

The following brief description of Rite Aid Corporation 401(k) Plan for Collectively Bargained Associates (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan. An individual account is established for each participant and provides benefits that are based on (a) amounts the participant and Rite Aid Corporation (the Company or Plan Sponsor) contributed to a participant's account, (b) investment earnings (losses), and (c) any forfeitures allocated to the account, less administrative expenses charged to the Plan and allocated to participant accounts, if any.

Empower Trust Company, LLC serves as Plan Trustee. The Employee Benefits Administration Committee is the Plan administrator (the Plan administrator) and is responsible for the preparation of the Plan's financial statements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participation**

The Plan includes employees covered by collective bargaining agreements who have negotiated for this plan, as defined in the Plan provisions. Employees are eligible to participate in the Plan after completing 1 year of service and attaining age 21. Eligible employees with Local #1776, Local #75, Local #1360, and Local #1, and Local #1059 are eligible after three months of service and attaining age 21.

**Contributions**

Each year, participants may contribute up to 70% of their annual compensation, as defined in the Plan, as pretax or Roth contributions. Participants age 50 and over may make additional contributions, as defined in the Plan. For employees who have bargained for an employer match, the Plan Sponsor matches 100% of a participant's payroll contribution, up to a maximum of 2% of such participant's compensation. Thereafter, the Plan Sponsor will match 50% of the participant's additional payroll contributions, up to a maximum of 2% of such participant's additional annual compensation. Participants may also contribute, or rollover, amounts representing distributions from another qualified defined benefit or defined contribution plans. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Plan Sponsor's matching contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

Upon termination of service, a participant may elect to receive benefit distributions in one of several forms, including installment payments or lump-sum payments. Benefits are payable upon retirement, termination of employment, or the death or disability of the participant. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Sponsor will authorize the benefit payment without the participant's consent. Prior to March 31, 2024, if the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account (IRA) in the participant's name. Effective April 1, 2024, terminated participants with an account balance between \$1,000 and \$7,000 may have their benefit payment rolled into an IRA in the participant's name.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal, plus 1%. Principal and interest is paid ratably through payroll deductions or as a lump sum for the outstanding loan balance.

**Vesting**

All Participants, except for participants who merged in from the Rite Aid Services, LLC 401K Plan (Services Plan) are immediately vested in their contributions and matching contributions, plus actual earnings thereon. Vesting in the Services Plan matching contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant is fully vested if they terminate due to death, disability, or when turning age 65.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Master Trust's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Plan fees and expenses related to account maintenance, transactions and investment fund management are allocated to participant accounts. Under the terms of the Plan document, costs relating to Plan administration may be paid by the Plan Sponsor or paid from Plan forfeitures. For the year ended December 31, 2024, participant accounts have paid substantially all administrative expenses. Investment-related expenses are included in Master Trust Investment Income.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefit payments to participants are recorded upon distribution.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Trust Company, LLC, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 INVESTMENT IN MASTER TRUST**

The Plan's investments are held in a Master Trust that was established for the investment of assets of the Plan and several other Company sponsored retirement plans. A portion of the Plan's asset portfolio is segregated from the other participating plan's assets within the Master Trust whereas the remaining portion is commingled with other participating plan's assets for investment and administrative purposes.

Although a portion of the assets of all plans are commingled in the Master Trust, the trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans. The net investment income or loss and administrative expenses are allocated by the trustee to each participating plan based on the relationship of the interest of each plan to the total of the interests of the participating plans. For the portion of assets that is segregated, the Plan does not have an undivided interest in each investment in the Master Trust. **NOTE 5 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Common Collective Trusts* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Custom Funds* –The custom funds are unregistered custom accounts maintained by the Trustee. The underlying investments in the custom accounts valued at fair value consist of common collective trusts and mutual funds.

**NOTE 6 PLAN TERMINATION**

The Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Plan Sponsor contributions.

**NOTE 7 PLAN TAX STATUS**

The IRS has determined and informed the Plan Sponsor by a letter dated March 14, 2016, that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

On July 13, 2022, the Plan administrator received a letter from the Department of Labor (DOL) related to the Rite Aid Master Retirement Savings Trust. The Plan administrator responded to the request on October 31, 2022 and May 2, 2023. On December 6, 2023, Rite Aid Corporation entered into a settlement agreement whereby Rite Aid Corporation agreed to reimburse the Rite Aid Master Retirement Savings Trust \$1,165,519 for imprudent investment losses. On January 3, 2024, the DOL filed an unsecured bankruptcy claim against Rite Aid Corporation in the amount of the settlement. As of July 31, 2025 this settlement has not been paid to the Rite Aid Master Retirement Savings Trust.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Master Trust investments are managed by the trustee of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred for the investment management services are included in net appreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 SUBSEQUENT EVENTS**

On May 5, 2025, Rite Aid Corporation filed a voluntary petition for relief under Chapter 11 of the U.S. Bankruptcy Code. The Plan is not a Debtor in the Chapter 11 proceeding. Rite Aid Corporation continues to operate their business as debtors in possession and are in the sales process of substantially all assets. In connection with this process, the possibility exists that the court may terminate the Plan. In the event of a Plan termination, the net assets of the Plan would be distributed in accordance with the provisions of the Plan document. No provision for the preceding uncertainty has been made in the Plan's financial statements.

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.
