## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
PowerSecure, Inc. 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.

- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

**Other Matter**

*Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. **1. DESCRIPTION OF PLAN**

The following description of the PowerSecure, Inc. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the official Plan document for a complete description of the Plan provisions.

**General**

The Plan is a defined contribution plan that was established in 1993 by PowerSecure, Inc. and subsidiaries (collectively referred to as the Company) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (IRC), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is the Plan's sponsor and serves as Plan administrator.

Effective January 1, 2025, Bank of America, N.A. was appointed as custodian of the Plan. Plan assets were liquidated into cash on the close of business December 31, 2024. The assets were subsequently invested and mapped to participant-directed investments on January 2, 2025 at Bank of America, N.A.

**Eligibility**

Employees of the Company are eligible to participate in the Plan after completing one month of service and attainment of age 18, except for collective bargaining employees, leased employees and nonresident aliens, as defined in the Plan.

**Contributions**

Each year, participants may contribute up to 80% of pre-tax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in a designated fund until elected otherwise by the participant. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified, employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

**Employer Match and Profit-Sharing Contributions**

The Company is allowed to make contributions to the Plan in the form of matching contributions, other employer contributions, or profit-sharing contributions, as defined in the Plan and as approved by the Board of Directors (the Board). In 2024, the Company matched 50% of each eligible participant's contribution up to a maximum of 6% of the participant's compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of Company contributions and Plan earnings, and charged with any benefit payments, allocations of Plan investment losses and administrative expenses. Allocation of the Company's contribution is based on participant contributions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are immediately vested in all contributions offered by the Plan.

**Participant Loans**

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time, not exceeding 15 years. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

**Withdrawals and Distributions**

Generally, a participant's vested account balance is payable by lump-sum distribution, between ages 59½ and 73, upon his or her retirement or disability. Upon termination of employment, the vested portion of the participant's account may be withdrawn in a lump sum or left in the Plan.

**Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts are used to reduce administrative expenses and future employer contributions payable under the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$47,208 and \$81,269, respectively. For the year ended December 31, 2024, forfeited balances were used to reduce administrative expenses by \$79,170.

**Administrative Expenses**

Expenses incurred in the reasonable administration of the Plan shall be paid from the Plan unless otherwise paid by the Company.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make

estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

The investments are reported at fair value, which is based on the quoted market price of the investment as of the end of the year. Newport Trust Company, LLC served as trustee of the Plan through December 31, 2024. Charles Schwab is the custodian of the brokerage account.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

General administrative Plan expenses may be paid out of the forfeiture account or paid by the Company. Investment management, distribution and loan-transaction fees are paid by the Plan participants.

**3. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or

liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There were no investments held in the Plan as of December 31, 2024, due to the liquidation of the assets upon transfer of custodian. Plan investments were mapped to participant-directed investments on January 2, 2025. The investments were mapped to approximately \$1 million in money market funds and \$67 million in mutual funds. Both of these types of investments are level 1 and readily marketable.

The following table sets forth by level, within the fair value hierarchy, the Plan’s investments at fair value as of December 31, 2023. There were no Level 2 or 3 investments.

**4. INFORMATION CERTIFIED BY TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the respective trustee of the Plan.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative fees were paid to Ascensus, LLC and affiliates for recordkeeping and trustee/custodian services. Therefore, these transactions qualify as party-in-interest. Fees paid

by the Plan for investment advisory, trustee and recordkeeping services were included in administrative expenses for the year ended December 31, 2024, in the statement of changes in net assets available for benefits.

**6. PLAN TERMINATION**

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate or modify the Plan at any time by resolution of the Board and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

**7. TAX STATUS**

The Plan has adopted a nonstandardized prototype submitter plan sponsored by Ascensus, LLC. The Internal Revenue Service (IRS) has determined and informed Ascensus, LLC by an opinion letter dated June 30, 2020, that the nonstandardized prototype plan is designed in accordance with applicable sections of the IRC. The nonstandardized prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, no provision for taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. The Plan is not currently under IRS examination for any Plan years.

**8. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
