### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CountryMark Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CountryMark Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Note 1. Description of Plan**

The following description of CountryMark Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined-contribution plan established by the Countrymark Cooperative Holding Corporation (Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of the eligible employees of the Company not covered by a collective bargaining agreement. Countrymark Refining and Logistics, LLC and Countrymark Energy Resources, LLC, related employers, also participate in the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

Empower Trust Company, LLC (Empower) serves as the trustee of the Plan and Empower Institutional serves as the recordkeeper.

The Plan is administered by the Retirement Committee of the Company.

### **Eligibility**

Full-time employees age 21 and older are immediately eligible to participate in the Plan. Eligible employees automatically become participants in the Plan for profit-sharing purposes.

Participants' periods of service with Land O'Lakes, Inc. (Land O'Lakes) or any of the Company's member cooperatives are included for determining eligibility and vesting in Employer matching and profit-sharing contributions.

### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 75% of their eligible compensation. Employee Roth, after-tax, and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes matching contributions of 100% of employees' salary deferral amounts on the first 7% of employees' compensation.

Participants are automatically enrolled to defer at 7% unless the participant makes an affirmative election otherwise. Participants may elect to automatically increase their deferral election by 1% each year to a maximum of 10%.

The Company may make additional discretionary profit-sharing contributions, which are allocated as a percentage of compensation based upon the participants' years of service with the Company. The contribution percentage is dependent upon the Company's pre-tax net income as defined in the Plan. The Company paid profit-sharing contributions, net of forfeitures, of \$2,742,408 for 2024 and \$4,935,554 for 2023, which has been recorded as a portion of the employer contribution receivable at year end.

***Vesting***

Participant contributions and earnings thereon are 100% vested at all times. Participants vest in the Company's 401(k) matching and discretionary profit-sharing contributions based upon years of service as follows:

The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce Company contributions or to pay Plan expenses at the discretion of the Company.

***Participant Investment Account Options***

Investment account options available include various funds. Participants direct the investment of their contributions into various investment options offered by the Plan as well as a self-directed fund, which allows participants to direct their contributions into investments of their choice, and may change the allocation daily.

***Participant Accounts***

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer contributions as well as the participant's share of the Plan's income or loss and any related administrative expenses. Allocations are based on the proportion of each participant's account balance to the total of all participants' account balances.

***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$55,986 and \$66,714, respectively. Forfeitures of \$67,189 and \$221,883 were used during 2024 and 2023 to offset 2024 and 2023 contributions, respectively. Forfeitures of \$69,880 was used to offset 2023 contributions that would be considered receivables at December 31, 2023.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$500. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at amortized principal balance plus accrued by unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Participants or beneficiaries receive their benefits generally in one lump-sum distribution, upon termination, disability, death or retirement, as defined in the Plan. Participants can also elect to receive their vested benefit in installments.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Quoted market prices, if available, are used to value investments. The Plan's mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Common stock held in the self-directed brokerage account are valued at the closing price reported on the active market on which the individual securities are traded. The Plan's interest in the stable value fund is valued based on information reported by the investment advisor using the audited financial statements of the fund at year end. The stable value fund provides for daily redemptions with no advance notice requirements and has no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5. Plan Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower Trust Company, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

**Note 6. Plan Termination**

Although it has not expressed intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

**Note 7. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid fees of \$98,731 and \$86,098 at December 31, 2024 and 2023, respectively, to the Plan trustee or custodian. Fees paid to investment advisors totaled \$122,980 and \$106,030 during 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties in interest totaled \$1,553 and \$1,153 during 2024 and 2023, respectively. The Company and participating employers provide certain administrative services at no cost to the Plan.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through July 10, 2025, which is the date the financial statements were available to be issued.
