## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees,  
Plan Administrator and Plan Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Louisville Collegiate School Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Louisville Collegiate School Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Louisville Collegiate School Defined Contribution Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

**Note 1 – Description of Plan**

The following description of Louisville Collegiate School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a 403(b) defined contribution plan established by Louisville Collegiate School (the Plan Sponsor), for the benefit of eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws. The Board of Trustees is responsible for oversight of the Plan. The Finance Committee of the Board of Trustees determines the appropriateness of the Plan's investment offerings and monitors investment performance.

There is no minimum age or service requirement to make pre-tax elective or Roth contributions to the Plan.

**Contributions**

The Plan is funded through employee elective deferrals, Roth and Plan Sponsor contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the Internal Revenue Code (IRC). At the discretion of the Plan Administrator, participants may be permitted to deposit or “roll over” into the Plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. To be eligible to receive employer matching contributions, participants must have completed one year of service and be 21 years or older. Plan participants who have previously participated in a Plan with Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA-CREF) are immediately eligible for the employer match. Once the participant meets eligibility for employer match, the Plan Sponsor will begin matching 100 percent of participants’ pre-tax elective and Roth contributions up to 5 percent of the participant’s eligible compensation.

Participants direct the investment of their pre-tax elective, Roth and Plan Sponsor’s matching contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the Plan Sponsor's contributions, and Plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

## Notes to Financial Statements

### Vesting

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions, rollover contributions from other plans, Plan Sponsor's matching and actual earnings thereon.

### Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- In service
- Hardship
- Termination partial withdrawal
- Rollover source withdrawal at any time

### Plan Expenses

The Plan's expenses are paid by either the Plan or the Plan Sponsor, as provided by the plan document. Expenses paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments. The Plan Sponsor does not intend to request reimbursement from the Plan for these costs.

## Note 2 – Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Reclassification

Certain reclassifications may have been made to the 2023 financial statement presentation to correspond to the current year's format. Total net assets available for benefits are unchanged due to these reclassifications.

## Notes to Financial Statements

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

### **Contributions**

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

### **Payment of Benefits**

Benefit payments are recorded when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to the Plan's year-end, and who had requested a distribution which was approved but not yet paid at year end, if any. There were no unpaid distributions at December 31, 2024 and 2023.

### **Purchase of Annuity Contracts**

Purchases of annuity contracts include payments to insurance companies to purchase annuity contracts that are excluded from plan assets. These annuity contracts consist of participant requests for life annuity payments using a fixed period of fixed payment option.

### **Subsequent Events**

Subsequent events were evaluated through August 1, 2025, which is the date the financial statements were available to be issued.

## Notes to Financial Statements

### Note 3 – Certified Investments

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA-CREF, the custodian of the Plan.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

    Quoted prices for similar assets or liabilities in active markets;

    Quoted prices for identical or similar assets or liabilities in inactive markets;

    Inputs other than quoted prices that are observable for the asset or liability; and

    Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## Notes to Financial Statements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### Variable Annuity Contracts

Variable annuity contracts primarily invest in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio's investment objectives and are valued at the net asset value (NAV) of units held by the Plan at the daily closing price as reported by the fund. The Plan has determined that the variable annuity contracts are classified within Level 1 of the fair value hierarchy. There are no significant unfunded commitments or restrictions on redemption related to these types of investments.

The TIAA Real Estate account is an insurance company separate account investing mainly in real estate and real estate-related investments. The value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. This fund is required to publish its daily NAV and to transact at that price. Since the investment has a readily determinable value, the NAV is not used as a practical expedient.

### Fixed Annuity Contracts

Fixed rate annuity contracts, which are non-benefit responsive, are fully and unconditionally guaranteed and backed by the claims-paying ability of the custodian. These contracts are not available for sale or transfer on any securities exchange, accordingly, transactions in similar investment instruments are not observable. The fixed annuity contract is reported at contract value which approximates fair value. The Plan has determined that the fixed annuity contracts are classified within Level 3 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Fixed Annuity Contract with Insurance Company

The Plan has a fixed annuity investment contract with TIAA-CREF totaling \$4,849,826 and \$4,416,217 as of December 31, 2024 and 2023, respectively. Within this contract are sub-contracts, some of which are fully benefit-responsive while others are not. The fully benefit responsive contracts totaled \$610,464 and \$327,761 at December 31, 2024 and 2023, respectively. TIAA-CREF maintains those contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited. The minimum crediting rates for the fixed annuity investment contracts is between 1% and 3% with the potential for additional interest above the guaranteed minimum, which is declared annually. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code.

## Notes to Financial Statements

2. Premature termination of the contracts.
3. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan).
4. Changes to the Plan's prohibition on competing investment options.
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.
6. Participant-directed transfers from the investment fund in the 90 days preceding the establishment of a competing investment fund.

No events are probable that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

### Note 6 – Prohibited Transactions

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$123 and \$131 for the year ended December 31, 2024 and 2023, respectively, all of which represented employee salary deferrals, that were not remitted timely. These contributions are considered prohibited transactions.

The Plan Sponsor will calculate lost investment earnings and file Form 5330, as applicable, and expects to compensate the plan for the lost earnings in 2025.

### Note 7 – Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives.

The Plan invests in various fixed and variable annuity contracts sponsored by TIAA-CREF. TIAA-CREF is the custodian and record-keeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. Jones, Nale & Mattingly PLC is the independent auditor of the Plan, therefore, these transactions also qualify as party-in-interest transactions. Fees paid by the Plan Sponsor for administrative services for the year ended December 31, 2024 are excluded from these financial statements.

## Notes to Financial Statements

TIAA-CREF received revenue from mutual fund service providers for services TIAA-CREF provided to the funds. This revenue is used to offset certain amounts owed to TIAA-CREF for its administrative services provided to the Plan. If revenue received by TIAA-CREF from such mutual fund service providers exceeds the amount owed to TIAA-CREF for administrative services provided to the Plan, then TIAA-CREF remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to plan administrative expenses or allocated to the accounts of the participants. As of December 31, 2024 and 2023, unallocated revenue credits were \$4,208 and \$5,015, respectively. During the year ended December 31, 2024, \$8,506 was allocated to participants. The credits received in 2024 are included in other income in the statement of changes in net assets available for benefits.

### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 9 – Tax Status

The Plan sponsor adopted a 403(b) volume submitter plan sponsored by TIAA-CREF which received a favorable advisory letter, provided by the plan's qualified tax counsel dated August 7, 2017, which states that the Plan is designed in accordance with Section 403(b) of the IRC and drafted to conform with the requirements of Treasury regulations section 1.403(b)-1. To the extent applicable, the plan document applies the guidance provided in Revenue Procedures 2007-71. Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

### Note 10 – Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to contribute its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Note 11 – Plan Amendment

The Plan has implemented certain requirements by the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act). Written amendments to the Plan to reflect these operational changes were adopted subsequent to year ended December 31, 2024.
