Basis for Opinion

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Huebsch Laundry Co. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 DESCRIPTION OF PLAN

General

The Huebsch Laundry Co. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan covering all full-time employees of the Company who have completed 2 months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

Administrative Expenses

Administrative expenses are generally paid by the Plan or may be paid from forfeitures at the direction of the Plan administrator. The Plan sponsor may elect to pay plan expenses.

Contributions

Each payroll period, participants may elect to contribute either pre-tax or post-tax deferrals, as defined in the Plan document. Participants are automatically enrolled with automatic increases each year with the ability to opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions and account balances into the available investment options offered by the Plan. Participants may change their investments on a daily basis. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may authorize discretionary employer regular matching contributions in accordance with provisions specified in the Plan document.

The Board of Directors of the Company may also authorize a discretionary profit-sharing contribution to the Plan. The participants do not need to make salary reduction contributions to share in the profit-sharing contribution. Such contributions are allocated to participants using a compensation-based formula. At December 31, 2024 and 2023, the Plan had not accrued a discretionary profit sharing contribution.

The Plan provides for qualified non-elective matching and profit-sharing contributions if needed. All contributions to the Plan are subject to certain limitations. In addition, The Plan provides both auto-enrollment and auto-escalation features. An initial auto-enrollment of 1% goes into effect in the second plan year after the participant becomes eligible. An auto-escalation occurs each year, escalating by 1% yearly to a maximum of 3% each year.

Note 1 DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and forfeitures. Also, the participant may be credited with an allocation of the additional profit sharing contribution and the employer matching contribution, if any. Allocations of profit sharing contributions are based on a compensation based formula. Plan earnings are allocated based on participant account balances. Each account may be charged with an allocation of fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested in employer contributions and profit sharing after six years of credited service. A participant is 50% vested in company match contributions after one year, and fully vested after two years.

Forfeited accounts

Participants may also share in forfeited non-vested accounts. Forfeitures related to employer matching contributions can be applied to administrative expenses of the Plan or allocated to participants based on Plan compensation. Forfeitures related to profit sharing contributions can be applied to administrative expenses of the Plan or allocated to participants as additional profit sharing contributions. During 2024, \$1,888 was used to offset employer match and was allocated to participant accounts. Unallocated forfeitures were \$2,459 at year end.

Notes Receivable from Participants

Participants may borrow from their fund accounts (for hardship reasons only) from a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Loan terms may not exceed five years or 15 years for principal residence. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 2%. Payments are made through payroll deductions. Participants are limited to two loans outstanding at any given time.

Payment of Benefits

Upon termination of employment, participants become eligible for benefits from the Plan equal to the vested balance of their accounts. If a participant's vested benefit is \$5,000 or less, it will be paid in a lump sum. If the participant's vested account balance exceeds \$5,000, they may choose to have their benefits paid within the limits set by tax laws and the Plan. Participant benefits must be paid, or distributions must commence no later than the date minimum distributions are required to start under tax laws.

Participants, after reaching retirement age as defined, may withdraw money from their vested accounts for any reason. Plan participants may withdraw rollover contributions plus earnings thereon for any reason. Prior to the retirement age as defined, participants may make hardship withdrawals for purposes defined in the Plan.

Note 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Fair Value Measurements (Continued)

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investment Valuation

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Subsequent events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through July 17, 2025, the date the financial statements were available for issue.

Note 3 INVESTMENTS

Note 4 PLAN TERMINATION

The Company has expressed the intent to terminate the plan during 2024, as outlined in Note 8. The Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

Note 5 INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter on June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan paid recordkeeping and loan fees of \$65,148 and \$44,159 to Empower in 2024 and 2023, respectively.

Notes receivable from participants qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 SUBSEQUENT EVENTS

In December 2024, plan management initiated the process of terminating the Plan. As part of the termination, the Plan will distribute or rollover all remaining plan assets to eligible participants. The distribution of assets is expected to be completed during the 2025 plan year.
