Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Affinity Hospice Management LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Note 1. Description of Plan***

The following description of the Affinity Hospice Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan that was established on August 1, 2015, to provide benefits to all eligible employees. The Plan covers all eligible employees of Affinity Hospice Management LLC and participating affiliates (the Participating Companies) except for those who are non-resident aliens, interns, leased employees and employees covered by a collective bargaining agreement. To be eligible, an employee must have completed twelve months of service, as defined in the plan document, and be twenty-one years of age. The Board of Trustees is responsible for the oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

#### ***Contributions***

Each year, participants may contribute pre-tax and after-tax annual compensation, as defined in the plan document, subject to certain plan and Internal Revenue Service (IRS) limitations. Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Participating Companies make matching contributions equal to 100% of the participants' elective deferrals up to 3% of the participants' plan compensation, and 50% of the participants' elective deferrals from 3% to 5% of participants' plan compensation. The Participating Companies may decide each plan year whether to make discretionary non-elective contributions, allocated on a pro rata basis based on each participant's plan compensation.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and the Participating Companies' matching contributions as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses, if and when such expenses are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Note 1. Description of Plan (continued)***

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Participating Companies' contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a maximum of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Loan repayment terms may not exceed five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing market rates, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

For termination of service due to death, a participant may receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or in installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants may receive an in-service withdrawal upon reaching 59½ years of age. Hardship withdrawals are permitted under the Plan if certain criteria is met.

***Forfeited Accounts***

At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$22,779 and \$8,272, respectively. These accounts are used to reduce the plan expenses.

***Note 2. Summary of Significant Accounting Policies***

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

*Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. If a participant ceases to make loan repayments and the plan administrator deems the participant loans to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

*Expenses*

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Participating Companies. Expenses paid by the Participating Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Note 3. Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level 2:* Inputs other than quoted prices included within level 1 that are observable for the asset or liabilities, either directly or indirectly, such as:

Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023. Registered Investment Companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**Note 6. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by Human Interest Inc., the Plan recordkeeper, and Matrix Trust Company, which serves as the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Human Interest Inc. provides certain administrative services to the Plan pursuant to a service agreement between the Participating Companies or Affinity Hospice Management LLC and Human Interest Inc. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Participating Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the plan of any vested rights. In the event of plan termination, participants would become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan is structured and follows a prototype non-standardized profit-sharing plan, pre-approved by the IRS. The IRS issued an opinion letter dated June 30, 2020, that the prototype plan is acceptable in accordance with applicable sections of the Internal Revenue Code. Although the Plan may have been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe that the Plan is qualified and related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Delinquent Transmittals**

During 2024 and 2023, the Participating Companies erroneously failed to remit certain employee deferrals to the Plan within the period prescribed by the Department of Labor regulations, aggregating \$153,904 and \$170,953, respectively. The Participating Companies will compute the lost earnings on the deposits and remit the deposits along with contributions for lost earnings to the Plan.

**Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 11. Subsequent Events**
