### **NOTES TO FINANCIAL STATEMENTS**

#### **DESCRIPTION OF PLAN**

The following description of the S.L. Williamson Co., Inc. (Company) 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of the Company who have six months of service and are the age of eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Each year, participants may contribute up to 100 percent of pre-tax and post-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional "catch-up" contributions up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants may also elect to designate their salary deferrals as Roth deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The deferral rate is increased 1 percent annually, not to exceed 6 percent.

Discretionary matching contributions may be contributed by the Company in an amount determined at the Company's sole discretion. During 2024 and 2023, the Company made discretionary matching contributions equal to 15% of the total deferred by each participant. For any Plan year, the Company may contribute additional discretionary amounts as determined by the Company. The Company did not contribute any additional discretionary amounts for the years ended December 31, 2024 and 2023.

Participants direct the investment of both employee and employer contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on years of continuous service. A participant becomes 25% vested after one year of service, 50% vested after two years of service, and 100% vested after three years of service.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the vested interest, annual installments over a specified period, or purchase of an annuity contract. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$161 and \$1,117, respectively. Forfeitures can be used to reduce the employer contribution or expenses for the current Plan year or a subsequent Plan year. During 2024, the plan used \$1,327 of forfeitures to pay plan expenses.

## **SUMMARY OF ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the **FAIR VALUE MEASUREMENTS** note for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### ***Payment of Benefits***

Benefit payments are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees related to record keeping activities are charged against participant accounts and are included in administrative expenses. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### ***Subsequent Events***

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

## **INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, the Plan's trustees, and was not subjected to any auditing procedures performed:

- a. Total investments, as shown in the accompanying statements of net assets available for benefits, of \$6,311,246 as of December 31, 2024 and \$5,472,577 as of December 31, 2023.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, of \$637,376 for the year ended December 31, 2024.
- c. All investment-related information, in the accompanying supplementary Schedule H, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024.

### FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Mutual funds are stated at fair value as reported by Ascensus Trust Company (the Plan's trustee), and are based on the fair value of the underlying securities. The fair value of the underlying securities is based on quotations from national exchanges.
- The money market fund is stated at fair value, and is based on the fair value of the underlying securities. The fair value of the underlying securities is based on quotations from national exchanges, quoted bid and ask prices, valuation matrices that incorporate dealer-supplied valuations, and proprietary pricing models, and are valued at amortized cost.

- The Plan's interest in the stable value collective trust is valued at the net asset value (NAV) of units of the trust, which is used as a practical expedient to estimate fair value. The fair value of participation units held in the Reliance Trust Stable Value Fund (MetLife Series 25053, Class 0), a common/collective trust (CCT), is based on net asset value as reported by the manager of the collective trust fund, Reliance Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of, or close to, the financial statement date. The CCT invests in the MetLife Group Annuity Contracts 25053, which consist of separately-managed investment portfolios in fixed income securities, and also enters into wrapper contracts, which are issued by third parties and are designed to allow the Fund to maintain a constant net asset value. The CCT provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements.

Company contributions to the Plan or benefits accrued or paid by the Plan for participants are not considered party in interest transactions.

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Vanguard Group, Inc. provided administrative and recordkeeping services to the plan. Fees paid by the Plan for administrative and recordkeeping services amounted to \$16,834 for the year ended December 31, 2024.

During 2024, the Plan also paid \$18,792 in investment advisory services to Cetera Advisor Networks, a service provider. Payment of these expenses qualifies as party in interest transactions.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**TAX STATUS OF THE PLAN**

The Plan Sponsor adopted Ascensus Inc.’s prototype nonstandardized profit sharing plan document. The Internal Revenue Service has issued an opinion letter dated June 30, 2020 stating that the prototype plan sponsored by Ascensus Inc. is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

## **NOTES TO FINANCIAL STATEMENTS**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
