1. DESCRIPTION OF THE PLAN

The following description of the Pierson Ferdinand LLP 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all eligible employees of Pierson Ferdinand LLP (the Company and Plan Sponsor). Investment management fees and a portion of administrative expenses are paid by the Plan. At December 31, 2024, the assets of the Plan were maintained in investment funds held by Ascensus Trust Company (Ascensus), the Custodian of the Plan. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

Eligibility

Individuals, other than those specifically excluded per the terms of the Plan Document, become eligible to participate in the Plan on their date of hire.

Contributions

For each Plan year, eligible participants may make voluntary pre-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants are also eligible to make Roth elective contributions to the Plan. Additionally, participants who are over the age of 50 are eligible to make an additional "catch up" contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides an automatic enrollment provision in which newly eligible participants are enrolled to contribute 3% of their annual salary, unless the participant elects otherwise. Each subsequent year, the employee's contributions are increased by 1% automatically until the contributions reach 10% of the employee's salary. The employees can also opt out of contributing to the Plan at a date subsequent to their date of hire.

The Qualified Automatic Contribution Arrangement (QACA) safe harbor employer contribution base rate is equal to 100% of employee deferrals for the first 1% of eligible compensation and 50% of employee deferrals for the next 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may receive their accumulated vested benefits held by the Plan's custodian upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability if their account balance is in excess of \$5,000. If the participant elects to keep their interest in the Plan, the participant's account will continue to receive its share of earnings or losses.

1. DESCRIPTION OF THE PLAN (Continued)

Vesting

Employees are fully vested in their elective deferrals plus actual net earnings/losses thereon. Participants become vested in the portion of their individual account derived from QACA safe harbor employer contributions become 100% vested upon completion of one year of service.

Forfeitures

If a participant's employment is terminated, the non-vested portion of their account balance will become subject to forfeiture in accordance with the provisions of the Plan agreement and shall be applied to reduce administrative expenses of the Plan and then used to reduce QACA safe harbor employer contributions. During 2024, no forfeitures were used to reduce administrative expenses.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for the purchase of a principal residence, in which case it may be longer. A participant may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Participants are eligible for retirement benefits upon reaching age 65. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or distributions based on various annuity options or fixed income payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants who have reached age 59½ may take in-service distributions. Participants may also receive hardship distributions under certain circumstances, as defined in the Plan Document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Participant accounts are charged fees for processing loans and benefit payments. Certain fees may be paid by the Plan through reduction of investment income and netted against net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Income Taxes

The Plan uses a prototype plan document sponsored by Ascensus LLC. Ascensus received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024, as well as investment income and investment transactions for the year then ended, has been derived from information provided by Ascensus, the Custodian of the Plan, and has been certified by them as complete and accurate.

4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds and money market funds: Values are determined based on quoted market prices in active markets.

4. FAIR VALUE MEASUREMENTS (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of money market funds and mutual funds managed by Ascensus, the Custodian of the Plan. Transactions in such investments qualify as party-in-interest transactions.

Notes receivable from participants of \$116,157 as of December 31, 2024, with interest ranging from 9.00% to 9.50% also qualify as party-in-interest.

6. RECONCILIATION TO FORM 5500

While net assets available for benefits and change in net assets available for benefits agree between the financial statements and Form 5500 in total as of and for the year ended December 31, 2024, certain classifications differ between the financial statements and Form 5500.

7. SUBSEQUENT EVENTS

Effective May 13, 2025, the Plan was amended to prohibit plan participants from taking loans.

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued.
