NOTE 1 - PLAN DESCRIPTION

The Cars.com, LLC (“the Company”) 401(k) Retirement Plan (“the Plan”) is a defined contribution plan. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The following is a brief description of the Plan. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan was established in 1998 and is subject to the applicable provisions of ERISA. Under the terms of the Plan, all employees of the Company, except union employees, employees of any controlled group employer that does not affirmatively adopt this Plan, and other employees, as defined, are eligible to participate in the Plan as soon as administratively feasible.

The Plan is administered by the Company. The Plan’s trustee is State Street Bank and Trust Company (“State Street”). Transamerica Retirement Solutions (“TRS”) is the Plan’s recordkeeper.

Contributions and Vesting

Participants may elect to contribute on a before-tax basis and with Roth deferrals up to 90% of eligible compensation. The Company makes a safe harbor matching contribution on behalf of the participants for each payroll period. The matching contribution is equal to 100% of the first 3% and 50% of the next 2% that the participant contributes. Contributions are subject to certain limitations. Participants who do not elect a deferral percentage are automatically enrolled at 3%, except for part-time or temporary employees. In the absence of an affirmative election, any automatically enrolled participant’s deferral percentage shall automatically increase by 1% each year until they reach 6%.

Participants vest immediately in all contributions and earnings thereon.

Participant Accounts

Each participant’s own account is credited with the participant’s contribution and (a) the Company’s contribution and (b) the Plan’s earnings or losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Each participant directs the manner in which his or her account is invested based on the investment options available under the Plan.

Notes Receivable from Participants

The Plan provides for loans to participants in an amount not to exceed 50% of the individual’s vested balances or \$50,000, whichever is less, based on certain criteria as set forth in the Internal Revenue Code (“IRC”). Loans bear interest at the prime rate plus one percent as determined by the Plan Administrator. Loans are repayable over a period not to exceed five years or ten years if the loan is used to acquire a primary residence. Principal and interest are paid through payroll deductions. Only one loan per participant may be outstanding at any given time.

Plan Benefits

Upon completion of service through disability, retirement, death, or termination, the participant or beneficiary will receive the account balance in the participant’s account in the form of a lump-sum distribution, installment payments, or deferred distribution. Participants may elect to apply for hardship

withdrawals pursuant to the terms of the Plan. Participants may freely withdraw from their accounts after they are 59½ years old.

Administrative and Investment Management Expenses

Certain of the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company. Terminated participants pay their own recordkeeping fees. Participants pay investment management fees based on their investment decisions.

Plan Termination

The Plan is intended to be permanent; however, the Company reserves the right to amend or terminate the Plan. Upon termination of the Plan, the full value of each participant's account, after payment of all expenses and proportional adjustments for expenses, gains/losses, and allocation of any unallocated funds to the date of termination, shall remain fully vested and non-forfeitable.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Loans deemed default by the Plan Administrator are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Other than fully benefit-responsive investment contracts which are valued at contract value, the Plan's investments are reported at fair value. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

Mutual funds: The fair value of mutual fund investments is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair values of participation units in the collective trust funds are based upon the net asset value ("NAV") of such funds. The NAV is used as a practical expedient to estimate fair value. The stable value collective trust fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirements. The T. Rowe collective trust funds provide for daily redemptions by the Plan at reported net asset share per share but may require a 90-day advance written notice prior to redemption of the trust units. There were no unfunded commitments related to the collective trust funds at December 31, 2024 or 2023.

Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - TAX STATUS OF PLAN

The Internal Revenue Service ("IRS") issued an opinion letter dated June 30, 2020 indicating that the prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The Company has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC and to maintain the tax qualified status of the Plan.

In accordance with U.S. GAAP, tax positions taken by the Plan must be evaluated and a tax liability must be recognized for uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. There is no such tax liability recognized at December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

The Plan holds an investment contract issued by TFLIC which qualifies as a party-in-interest investment. Fees paid to TRS as well as other service providers qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 6 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through September 5, 2025, which is the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.
