Note 1 - Description of plan:

The following description of Convo Communications LLC (the "Sponsor") 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. *General* - The Plan is a defined contribution plan covering substantially all employees of the Sponsor who have reached age 21 and are not a resident of Puerto Rico or covered by a collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations. Effective May 10, 2024, the Plan eliminated the age requirement for eligibility purposes. There are no service requirements or excluded classes of employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was originally established as of January 1, 2010, and has been subsequently amended and restated. The Plan trustees are responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Effective March 31, 2024, the Plan terminated its contract with Voya Retirement Insurance and Annuity Company ("Voya"). Plan assets of approximately \$4,527,000 were transferred out of the Plan's custodial accounts with Voya on April 2, 2024, and deposited to Principal Financial Services ("Principal"), Inc., the new trustee, on April 3, 2024.

- b. *Contributions* - Each year, participants may contribute up to the lesser of 100% of eligible compensation or the maximum amount allowable by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans, commonly referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective January 1 to December 31, 2023, the Sponsor removed the safe harbor matching formula and resumed discretionary employer matching contributions to be determined by the employer each Plan year which are subject to no additional limitations. There were no sponsor contributions for the year ended December 31, 2023.

Effective January 1, 2024, the Sponsor resumed a safe harbor matching formula, calculated semi-annually, contributing 100% of the participant's matched employee contributions that are not in excess of 4% of the participant's plan compensation. Sponsor contributions for the year ended December 31, 2024 were approximately \$452,000.

Note 1 - Description of plan (continued):

Contributions (continued) - Contributions are presented net of corrective distributions which consist of contributions refunded to participants during the Plan year. There were no corrective distributions for the years ended December 31, 2024 and 2023.

- c. Participant accounts - Each participant's account is credited with the participant's contribution and Sponsor contributions, as well as allocations of the Sponsor's contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. Vesting - Participants are immediately vested in their deferral contributions, rollover contributions, Sponsor safe harbor contributions, qualified non-elective contributions, plus actual earnings thereon. Vesting in the Sponsor's employer matching and profit-sharing contributions is subject to a four-year period at 25% per year from years one through four.
- e. Notes receivable from participants - Participants may borrow from their fund accounts from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note receivable repayment terms generally may not exceed five years, except in the case of the purchase of a primary residence. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined quarterly, is set at a range from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator at the origination date of the loan. Principal and interest are paid ratably through payroll deductions. Participants may have up to one loan outstanding at a time.
- f. Payment of benefits - Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59 ½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the Internal Revenue Code ("IRC"). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy. If the value of the vested account balance does not exceed \$5,000, then a lump-sum distribution will be made automatically.

- g. *Forfeited accounts* - Any forfeiture will be first used to reduce administrative expenses. Any remaining forfeitures are then used to reduce employer contributions. The Plan Administrator applied approximately \$16,000 in forfeitures to employer contributions for the year ended December 31, 2024, with no forfeitures applied to employer contributions for the year ended December 31, 2023. Forfeitures remaining in the Plan were approximately \$3,000 and \$16,000 for the years ended December 31, 2024 and 2023, respectively.

Note 2 - Summary of significant accounting policies:

Basis of accounting - The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates - The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The pooled separate accounts are not classified in the fair value hierarchy, however, as a practical expedient, the fair value is measured at Net Asset Value ("NAV") per share of the underlying assets as traded in an exchange or active market. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Note 2 - Summary of significant accounting policies (continued):

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess contributions payable - Amounts payable to the Sponsor for contributions made in excess of the 4% maximum safe harbor match contributions described in Note 1 are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the Sponsor in April 2025.

Payment of benefits - Benefit payments to participants are recorded when paid. At December 31, 2024 and 2023 there were no distributions approved that were not disbursed prior to year-end.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events - Subsequent events are evaluated through the date of the independent auditors' report, which is the date the financial statements were available to be issued and determined that no material subsequent events require an estimate to be recorded or disclosed as of December 31, 2024.

Note 3 - Fair value:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in techniques used for assets measured at fair value.

- Money market accounts - Assets are valued at the NAV, generally \$1 per share, and are reported on the active market on which securities are traded.
- Pooled separate accounts - The underlying assets of the pooled separate account consist of mutual funds known as sub-accounts. Each sub-account invests in shares of an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds using the practical expedient. Certain fund fees, expenses, and administration charges (if any) are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at net asset value on a daily basis.

Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the pooled separate account in order to ensure that securities liquidations will be carried out in an orderly business manner. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies of assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Investments:

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivables from participants was obtained by management and agreed to or derived from information certified as complete and accurate by Principal for April 1 to December 31, 2024 and Voya for January 1 to March 31, 2024 as well as for the year ended December 31, 2023.

Note 5 - Guaranteed investment contracts:

In 2018, the Plan entered into a fully benefit-responsive guaranteed investment contract with Voya totaling \$210,754 at December 31, 2023. This contract was terminated in March 2024. Voya maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1%. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the issuer to terminate the agreement prior to the scheduled maturity date.

In 2024, the Plan entered into a fully benefit-responsive synthetic guaranteed investment contract with Principal totaling \$522,302 at December 31, 2024. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The synthetic guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The synthetic guaranteed investment contract does not permit the issuer to terminate the agreement prior to the scheduled maturity date.

These contracts meets the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya and Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Note 5 - Guaranteed investment contracts:

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet its financial obligations. The issuers' ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuers.

Note 6 - Party-in-interest transactions:

Certain Plan investments are units in pooled separate accounts managed by Voya and Principal. Voya was the trustee, as identified by the Plan, through March 31, 2024, with Principal becoming trustee, as defined by the Plan, effective April 1, 2024; therefore, these transactions qualify as party-in-interest transactions.

Principal provides certain administrative services to the Plan pursuant to an agreement between the Sponsor and Principal. Principal receives revenue from mutual fund service providers for services that Principal provided to the funds. This revenue is used to offset certain amounts owed to the Principal for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by Principal from such mutual fund service providers exceeds the amount owed under the agreement, Principal remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Sponsor may make a payment to Principal for administrative services not covered by revenue sharing.

Note 6 - Party-in-interest transactions (continued):

Notes receivable from participants represent a portion of the Plan's receivables. These transactions also qualify as party-in-interest transactions.

All party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7 - Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Income tax status:

Effective July 15, 2021, the Plan adopted the non-standardized pre-approved profit-sharing plan established by Alliance Benefit Group of Houston ("ABG"), Inc. The non-standardized pre-approved ABG plan obtained an opinion letter on June 30, 2020, in which the IRS stated that the form of the ABG plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has adopted amendments since adopting the ABG plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt through December 31, 2024.

Note 9 - Risks and uncertainties:

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
