(1) DESCRIPTION OF PLAN

The following description of the Muhlenberg College Retirement Plan (“*Plan*”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of Muhlenberg College (the “*College*”). The Plan was adopted January 1, 1946 and was amended on January 1, 2009. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*). All employees who have completed two years of service, defined as 1,000 hours of service during a 12 month period, and who complete 1,000 hours of service during the plan year, are eligible for the plan to the extent of the contribution made by the College. The two year waiting period is waived for employees who were fully vested in a plan with a previous employer.

B. Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (“*IRC*”). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The College makes a contribution of 6% of an eligible employee’s compensation. Contributions are subject to certain Internal Revenue Services (“*IRS*”) limitations.

C. Participants Accounts

Each participant’s account is credited with the College’s contribution and an allocation of the Plan’s earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are 100% vested as soon as they are eligible for the Plan, as defined in the Official Summary Plan Description.

E. Plan Loans

Loans were previously made available to participants who invest in TIAA-CREF products, subject to certain limitations. Such loans were collateralized by the participant’s vested account balance and were generally capped at the lesser of 50% of vested interest balance or \$50,000. Interest was based on rates at the time of loan issuance and repayment was generally over a five-year period. As of January 1, 2022, TIAA-CREF terminated this loan program, and no further loans are being issued.

There were no outstanding loan balances at December 31, 2024. Outstanding plan loan balances were \$1,473 at December 31, 2023. During the year ended December 31, 2024, there were no Plan loan defaults.

F. Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Participant note transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Participant notes range from one to five years, or up to 10 years for the purchase of a primary residence. The participant notes are secured by the balance in the participant account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan administrator. The interest rate on notes receivable bear interest between 4.25% and 9.50%. Principal and interest is paid ratably through semi-monthly payroll deductions generally over five years. Participants can only have one outstanding note receivable at any given time. These amounts are reported as notes receivable from participants in the accompanying Statement of Net Assets Available for benefit. As of December 31, 2024 and 2023, the amount outstanding was \$111,063 and \$111,091, respectively.

G. Investment Options

Upon enrollment in the Plan, and at any time during the plan year, a participant may direct all future employer contributions into any of the investment options available under the Plan.

H. Payment of Benefits

A participant's vested benefits will normally be distributed to the participant or the participant's beneficiary upon termination of service, retirement, disability or death of the participant, by transfer to another qualified plan or individual retirement account, through a lump sum distribution or in installment payments.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant's account are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

I. Administration

The College is the administrator of the Plan. TIAA-CREF has been designated as the custodian and trustee of the Plan. TIAA-CREF maintains individual participant account records and advises the Plan on other matters related to the operation of the Plan.

J. Forfeited Accounts

Forfeited non-vested accounts are used to reduce employer contributions and expenses. As of December 31, 2024, and 2023, there were no forfeited non-vested account balances. Additionally, no forfeited accounts during the years ended December 31, 2024 and 2023 were used to offset employer contributions or were allocated to participant accounts.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Certain TIAA Traditional Annuity contract types are considered fully benefit responsive. The contract value of these annuities approximates fair value for the years ended December 31, 2024 and 2023.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments other than fully benefit-responsive contracts are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

(3) INVESTMENTS

The Plan's investments are held in a directed trust. There are several investment options available to the participants at the time of this report. Participant accounts are allocated based on the decisions of the individual participants. The following tables present the fair value and contract value of these investments which have been certified by the Plan's custodian and trustee as of December 31:

The Plan utilized various methods to measure the fair value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.

Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan’s own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. The summary of inputs used to value the Plan’s assets that are carried at fair value as of December 31 is as follows:

(4) TIAA TRADITIONAL ANNUITY

The Plan offers guaranteed annuity contracts with Teachers Insurance Annuity Association (“**TIAA**”), an insurance company. TIAA maintains the contributions in a general account. The Traditional Annuity is offered through two contract types; Retirement Annuities (“**RA**”) and Supplemental Retirement Annuities (“**SRA**”). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over 10 annual installments. The SRA contracts provide for full participant-directed liquidity and are considered fully benefit-responsive. The contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is obligated to repay the principal and a specified interest rate that is guaranteed to the plan. When a participant’s accumulation in an annuity contract is converted to a lifetime payment annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

The RA contracts are presented within investments on the face of the statement of net assets available for benefits at contract value, which approximates fair value. The SRA contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was approximately \$9,474,000 and \$9,700,000, respectively for the SRA contract. The fair value of the investment contracts at December 31, 2024 and 2023 was approximately \$30,634,000 and 30,800,000, respectively, for the RA contracts. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1% percent. Such interest rates are reviewed periodically for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options of deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(6) TAX STATUS

The trust, established under a prototype plan to hold the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. Although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Management has reviewed the tax positions for each of its open tax years (2021 – 2023) or expected to be taken in the Plan's 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

(7) RISKS AND UNCERTAINTIES

The Plan invests in shares of registered investment companies which employ various investment strategies. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS

Certain administrative costs of the Plan are paid by the employer/sponsor. For the years ended December 31, 2024 and 2023, the Plan has a liability of approximately \$100,000 to reimburse the employer/sponsor for such costs.

The Plan also makes investment options available to its participants in products of the custodian and trustee of the Plan, TIAA-CREF.

Loans to participants are also considered Party-In-Interest transactions.

(9) DELINQUENT PARTICIPANT CONTRIBUTIONS

As of December 31, 2024, there were \$2,100 of participant contributions related to the 2024 plan year, that were not remitted timely. The amounts have been reported on the Supplemental Schedule of Delinquent Contributions accordingly.

(10) SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through August 8, 2025, the date the financial statements were available to be issued.
