NOTES TO THE FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation – The accompanying financial statements of Structural Component Systems, Inc. Profit Sharing Plan (the Plan) are prepared on the accrual method of accounting.

General – The Plan, sponsored by Structural Component Systems, Inc (the Company), is a defined contribution retirement plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Plan Sponsor believes it is in compliance with ERISA. Some administrative expenses related to the Plan are paid by the Company. The Company has no reversionary interest in the Plan.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value based on the latest quoted market prices. The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE B – DESCRIPTION OF PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

Eligibility – Under the terms of the Plan, an employee will be eligible to participate in the plan if they have completed two consecutive months of service and have also attained age twenty one (21). An eligible employee will become a Participant on the first day of the month on or after the date on which the participant met the requirements.

Contributions and Participant Accounts - 401(k) Provision – Each participant may elect to make salary reduction 401(k) contributions of not less than 1% up to 100% of their compensation, as defined, subject to federal deferral limits. Employees over the age of 50, may make “catch-up” contributions subject to federal annual limits. The Company may elect to make matching 401(k) contributions up to \$2,000 for each participant meeting certain requirements. The Company may also make a discretionary nonelective contribution to the Plan. The Company may also elect to make a profit sharing contribution to the Plan. Participant and Company 401(k) contributions are allocated within each participant's account to investment options based upon the participant's current investment allocation elections. Annual 401(k) contributions are subject to limitations set by the Internal Revenue Service.

The Plan also offers automatic enrollment as a feature of the plan and all eligible employees are automatically enrolled at 4% of salary. Employees are given the option to elect out of participation if they choose to do so.

Each participant's account is credited with the participant's elective deferral 401(k) contributions, employer matching 401(k) contributions, an allocation of the Plan earnings and forfeitures of terminated participant's non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant account balances as defined.

The Company did not make any contributions for the years ended December 31, 2024 and 2023.

Forfeitures – Forfeitures are amounts that come from terminated employees (participants) share of employer matching 401(k) contributions that are not vested. Amounts attributable to uncashed checks may be temporarily forfeited if the Plan Administrator is unable to locate the participant after reasonable efforts. Such amounts shall be restored if the participant later makes a valid claim to the benefit. Forfeitures can be used to offset 401(k) plan expenses and employer matching contributions. The Plan forfeiture balance as of December 31, 2024 and 2023 was \$410 and \$1,560, respectively. For the years ended December 31, 2024 and 2023, forfeited amounts total approximately \$2,831 and \$6,773, respectively. For the years December 31, 2024 and 2023, \$4,007 and \$5,641 forfeitures were used to pay plan expenses, respectively.

Vesting – Active participating employees become vested in employer matching 401(k) and nonelective contributions based on years of continuous service. Participants become 100% vested after six years of service. Participants are immediately fully vested in all employee 401(k) contributions.

NOTE B – DESCRIPTION OF PLAN – Continued

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

Benefits – Upon the participant's retirement or termination of service, the Plan shall value and distribute the participant's account in accordance with the Plan document and the Internal Revenue Code. Separate provisions apply in the event of death or disability of the participant. Payments are to be made in a lump sum. Withdrawals prior to termination of employment or retirement are prohibited unless elected by the participant under the following conditions: attaining age 59 ½, establishing permanent and total disability, demonstrating financial hardship, or otherwise allowed by the applicable laws and regulations.

NOTE C – INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Union Bank and Trust (the Custodian of the Plan).

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D – FAIR VALUE MEASUREMENTS – Continued

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common/collective trusts: Common/collective trusts hold investments in domestic and foreign equity securities, debt securities, and units in other affiliated and unaffiliated comingling trusts. The underlying assets may be valued based on quoted market prices, independent pricing service or by dealers making a market for certain securities. The unit value of the common/collective trusts are determined by dividing the underlying net asset values (assets less liabilities) by the outstanding number of units (Level 2).

NOTE E – RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

A party in interest, as defined by Section 3(14) of ERISA, includes, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Accordingly, loans to participants are considered party-in-interest transactions. Fees incurred by the Plan to the trustee for investment and trust services amounted to \$45,962 and \$43,150 for the years ended December 31, 2024 and 2023, respectively. There were fees payable of \$10,761 and \$8,408 at December 31, 2024 and 2023, respectively.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE G – TAX STATUS

The Plan has adopted a pre-approved defined contribution plan document sponsored by Union Bank & Trust Company, which received an IRS Opinion Letter dated June 30, 2020. The Opinion Letter states that the form of the basic plan document and adoption agreement satisfies the applicable requirements of Section 401(a) of the Internal Revenue Code (IRC).

Under IRS Revenue Procedure 2017-41, the Company may rely on the IRS Opinion Letter only to the extent specified therein. This reliance does not extend to the Plan's operational compliance, and certain qualification requirements are excluded from reliance, as outlined in the Opinion Letter and Revenue Procedures 2020-4 and 2020-1, Section 12.

The Plan has not obtained a separate determination letter from the IRS. However, the Plan Administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, continues to qualify under Section 401(a), with its related trust exempt under Section 501(a). Accordingly, no provision for income taxes has been included in the accompanying financial statements.

Plan management evaluates any uncertain tax positions in accordance with U.S. generally accepted accounting principles, which prescribe recognition thresholds and measurement criteria. As of the financial statement date, the Plan had no uncertain tax positions requiring recognition. While the Plan is subject to routine audits by taxing authorities, no examinations are currently in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
