### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Colonial Pipeline Company 401(k) Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Description of the Plan

The following description of the Colonial Pipeline Company 401(k) Investment Plan (the Plan) provides only general information. More detailed information concerning the Plan may be found by consulting the Plan document or the Summary Plan Description, which is available from the Plan administrator.

#### *General*

The Plan was adopted by Colonial Pipeline Company (the Company) effective January 1, 1964. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Administrative Committee is responsible for oversight of the Plan.

#### *Eligibility*

Full-time employees are eligible to participate in the Plan on their hire date. Prior to January 1, 2024, part-time, temporary and seasonal employees were eligible to participate in the Plan after attaining age 21 and completing one year of service. Effective January 1, 2024, the Plan was amended to allow for all part-time, temporary, or seasonal employees who were previously not active participants to become active participants on their date of employment or January 1, 2024. Co-op students and summer interns within the meaning of Code Section 414(n) are excluded from participation in the Plan.

#### *Contributions*

Participants may elect to make pre-tax and/or Roth contributions up to 75% of compensation as defined by the Plan, subject to the limitations of the Internal Revenue Code (IRC). Additional "catch-up" contributions of up to \$7,500 may be made by those participants who have attained age 50 prior to the close of the Plan year. Participants may also make after-tax contributions up to 40% of compensation as defined by the Plan. The aggregate of each participant's tax deferred contributions, Roth contributions and after-tax contributions may not exceed 80% of the participant's compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company matches 100% of participants' contributions up to 6% of each participant's base pay, subject to limits under the IRC. Additionally, the Plan includes Company contributions referred to as Core Savings Contributions (Core Contributions) for the benefit of employees of the Company whose benefits under the Colonial Pipeline Company Retirement Plan have been frozen effective March 31, 2006, and for participants hired or rehired since then. These contributions are equal to 4% of each eligible employee's base pay, subject to limitations of the IRC.

The Plan provides for automatic enrollment and deferrals such that newly eligible or rehired employees are automatically enrolled at 6% of eligible compensation, unless the participant affirmatively makes a different election. Active participants whose deferral election is less than 10%, who have not made an affirmative participant deferral election, will have their participant contribution percentage increased by 1% each year up to 10%, as of the merit increase date.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings (losses) on the investments in their account. Participants direct the investment of their account into various investment options offered by the Plan. The Company currently offers mutual funds and a common collective trust fund as investment options for participants. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

### 1. Description of the Plan (cont.)

#### *Vesting*

Participants are immediately vested in their contributions and Company matching contributions, plus actual earnings thereon. Core contributions fully vest after one year of service.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts relating to Core Contributions totaled \$15,017 and \$5,090, respectively. These accounts may be used to pay administrative expenses or to reduce future Company contributions. During 2024, the Plan used \$4,700 of forfeitures to reduce Company contributions.

#### *Benefit Payments*

At the time of death, disability, termination of service or retirement, the participant or his/her beneficiary may receive payment of the vested interest in their account in a lump-sum distribution, partial withdrawals or annual installments. Under certain qualifying circumstances, hardship withdrawals are permitted under the Plan.

#### *Notes Receivable from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. The loans are secured by the balance in the participant's account. The interest rate is the prime rate plus 1% and is fixed over the life of the note. During 2024, loans had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years, or 15 years if used for the purchase of a primary residence. Principal and interest are paid ratably through bi-weekly payroll deductions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

#### *Contributions*

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Plan Expenses*

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are deducted from net appreciation/(depreciation) of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Certified Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Charles Schwab Trust Bank (Schwab), the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) No. 820 are described as follows:

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets;

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* (or shares of registered investment companies) are valued at the net asset value of shares held by the Plan at year-end by obtaining quoted prices on nationally recognized securities exchanges.

Units of participation of the *common collective trust fund* (Commingled Pension Trust Fund (Stable Asset Income) of JP Morgan Chase Bank, N.A.) are valued at the net asset value (NAV) of units (or its equivalent practical expedient) of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Party-In-Interest Transactions

Schwab performs services, sells products and maintains certain investments of the Plan for which fees are charged to the Plan. Notes receivable from participants are also defined as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions.

### 6. Tax Status

The Plan received a determination letter from the Internal Revenue Service (IRS) dated March 4, 2014, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The Plan obtained a letter from Plan's ERISA counsel dated July 12, 2019, covering amendments through June 14, 2019, stating that counsel believes the Plan has been amended to be in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Core Contributions. If the Company terminates the Plan or discontinues contributions, the Plan's assets are to be used for the exclusive benefit of participants and their beneficiaries at the time of termination.

### 8. Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the Plan's statements of net assets available for benefits.

### **9. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. The legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### **10. Subsequent Events**

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, July 28, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
