INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
MMC Group, LP 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MMC Group, LP 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from John Hancock Life Insurance Company (U.S.A.) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

1. Description of the Plan

The following description of the MMC Group, L.P. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective October 1, 1998. The Plan was amended January 1, 2022. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code ("IRC"), as amended.

Administration

MMC Group, L.P. (the "Company" or the "Plan Sponsor") has appointed employees of the Company to administer the Plan. The Plan investments are managed by John Hancock Life Insurance Company (the "Custodian") as agent for the trustees.

Eligibility

All employees of the Company who have completed three months of service and reached the age of eighteen are eligible to participate in the Plan. Employees will become a participant on the first day of the month following the completion of the eligibility requirements.

Participant Contributions

Annual employee contributions are limited to a maximum of 75% of each participant's annual compensation subject to a dollar limitation. Total elective deferrals made by an employee are further limited by the Internal Revenue Service to a maximum contribution of \$23,000 (\$30,500 if the employee is age fifty or older) adjusted annually by the Secretary of the Treasury for inflation in 2024 and may be made on either a pre-tax basis or a post-tax basis as a "Roth Deferral". Employee contributions to the Plan are made through regular payroll deductions. Participants may stop their elective deferred contributions at any time. Participants may increase or decrease the amount of their contributions monthly.

Employer Contributions

The Company may match, in its sole discretion, contribute and allocate to each eligible participant's account, a percentage of the participant's elective deferrals. Matching contributions, if any, shall be determined as of the end of the Plan year. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors. The Company made \$4,128 in sharing contributions during the year ended December 31, 2024.

Rollovers

Participants may elect to make rollover contributions to the Plan from other qualified plans.

Notes to Financial Statements

Participants' Accounts

Participant accounts are credited with (1) participant contributions, (2) Company matching contributions, if applicable, (3) Company discretionary profit sharing contributions, if applicable, and (4) Plan earnings and forfeitures. Allocations of any profit sharing contributions to participant accounts are based on participant compensation. Plan earnings are allocated pro rata within each investment based on the participant's account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their contributions and allocated earnings thereon. The Company's matching and profit sharing contributions vest as follows: less than one year of service-0%, 1 year-20%, 2 years-40%, 3 years-60%, 4 years-80%, after 5 years-100%. A participant's account becomes 100% vested upon death, attaining normal retirement age, retirement due to disability, or if the Plan terminates.

Forfeitures

If a participant withdraws from the Plan before becoming fully vested, the portion of the participant's account attributed to the Company's matching or profit sharing contributions, which has not vested, will be forfeited and applied first to the payment of the Plan's administrative expenses and any excess applied to reduce either the matching or profit sharing contributions. There were no unused forfeiture balance as of December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance, reduced by any outstanding loan balance, or \$50,000. Loans bear interest equal to the Wall Street Journal's prime rate, at the inception of the loan, plus two percentage points at the inception of the loan (ranging from 4.25% to 9.50% at December 31, 2024). Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Participant loans are collateralized by the respective participant's account balance and are repaid through payroll deductions. The maximum term of the participant loan is five years, not to exceed five years, unless the loan was obtained to purchase a participant's principal residence with a maximum term of 15 years.

Benefit Payments to Participants

A participant's vested account balance is paid to the participant or the participant's beneficiary in a lump sum cash payment as of the valuation date following retirement (normal retirement age under the Plan is 65), death or disability, or other termination of employment. If, however, the amount of the participant's vested account balance is greater than \$5,000, then a participant can elect to have his vested account balance paid to him in installments over a fixed period. In addition, the Plan permits in-service distributions to participants who have attained age 59 1/2 of amounts up to the value of his vested account balance.

Hardship Withdrawals

Upon demonstration of immediate and heavy financial need, as defined in the Plan document, hardship withdrawals are allowed from the participant's salary deferrals contributed to the Plan, as well as the participant's Plan account attributable to certain Company matching contributions and Company profit sharing contributions.

Administrative Expenses

A substantial portion of the administrative expenses of the Plan is paid by the Company as defined in the Plan document. Administrative expenses include third party administration and audit services.

Termination of the Plan

While the Company has not expressed any intent to discontinue the Plan, it may, by action of the Board of Directors of the Company, terminate the Plan. In the event the Plan is terminated, the participants become 100% vested in their account balances.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting and are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The valuation methodologies used for assets measured at fair value are described further in Note 5. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments is comprised of realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Use of Estimates

The preparation of financial statements, in conformity with U.S. GAAP, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are recorded as deemed distributions based on the terms of the Plan document. There was no allowance as of December 31, 2024 or 2023 as the loans are fully collateralized by the participants' accounts.

3. Information Certified by the Custodian (Unaudited)

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian, a qualified institution, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments and notes receivable from participants, as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;

The Plan's independent auditors did not perform any auditing procedures with respect to this certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Income Tax Status

The Plan is using a non-standardized prototype plan document, which has received an opinion letter dated June 30, 2020 stating that the form of the Plan is acceptable under section 401 of the Internal Revenue Code (the Code) for use by employers for the benefit of their employees. The Plan has since been amended but the Plan Sponsor believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Fair Value Measurements

The accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Pooled Separate Accounts: These accounts are valued on a net unit value basis as determined by the custodian on the last business day of the Plan year. The fair values of these investments are determined by reference to the respective fund's underlying assets, with the custodian specifying the source(s) to use for underlying investment asset prices. The investments underlying the Plan's pooled separate accounts primarily include domestic and international equities and domestic fixed income securities. The net assets value prices of the individual pooled separate accounts are not quoted on any market; however, the unit prices are based on the underlying investments, which are traded in an active market, and are reported at net asset value within the financial statements.

As of December 31, 2024 and 2023, there were no restrictions on redemption or unfunded commitments for any of the major classes of assets, as well as no transfers between Level 1 and 2 investments.

6. Related-Party Transactions and Party-in-Interest Transactions

At December 31, 2024 and 2023, there were outstanding loans of \$97,204 and \$71,769, respectively, due from Plan participants. All of these loans were made in accordance with the Plan document which permits loans to be made with prescribed terms, amounts and collateral. None of these loans were determined to be a prohibited transaction as defined by ERISA.

Certain Plan investments are managed by the custodian. Also, the Plan Sponsor pays certain fees on behalf of the Plan. These transactions qualify as exempt party-in-interest transactions.

7. Risks and Uncertainties

The Plan provides for investments in various investment securities, which in general are exposed to volatility and various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts recorded in the Statements of Net Assets Available for Benefits and changes therein.

8. Excess Contributions Payable

Amounts payable to participants totaling \$5,975 and \$71,016 for contributions in excess of amounts allowed by the IRS are recorded as a liability on the statements of net assets available for benefits at December 31, 2024 and 2023, respectively. \$5,975 is included in distributions to participants in the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan distributed the 2024 and 2023 excess contributions to applicable participants prior to March 15, 2024, and 2023, respectively.
