### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Population Services International Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

**Note 1 Description of Plan**

The Population Services International Retirement Plan (Plan) is sponsored by Population Services International (Organization). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution profit sharing plan established to provide certain employees of the Organization with retirement benefits in accordance with Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Board of Trustees is responsible for oversight of the Plan and Plan management is responsible for determining appropriate investment offerings and performance.

Effective November 14, 2024, the Plan's trustee changed from Newport Trust Company, LLC ("Newport") to Ascensus Trust Company (collectively, "Ascensus").

**Eligibility**

All Organization employees, who are on the Organization's United States payroll, are eligible to participate in the Plan if they have worked for the Organization for at least one year of service.

Effective January 1, 2023, the Plan was amended to exclude nonresident aliens and third-party nationals.

**Employer Contributions**

The Organization makes a contribution to each eligible participant. For the year ended December 31, 2024, the Organization made contributions based on the following formula:

- U.S citizens working overseas will receive 4% of their covered compensation.
- Domestic employees will receive 7% of their covered compensation.

Covered compensation excludes bonuses and other items as defined in the Plan document.

For the year ended December 31, 2024, employer contributions totaled \$1,589,734. The contribution was paid into the Plan in March 2025.

**Participants' Accounts**

Each participant's account is credited with their allocation of employer contributions, expenses, and Plan earnings or losses.

**Vesting**

Employer contributions are 100% vested after the participant's third year of service, as defined. In the event of death, disability or attainment of age 59½, participants' accounts become fully vested.

***Payment of Benefits***

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, or in a rollover distribution in accordance with Internal Revenue Service (IRS) regulations and Plan provisions. Withdrawals from the Plan before leaving the Organization are available after attaining the age of 59½. Distributions to participants are recorded when paid.

***Forfeitures***

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to reduce future Organization contributions. The Organization used and \$638,756 of forfeitures to reduce employer contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$118,694 and \$638,756, respectively. The forfeiture balance is included in the Standard Insurance Company Stable Asset II Fund at December 31, 2024 and 2023. The Organization used forfeitures totaling \$118,795 to offset employer contributions paid subsequent to year end December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed by the Plan.

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value (except for the guaranteed annuity contract with Standard Insurance Company which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

***Investment Contract with Insurance Company***

The Plan is a party to a fully benefit-responsive guaranteed investment contract with Standard Ins Co (Standard). Standard maintains the contributions in a guaranteed interest account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for the credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, which is benchmarked relative to Treasury indices in a process similar to that used by banks and other insurance companies for their products. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investments; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the Plan to qualify under 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Organization and are excluded from these financial statements.

***Subsequent Events***

The Plan has evaluated subsequent events through July 30, 2025, which is the date the financial statements were available to be issued.

**Note 3. Information Certified by the Plan's Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Newport, a qualified institution, has certified the following investment information included for the period from January 1, 2024 to November 14, 2024 and Ascensus, a qualified institution, has certified the following investment information as of December 31, 2024 and for the period from November 14, 2024 to December 31, 2024 in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions and Related-Party Transactions**

During the year ended December 31, 2024 Newport and Ascensus served as the trustees of the Plan. Newport and Ascensus charge the Plan for administrative and recordkeeping fees and as such, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Newport and Ascensus totaled \$21,593 for the year ended December 31, 2024. The Organization provides certain accounting and administrative services to the Plan for which no fees are charged.

**Note 5. Tax Status**

The Plan is designed to be exempt from taxation under the IRC. The Organization obtained a determination letter on November 30, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the plan and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan at any time by resolution of the Board of Trustees, subject to the provisions of ERISA. In the event of Plan termination, all accounts will become 100% vested and will be valued on the termination date and account balances will be distributed in full to participants.

**Note 7. Risks and Uncertainties**

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to inherent risks such as interest rate changes, market valuation changes, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect the future value of amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The Plan's investments are stated at fair value (except for the investment contract with Standard, which is reported at contract value). That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** - Inputs to valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** - Significant unobservable inputs, including the Organization's own assumptions in determining the fair value of investments.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The following is a description of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
