**NOTE 1 - PLAN DESCRIPTION**

The following description of Cardiology Associates of Mobile, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan covering all employees of the Company who have one year of service and are age twenty-one or older. One year of service is defined as twelve consecutive months beginning on each employee's employment date during which 1,000 hours are obtained. Participants may enter the Plan on the first day of the quarter following the date they meet the service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each participant may make pre-tax contributions out of his or her annual compensation. Total pre-tax contributions by a participant may not exceed limits as determined by the Internal Revenue Code (IRC). Participants may make Roth deferrals which are taxable in the year of deferral. Typically, earnings on Roth contributions are not subject to federal income taxes upon distribution. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan is a 401(k) plan with a non-elective contribution structure under a safe harbor provision. For each eligible participant employed, the Company contributes at least 3% of the participant's eligible compensation regardless of service completed during the Plan year or employment status on the last day of the Plan year. This contribution is fully vested and referred to as a non-elective contribution. During the year ended December 31, 2024 and 2023, the Company reported non-elective contributions of \$648,398 and \$625,962, respectively. The Plan was amended retroactive to January 1, 2010, to change the discretionary matching contribution to a fixed matching contribution. The fixed matching contribution is equal to 100% of the first 6% of compensation deferred by each eligible participant. During the year ended December 31, 2024 and 2023, the Company reported fixed matching contributions of \$1,107,142 and \$1,082,653, respectively. The Company also may make discretionary profit-sharing contributions based on certain percentages of each participant's eligible compensation, subject to limitations stated in the Plan agreement and the IRC. During the year ended December 31, 2024 and 2023, the Company reported discretionary profit-sharing contributions of \$588,407 and \$559,320, respectively.

*Participant accounts.* Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and net earnings (losses), and is charged with the participant's withdrawals and allocation of administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Payment of Benefits.* Payment of a participant's account balance is available upon death, disability, or retirement. If employment terminates for reasons other than those listed above, the participant will be entitled to receive only the "vested percentage" of his account balance and the remainder of his account will be forfeited. Only employer discretionary contributions are subject to forfeiture. A participant who is eligible to make distribution elections may elect to receive the value of his vested account balance as soon as administratively feasible as a lump sum distribution.

Participants are also able to make distribution elections at normal retirement age or at age fifty-nine and one-half (59 1/2) regardless of employment status. In-service distributions at age 59 1/2 are permitted from pre-tax elective deferral accounts and at normal retirement age from all other accounts.

*Vesting.* Participants are immediately vested in their contributions and the employer's non-elective contributions plus actual earnings thereon. Vesting of employer matching and discretionary profit sharing contributions plus actual earnings is based on vesting years of continuous service as follows:

*Forfeited Accounts.* As prescribed by the Plan, forfeitures, less any amounts applied for the payment of administrative fees, shall be used to reduce any employer contribution to the Plan. Forfeited non-vested account balances at December 31, 2024 and 2023 were \$1,860 and \$91, respectively. The amounts forfeited, including dividends earned on forfeited amounts, for the years ended December 31, 2024 and 2023 were \$121,881 and \$9,128, respectively. The amounts used to offset employer contributions during the years ended December 31, 2024 and 2023 were \$120,112 and \$9,087, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Receivable

Employer contributions receivable consists of safe harbor and profit-sharing contributions not yet remitted to the Plan at year end. Amounts due at year end were received by the Plan subsequent to year end.

Investment valuation and income recognition

The Plan's investments are stated at fair value as provided by the Trustee, Newport Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits payable

Net assets available for benefits include benefits due to participants who have withdrawn from participation in the Plan as of December 31, 2024 and 2023. Benefits are recorded when paid.

Administrative expenses

Costs of administering the Plan's assets are paid by the Plan and the Company. Investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

Subsequent events

Subsequent events have been evaluated through August 4, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - PLAN ADMINISTRATION**

The general administration of the Plan and the responsibility for carrying out its provisions are placed with the Administrative Committee and the Board of Directors of the Company.

Newport Trust Company serves as Trustee for the Plan. The Trustee holds, manages, invests and reinvests the Plan's assets. Newport Group, Inc. serves as the third-party administrator of the Plan.

Mitchell, McLeod, Pugh, & Williams, Inc. serves as Investment Advisor (the Advisor) to the Plan. The Advisor is authorized to supervise and manage the Plan in accordance with the investment objectives of the Company. The Advisor's responsibilities also include advising individual participants regarding investment choices and objectives for their individual accounts.

The Company is responsible for accurate books and records with respect to its employees for purposes of administering the Plan.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants will become 100% vested in their accounts.

**NOTE 5 - TAX STATUS**

The Company received an opinion letter from the Internal Revenue Service dated June 30, 2020, that stated that the Plan is acceptable under Code Section 401(a) and, therefore, the related trust is exempt from tax pursuant to Section 501(a) of the IRC. The Plan is required to operate in conformity with the IRC to maintain qualification. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The investment information included in the accompanying financial statements and the supplemental schedule in total, including investments held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments, dividends and interest for the years then ended, was obtained from information prepared by the Trustee of the Plan and provided to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 8 - COMMITMENTS AND CONTINGENT LIABILITIES**

Plan management is not aware of any commitments or contingent liabilities as of December 31, 2024 and 2023.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

The Advisor is a fiduciary because they give investment advice and, therefore, these transactions qualify as party-in-interest transactions. The administrative fees paid by the Plan for the years ended December 31, 2024 and 2023 were \$27,177 and \$25,423, respectively.

**NOTE 10 - RISKS AND UNCERTAINTIES**

The Plan provides for investments that are exposed to various risks, such as interest rate, credit, and market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the value of investment securities may occur in the near future and that changes could materially affect the amounts reported in the statements of net assets available for benefits.
