### Note 1 - Plan Description

Dart Container Corporation Employees' 401(k) Plus Plan (the "Plan") was adopted on April 1, 1967 and restated effective January 1, 2021. The following description of the Plan provides only general information. Participants should refer to the plan agreement and related union agreements, if applicable, for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time employees of Dart Container Corporation and participating companies (collectively, the "Company") who have completed 30 days of service and are not covered by any other plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The participating companies include Dart Container Corporation; Dart Container of Michigan LLC; Dart Container Corporation of Pennsylvania; Dart Container Corporation of Georgia; Dart Container Corporation of Illinois; Dart Container Corporation of California; Dart Container Corporation of Kentucky; Dartco of Texas, LLC; Dart Container Company of Mississippi LLC; Dart Container Company of Florida LLC; Dart Container Corporation of Florida; DS Technology Hub, LLC; Dart Care LLC; Solo Cup Operating Corporation; Dart Properties II LLC; Dart Atlas Holdings, LLC; Third Palm LLC; LWP Cypress PM LLC; and Oakwood EP LLC.

#### **Contributions**

The Plan provides for employee salary contributions up to the maximum allowable contributions established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Participants with more than one year of service are eligible to receive company matching contributions. The Company is required to make matching contributions of 100 percent of compensation deferred by the participant up to 3 percent of a participant's eligible compensation, plus 50 percent of eligible compensation deferred by the participant that is between 3 and 5 percent of a participant's eligible compensation. Matching contributions are paid by March 31 of the following year.

The Company may also make annual discretionary contributions, which are currently set at 2.5 percent of eligible compensation. Participants who have completed one year of credited service are eligible to receive an allocation of the Company's discretionary contribution. Discretionary contributions are paid by September 15 of the following year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Benefit Payments**

On termination of employment, retirement, or the attainment of age 59½, a participant, or the beneficiary in the case of death, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. Account balances less than \$1,000 are paid in a single lump sum upon termination.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### ***Vesting***

Participants are immediately vested in their contributions, rollover contributions, and safe harbor matching contributions plus actual earnings thereon. Vesting in the portion of their accounts related to discretionary contributions plus actual earnings thereon is based on years of credited service. Participants vest in these discretionary contributions based on a tiered schedule ranging from five to six years, varying based on the participating employer. See the plan document for a complete description of the vesting schedules.

#### ***Forfeitures***

If a participant is not fully vested at the earlier of five one-year breaks in service or distribution of the vested balance, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

#### ***Administrative Expenses***

The Plan is responsible for all administrative fees incurred on its behalf, which include direct plan expenses paid by the Company.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company (Vanguard) or its affiliates. Vanguard is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 25, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Vanguard holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Vanguard.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has received a determination letter from the IRS.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

##### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
