Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of North Mississippi Health Services, Inc. Employer Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

Note 1. Description of the Plan

The following brief description of the North Mississippi Health Services, Inc. Employer Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General

The Plan is a profit sharing plan and covers substantially all employees of North Mississippi Health Services, Inc. and subsidiaries (collectively, Sponsor or Plan Administrator). Any employee 21 years of age and older is generally eligible to participate in the Plan after completing one year of service. Participation ceases upon termination of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. In July 2024, the Plan was amended to include grandfathered participants from the North Mississippi Health Services, Inc. Retirement Plan and Trust Agreement that terminated at the same time.

Contributions

Eligible employees who make contributions to the North Mississippi Health Services, Inc. 403(b) Plan automatically receive matching employer contributions under the Plan.

Each year, the Sponsor contributes matching contributions to the Plan. Generally, matching contribution amounts equal 50% of each employee's contribution to the 403(b) Plan, up to a maximum of 4% of compensation, as defined. Employees do not contribute to the Plan, but direct the Sponsor's contribution on their behalf to investment options offered by the Plan.

Employees hired on or after January 1, 2016 and considered ineligible for the North Mississippi Health Services, Inc. Retirement Plan and Trust Agreement (Retirement Plan) are eligible for an employer matching contribution ranging from 50% to 125% (based on years of service) of the employee's contribution to the 403(b) Plan, not to exceed 6% of compensation. Employees hired on or before December 31, 2015 and considered ineligible for the Retirement Plan are eligible for an employer matching contribution ranging from 50% to 150% (based on years of service) of the employee's contribution to the 403(b) Plan, not to exceed 6% of compensation. Effective July 21, 2024, the Plan was amended to include specific matching contribution guidelines for North Mississippi Health Services, Inc. Retirement Plan participants, due to the termination of the Retirement Plan, which was effective July 21, 2024.

Effective January 1, 2016, employees whose years of service in the Plan and age total 45 or more (but less than 65) on December 31, 2015 will receive an added nonmatch employer contribution ranging from 2% to 6% of compensation. Employees will receive the additional sponsor-paid contribution whether or not they participate in the 403(b) Plan and as long as they are continuously employed on the last day of the plan year. Participants who are: (1) eligible employees are defined as grandfathered participants of the Retirement Plan, (2) have not maintained continuous employment with the Sponsor or another employer participating in the Plan since January 1, 2016, or (3) employees who transferred to the North Mississippi Medical Clinics, Inc. prior to January 1, 2017 are not eligible to receive the additional sponsor-paid contribution.

Participant Investment Account Options

Each participant has the option of directing the Sponsor's contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited or charged with the Sponsor's contribution, allocation of earnings or losses thereon, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are not vested in their accounts until the completion of three years of credited service, at which time they become 100% vested.

Payment of Benefits

Vested benefits are generally payable on termination, retirement, or disability. Participants may elect to receive the vested interest in his or her account through a lump-sum amount equal to the value of the participant's vested interest in his or her account or monthly, quarterly, semiannual, or annual installments over a fixed period. Participants may also elect to receive vested interest in his or her account by applying the balance toward the purchase of an annuity. Effective January 1, 2019, Qualified Joint and Survivor Annuities are only available to participants who have assets transferred from a money purchase pension plan into the Plan. The Plan was amended on August 31, 2023 to allow distributions for qualified births or adoptions from March 1, 2021 and after.

Forfeited Accounts

At December 31, 2024 and 2023, there was approximately \$111,000 and \$282,000 in forfeited nonvested accounts, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. Forfeited nonvested account balances of approximately \$339,000 and \$33,000 were used to reduce sponsor contributions in 2024 and 2023, respectively.

Notes Receivable From Participants

Notes receivable from participants consist of loans transferred in from the North Mississippi Medical Clinics, Inc. Savings Plan [401(k) Plan], which was merged into the Plan effective after the close of business on December 31, 2016. These loans shall continue to be serviced according to the terms and conditions set forth at the time of the loan. All of the remaining active loans from the 401(k) Plan carry a maturity date of up to five years for general purpose loans and up to 35 years for loans made to purchase the participant's principal residence and are secured by the balance in the participant's accounts and bear an interest rate at 4.25%. Principal and interest are paid ratably through monthly and quarterly participant payments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

The Lincoln Financial Group Fixed Annuity Contract is a deferred annuity contract issued by Lincoln Financial Group (Lincoln), which guarantees a minimum fixed rate of interest as specified in the contract. At December 31, 2024 and 2023, the crediting net interest rate, which is declared on a quarterly basis, was 2.45% and 2.25%, respectively. The guaranteed minimum interest rate for the fixed annuity contracts is 1.75%. The Lincoln Financial Group Fixed Annuity Contract is reported at contract value, and the contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate. The fixed annuity contracts are guaranteed against loss of principal, minus all withdrawals, including charges and adjustments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Administrative Expenses

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, the trustee of the Plan and qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Investment Contract with Insurance Company

The Plan holds a benefit-responsive investment contract with Lincoln National Life Insurance Company (LNLIC). LNLIC maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the guaranteed investment contracts is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.75%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents [including complete or partial plan termination or merger with another plan], (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other plan sponsor events [for example, divestitures or spin-offs of a subsidiary] that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 6. Tax Status

The Sponsor has adopted a volume submitter plan document. The Internal Revenue Service (IRS) has issued an opinion, dated June 30, 2020, that the form of the volume submitter document is acceptable under Section 401(a) of the Internal Revenue Code (IRC). The Plan Sponsor believes that the Plan is designed and is being operated within the applicable requirements of the IRC and, as such, is exempt from federal income taxes.

Note 7. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

The fair value of mutual funds is determined based on quoted market prices. The Lincoln Financial Group Fixed Annuity Contract is a traditional investment contract. The traditional investment contract is valued at contract value, which is the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 8. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$361,451 and \$301,819 of recordkeeping fees to Lincoln during the years ended December 31, 2024 and 2023, respectively. The Sponsor provides certain administrative services at no cost to the Plan.

Note 9. Risks and Uncertainties

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the Plan's accompanying financial statements and supplemental schedule.

Note 10. Subsequent Events

Subsequent events have been evaluated through August 11, 2025, which is the date the financial statements were available to be issued.
