We have performed audits of the financial statements of Caleel Hayden, LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of Plan

The following description of the Caleel Hayden, LLC 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document and summary Plan description for more complete information.

**General and eligibility:** The Plan is a defined contribution plan established on January 1, 2000, to cover all employees of Caleel Hayden, LLC (the Company or Plan Sponsor). Employees must reach the age of 18 before becoming eligible to participate in the Plan. One consecutive month of service with the Company must be completed in order to meet participation eligibility.

**Contributions and investment options:** Each year participants may contribute a specified percentage or dollar amount of pretax annual compensation, as defined by the Plan, subject to Internal Revenue Service (IRS) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employees are eligible for discretionary employer matching contributions on the date in which the employee becomes eligible to participate in the Plan. During 2024, the Company made matching contributions equal to 50% of participant's deferrals that do not exceed 6% of his or her compensation.

Participants are automatically enrolled in the Plan at a 1% deferral rate once eligibility requirements are met and are invested in the default fund based on the estimated retirement year, unless a different amount or an election not to contribute has been submitted.

Participants in the Plan direct their contributions and Company contributions into various investment options offered by the Plan. Participants may change their elections daily. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant accounts:** Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participant contributions and earnings thereon are fully vested and nonforfeitable. The vesting percentage for Company contributions is based on years of service under the following schedule:

Years of Service	Vested Percentage
1 year	25%
2 years	50%
3 years	75%
4 years	100%

In the event of Plan termination, death, attainment of age 65 or permanent or total disability, participants will become 100% vested in their account balances.

**Forfeitures:** Participants terminating employment without being 100% vested in the Company's contributions forfeit the nonvested portion of their account. Forfeitures are used to pay administrative expenses of the Plan or used to reduce the Company's contributions. The forfeiture balance as of December 31, 2024 and 2023, was \$16,051 and \$11, respectively. During 2024, \$25,302 of forfeitures were used to reduce Company contributions.

#### Note 1. Description of Plan (Continued)

**Payment of benefits:** On termination of service due to retirement, death or disability, a participant, or their beneficiary in the case of death, may elect to receive a lump-sum amount equal to the value of the participant's account, or an annuity which provides for annual installments over a specified period. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution less applicable taxes, or the participant may elect to roll over his or her account balances into another qualified retirement savings account. If a participant terminates employment and the individual's vested interest in the Plan does not exceed \$7,000, the distribution will be paid in a lump sum as soon as practicable after allowing a participant sufficient time within which to elect whether to receive the distribution in cash or as a direct rollover.

**Notes receivable from participants:** Participants may borrow from their fund accounts amounts from \$500 to \$50,000 reduced by the excess, if any, of the highest outstanding balance during the prior 12 months over the outstanding balance on the date on which the new note is made and limited to a maximum of 50% of the present value of the participant's vested account balance. The notes bear interest at the *Wall Street Journal* prime rate on the 14th of each month, plus two percentage points. Notes receivable are collateralized by the participant's vested account balance. The repayment period is limited to five years, except that a note used for the purchase of a principal residence may exceed five years. The repayment period may not extend beyond the participant's normal retirement date. Principal and interest is paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024, bear interest at rates ranging from 5.25% to 10.50% and are due through October 2028.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Accounting estimates and assumptions:** The preparation of financial statements in accordance with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Administrative expenses:** Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements.

**Risks and uncertainties:** The Plan utilizes various funds as investment instruments. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

#### Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Payment of benefits:** Benefit payments to participants are recorded upon distribution.

**Excess contributions refundable:** Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

**Subsequent events:** The Plan Administrator evaluated subsequent events through September 2, 2025, which is the date the financial statements were available to be issued.

The plan was amended in April 2025 to increase the automatic deferral provisions initially to 3%, increasing by 1% each year up to a maximum of 10% and to decrease the maximum number of loans outstanding per participant to 1.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance Trust Company, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate to the best of their knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

#### Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1:** Quoted prices in active markets for identical assets or liabilities.

**Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3:** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in valuation methodologies at December 31, 2024, compared to December 31, 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds:** Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy.

**Common collective trust:** These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities and then divided by the number of shares outstanding.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Related-Party and Party-in-Interest Transactions

Transactions with the Trustee, recordkeeper and third-party administrator qualify as party-in-interest transactions. Fees paid by the Plan to these parties totaled \$20,924 for the year ended December 31, 2024.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at its discretion. In the event of termination, the net assets of the Plan, after payment of any expenses properly charged, will be distributed to each participant according to the amount then credited to his or her account. Additionally, in the event of Plan termination, all participants will become 100% vested in their account balances.

#### Note 7. Tax Status

The Plan adopted a non-standardized form of a defined contribution pre-approved plan sponsored by the third-party administrator. The Plan has received an opinion letter from the IRS dated October 6, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan applies the standards on accounting for uncertainty in income taxes. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustments to the financial statements.

#### Note 8. Excess Contributions

The Plan failed certain nondiscrimination testing during 2024 and 2023, resulting in excess contributions payable of \$54,736 and \$28,965, respectively. These excess contributions were refunded to certain participants during 2025 and 2024, respectively.
