Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.



**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Westpak, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Westpak, Inc., a test laboratory specializing in product and package testing (the “Organization”). Employees will be automatically enrolled in the Plan at a 3% before-tax deduction. The employee also has to be at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan assets are held at and certified by Reliance Trust Company. See Note 3.

***Contributions***

Participants can contribute up to 100% percent of eligible compensation. However, contributions may not exceed limitations established under section 402(g) of the Internal Revenue Code of 1986 (“IRC”), as amended. The Plan permits catch-up elective deferrals for participants over 50 years of age subject to IRC limitations. The Organization may also make safe harbor matching contributions to the Plan. For the Plan year ending December 31, 2024, the Organization made safe harbor matching contributions of 100% of salary deferrals up to the first 3% and 50% of salary deferrals on the next 2% of eligible compensation. This safe harbor matching contribution was approximately \$313,000 for the 2024 Plan year.

The Organization also may, at its option, make a discretionary profit-sharing contribution to the Plan. The Organization did not make a discretionary profit-sharing contribution (modified cash basis) for the Plan year ended December 31, 2024.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and an allocation of the Organization’s matching contribution, discretionary Organization contribution, earnings, and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

***Vesting***

Participants are immediately vested in their voluntary contributions and the safe harbor matching contributions plus earnings thereon. Participants are 100% vested in the discretionary Organization profit sharing contribution after 3 years of service.

If forfeitures become available, the Organization will reduce the discretionary Organization contribution for that Plan year or pay Plan expenses.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant’s account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions, with repayment terms not to exceed five years.

***Payment of Benefits***

On termination of service, if a participant's account is less than \$5,000, the participant receives a lump-sum amount equal to the value of his or her vested account balance. If the participant's account exceeds \$5,000, the terminated participant may elect to defer distribution until a later date (but not later than their normal retirement date).

***Rollover Contributions***

Rollover contributions consist of amounts rolled over by participants from former employer plans.

***Plan Termination***

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their respective accounts.

***Administrative Expenses***

Currently, the Organization pays certain professional fees related to the Plan. The Plan pays certain expenses charged for participant-directed transactions, such as loan processing fees, distribution fees, and participant set-up fees, as well as investment management fees, where these expenses are allocated to participant's accounts based on the participant's current fair value. These expenses are reflected in the accompanying statements of changes in net assets available for benefits as administrative expenses.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions and investment income are recognized when received, and disbursements are recognized when made.

***Use of Estimates***

In preparing the Plan's financial statements, the Plan administrator is required to make estimates and assumptions that affect the reported amounts of Plan assets, and liabilities, and the reported increases and reductions of Plan assets during the reporting period. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

The Plan's Investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

***Notes Receivable from Participants***

The Plan allows loans to participants in accordance with the Plan document. These loans are reported at the unpaid principal balance plus accrued interest. Loans are deemed distributions by the Plan when they are determined to be in default.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Unobservable inputs for which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual funds:** Valued based upon quoted prices in an active market.

**Common collective trusts:** Valued at the respective net asset values (“NAV”) of the underlying investments held by the funds, less their liabilities. NAV is used as a practical expedient to estimate fair value. Transactions (purchase and sales) may occur daily. The Plan has no future investment commitments or redemption restrictions related to the funds as of December 31, 2024 and 2023.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
