Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hansen ICC, LLC Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Hansen ICC, LLC Savings Plan’s ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and

certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Hansen ICC, LLC Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) Defined Contribution Plan and was established on June 1, 2013. The Plan has been amended and restated throughout the years, and was most recently amended and restated on April 21, 2022, to bring it into compliance with the legislative and regulatory changes set forth in the IRS Notice 2017–37.

Effective December 29, 2020, related employer plans Hansen PPL Employee Savings Plan, Hansen PPL Retirement Savings Plan and Hansen Technologies North America Inc. 401(k) Profit Sharing Plan (the “Plans”), merged into the Hansen ICC, LLC Savings Plan. The Plans are participant-directed, defined contribution 401(k) plans. During the year ended December 31, 2020, assets totaling \$873,821 of the Hansen PPL Retirement Savings Plan were transferred into the Plan. During the year ended December 31, 2021, assets totaling \$8,050,189 of the Hansen Technologies North America, Inc. 401(k) Profit Sharing Plan were transferred into the Plan. During the year ended December 31, 2022, assets totaling \$606,191 of the Hansen PPL Employee Savings Plan and the Hansen PPL Retirement Savings Plan were transferred into the Plan.

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023 into law, which includes the package of retirement provisions referred to as “SECURE 2.0”. These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and ensuring they get connected with those assets when retirement comes. Most of the provisions of the SECURE 2.0 will become effective in 2024 and forward and will require significant changes to the Plan’s administration and recordkeeping, however, there is no current impact to the Plan.

The Plan provides retirement benefits for all eligible employees of the Company and all the merged plans who have at least three months of service and have attained the age of 18. Prior service with NirvanaSoft, LLC, Irdeto USA, Inc., and Hansen Technologies North America, Inc. is recognized for eligibility and vesting purposes.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute a percentage of their compensation or dollar amount and separately elect to defer a percentage of any bonus paid during the year, as defined in the Plan, provided the total deferral does not exceed the dollar limit set by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Effective January 1, 2016, the Company makes an enhanced safe harbor matching contribution equal to 100% of the participant’s elective deferrals that do not exceed 4% of the participant’s compensation, plus 50% of the amount of the participant’s deferrals that exceed 4% but do not exceed 6% of the participant’s compensation. The Plan previously permitted profit sharing contributions. The Employer may make a discretionary matching contribution. All

Contributions (continued)

contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (“the Code”).

Participants’ Accounts

Each participant’s account is credited with the participant’s contributions, Company’s contributions, and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations of investment income and administrative expenses are based on account balances, number of participants or as incurred by an individual participant, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their salary deferral, rollover contributions, safe harbor contributions, matching contributions, and profit sharing contributions, which were previously permitted by the Plan, including the earning on these amounts.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan which are held at Reliance Trust Company. These funds include a variety of investment options with various objectives and degrees of financial risk.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. Loan terms are for up to five years, except for loans to purchase a primary residence, which may be offered over a longer term. The loans are secured by the balance in the participant’s account and bear interest at a rate equal to 1% above the prime rate, as determined by the Plan administrator. Participants may only have one (1) loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum or in installments over a number of years, based upon election of the participant or as defined in the Plan or the Code. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$5,000, the Plan administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant’s balance exceeds \$5,000, the participant’s consent is required. The Plan also provides for in-service distributions to participants who have attained the age of 59½. In addition, upon financial hardship, a participant may withdraw money if he or she satisfies certain conditions.

Forfeitures

Under the Plan, participant accounts are 100% vested at all times. Any amounts that may otherwise be forfeited shall be used to reduce the Company's contributions or to be used to pay any administrative expenses of the Plan. Forfeited non-vested accounts amounted to \$22 and \$22 as of December 31, 2024 and 2023, respectively.

Rollover Contributions

Contributions from a qualified retirement plan established by a new participant's previous employer may be "rolled over" into the Plan. Rollover contributions amounted to \$125,324 and \$0 for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles ("GAAP") in the United States of America requires management of the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received in exchange for the sale of an asset or to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the notes receivable from participants amounted to \$282,310 and \$272,325, respectively, and bore an interest rate ranging from 4.25% to 9.50%.

Payment of Benefits

Benefits to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are, therefore, excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 – CERTIFICATION BY THE INVESTMENT TRUSTEE

The information related to investments and investment income presented in the accompanying financial statements and schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained or derived, from information certified to be complete and accurate by Reliance Trust Company, the trustee of the Plan, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three (3) levels of the fair value hierarchy under FASB ASC 820 are described, as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Valued based on quoted market prices.

Self-directed brokerage accounts consist of an interest-bearing cash sweep account and mutual funds, common stock, unit investment trusts, inclusive of exchange-traded funds, and other assets, inclusive of growth and technology-oriented equity investments.

Common/Collective Trust Funds – Valued at the Net Asset Value (“NAV”) of units of a bank collective trust.

The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

Were the Plan to initiate full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Net Asset Values

The following sets forth additional disclosures for the fair value measurement of investments in certain entities that calculate net asset value per share (or its equivalent) as of December 31, 2024 and 2023:

The common/collective trust's objective is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments, while maintaining sufficient liquidity to provide participant-directed withdrawals at their proportionate share of contract value. However, there is no assurance that this objective can be achieved. The Plan’s investments in collective trust funds consist of *MetLife Stable Value Fund – Series 25053 Class 0*. This fund invests entirely in the MetLife Group Annuity Contract 25053, which consists of separately managed investment portfolios directed by Reliance Trust Company. This fund is a bank collective trust fund for which Reliance Trust

Company serves as the trustee and investment manager. This fund is not FDIC-insured or registered with the Securities and Exchange Commission.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are units of a common collective trust managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and as such, these transactions qualify as a party-in-interest transaction. These transactions are exempt from the prohibited transactions’ rules under ERISA. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of the investment since they’re typically paid through revenue sharing rather than direct payments.

Notes receivable from participants are also considered to be party-in-interest transactions.

Investment and administrative expenses paid by the Plan to ADP, Inc., record-keeper of the Plan, amounted to \$2,525, and are included in Administrative Expenses in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 31, 2014 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PLAN TERMINATION

Pursuant to the terms of the Plan, the Company has the right, at any time, to terminate the Plan. Termination of the Plan will result in the discontinuance of all contributions to the Plan, including the safe harbor 401(k) contribution, with respect to any compensation that participants receive after the effective date of the termination. Termination of the Plan will not affect participants' rights to receive any contributions that participants have accrued as of the effective date of the termination.

NOTE 8 - RISKS AND UNCERTAINTIES

In general, the Plan's investments are subject to various risks, such as interest rate, credit, and overall market volatility risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be affected by shifts in the market's perception of issuers and changes in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
