## INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of  
Coverall North America, Inc. 401(k) Profit Sharing Plan and Trust:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Coverall North America, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Coverall North America, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. DESCRIPTION OF THE PLAN**

The following brief description of the Coverall North America, Inc. 401(k) Profit Sharing Plan and Trust is provided for general information purposes only. Participants should refer to the Coverall North America, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) agreement for more complete information.

**General** - The Plan is a defined contribution 401(k) plan covering all eligible employees of Coverall North America, Inc. (the “Company”) who have completed two months of full-time service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective February 1, 2022, Warjon, Inc. dba Coverall 401(k) Plan was merged into the Plan. For eligibility and vesting purposes, periods of service with Warjon, Inc. dba Coverall will be counted.

**Contributions** – Participants may elect to contribute a percentage of their compensation into the Plan with pretax dollars, subject to certain Internal Revenue Code (IRC) limitations. The Plan document also provides for voluntary after-tax contributions. The Company may make a discretionary matching and/or profit-sharing contribution. Contributions are subject to certain limitations. The Company matched 20% of the participant’s contributions up to \$2,000 for the years ended December 31, 2024 and 2023.

The Plan provides for automatic salary deferral of 6% if a participant has not completed a deferral agreement by the eligibility date. The participant may subsequently enter into a salary deferral agreement at any time to select an alternative deferral amount or to elect not to defer under the Plan. The Plan also automatically annually increases deferral amount by 1% of compensation up to a maximum of 15% of compensation unless participant opts out.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan investment results. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the vested portion of his or her account balance.

**Vesting** - Participants are 100% vested in contributions they make under the Plan, including actual earnings thereon. Employer contributions to the Plan vest at 20%, 40%, 60%, 80% and 100% after a participant provides two, three, four, five and six years of service, respectively. As of January 1, 2024, the Plan was amended to provide vesting at 20%, 40% and 100% after two, three and four years of service, respectively.

**Payment of Benefits** - On termination of service due to death, disability, or retirement, a participant may elect to receive (1) a lump-sum amount equal to the value of the participant’s vested interest in his or her account, (2) payments in installments, or (3) a direct rollover into an individual retirement account (IRA) or to another employer’s tax qualified plan. If a participant’s account balance is less than \$5,000, and the participant has not elected otherwise, the amount of the participant’s distribution will automatically be rolled over to an IRA established by an IRA provider selected by the Company.

**Notes Receivable From Participants** – Participants may borrow from their pre-tax fund accounts a minimum of \$1,000 but may not exceed a maximum of the lesser of \$50,000 or 50% of their vested account balances. Loan repayment periods are for a maximum of 5 years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a reasonable rate commensurate with the prevailing interest rate charged on similar commercial loans under like circumstances. Principal and interest are paid through payroll deductions. The Plan provides for single, lump-sum repayment at any time. The maximum number of loans outstanding allowed at one time is two.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. The Plan administrator is responsible for distributing account balances in accordance with the provisions of the Plan and ERISA after payment of all administrative and liquidation expenses by the Trustee.

**Forfeitures** - When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. Forfeitures are used to reduce Company matching contributions, as applicable, and may also be used to pay plan expenses. At December 31, 2024 and 2023, forfeited accounts totaled \$4,847 and \$3,780, respectively. During 2024, forfeited accounts of \$73,508 were used to reduce Company matching contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements have been prepared using the accrual basis of accounting.

**Investments Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Interest income is reported on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Use of Estimates and Risks and Uncertainties**- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

**Cash and cash equivalents** – Cash and cash equivalents consist of uninvested cash and accrued income receivables with original maturities of three months or less.

**Payment of Benefits** – Benefits are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the plan to comply with ERISA nondiscrimination tests.

**Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events** - The Plan has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued.

### 3. CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

**5. TAX STATUS**

On October 6, 2020, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. Although the Plan has been amended since the original determination, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of

December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
