# **Notes to Financial Statements**

*(All amounts are in United States Dollars unless otherwise stated)*

## **NOTE 1: DESCRIPTION OF PLAN**

The following brief description of PPL Healthcare LLC 401(k) Plan (formerly known as PEL Healthcare, LLC 401(k) Plan) (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### *General*

The Plan is a defined contribution plan effective July 01, 2020, as defined in the Employee Retirement Income Security Act of 1974, and is sponsored by PPL Healthcare LLC (formerly known as PEL Healthcare, LLC) (“the Company/ Plan Sponsor”). Employees of the Company are permitted to enter the Plan after reaching 21 years of age and are eligible for all types of contributions on the day the eligibility requirement is satisfied, except for nonelective profit-sharing contributions for which an employee is eligible on completion of twelve months of service, during which at least 1,000 hours of service are completed and on the first day of the Plan year quarter coinciding with or next following date requirements are met. The Plan recognizes service with Actavis Mid Atlantic LLC. Effective September 1, 2022, the Plan recognizes service with Piramal Critical Care, Inc. Effective January 1, 2023, the Plan recognizes service with Piramal Pharma Solutions, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### *Change of Plan and Plan Sponsor name*

Effective October 15, 2024, the Plan Sponsor changed their name from PEL Healthcare, LLC to PPL Healthcare LLC, and the Plan Sponsor amended the Plan to change the name of the Plan from PEL Healthcare, LLC 401(k) Plan to PPL Healthcare LLC 401(k) Plan.

### *Eligibility*

All the employees of the Company are eligible to participate in the Plan, subject to the eligibility requirements and exclusions mentioned in the Plan document.

### *Participant contributions*

The Plan permits elective deferrals, Roth elective deferrals, and rollover contributions. All employees are eligible for all the above contribution types. In-Plan Roth rollover contributions are not permitted. The Plan includes a provision under Internal Revenue Code (“IRC”) Section 401(k) whereby participants may make elective deferral contributions and Roth elective deferrals (“deferral contributions”) to the Plan up to a maximum of 75% of their annual compensation. Annual participant contribution amounts are limited to \$23,000 and \$22,500 of salary deferrals for the year ended December 31, 2024 (\$30,500 for participants aged 50 years and over), and December 31, 2023 (\$30,000 for participants aged 50 years and over), respectively.

### *Employer contributions*

The employer may, in its sole discretion, contribute and allocate to each eligible participant's account a percentage of the participant's elective deferrals. Matching contributions, if any, shall be determined each payroll period. Nonelective profit-sharing contributions, if any, shall be determined as of the end of the Plan year.

### *Participant accounts*

Each participant's account is credited with their contributions, employer contributions, if any, and Plan earnings or losses offset by withdrawals and Plan administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon retirement, disability, death, or termination, a participant or beneficiary can elect to receive either a lump-sum distribution or an installment distribution.

### *Administration*

The Company serves as the Plan administrator. The Plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions that may affect eligibility for benefits. For the years ended December 31, 2024, and December 31, 2023, the Plan administrator engaged ADP Retirement Services ("ADP") as a third-party plan administrator to assist in the administration of the Plan.

For the years ended December 31, 2024, and December 31, 2023, Reliance Trust Company served as trustee of the Plan pursuant to the Plan agreement. The trustee received all contributions made under the Plan and held Plan assets.

### *Plan expenses*

Some expenses incurred for administering the Plan are paid by the Company, and these amounts are excluded from the Plan's financial statements. Asset and fund fees are recorded as a reduction of investment income and charged to participant accounts. Certain distribution fees and participant note fees are paid by participants as applicable. Investment advisory/broker and some third-party administrator fees are paid by the Plan.

Participants also become 100% vested upon full or partial termination of the Plan, upon reaching the normal retirement age of sixty-five years, or upon disability or death of the participant.

### *Investment options*

Participants are required to make participant-directed allocations of their accounts among various investment options offered by the trustee.

### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

### *Benefit payments*

In-service withdrawals of all or a portion of a participant's account balance only from elective deferrals (a minimum of \$500) may be made by a participant after reaching age fifty-nine and a half. Upon normal retirement at age sixty-five, disability, or death, the participant or beneficiary may receive the value of the account as set forth in the Plan document.

Participants withdrawing from the Plan due to termination of employment, other than due to retirement, disability, or death, may receive the value of their vested account by transfer to another qualified plan or individual retirement account or as set forth in the Plan document.

Distributions from the Plan will normally be subject to income taxes and, in certain circumstances, may also be subject to Internal Revenue Service (IRS) penalties unless the distribution is transferred to another qualified plan or individual retirement account.

The Plan also has a provision for force out distributions, wherein participants with vested account balances less than or equal to \$5,000 will be provided lump-sum force out distributions. Amounts attributable to rollover contributions will be excluded for the determination of a forced-out distribution.

### *Hardship withdrawals*

Participants may obtain hardship withdrawals (a minimum of \$500) only from elective deferrals.

### *Forfeitures*

Non-vested account balances of terminated employees are forfeited after five consecutive one-year breaks in service, as defined in the Plan agreement or the distribution of the entire vested portion of the Participant's account, whichever is earlier. The employer may use forfeitures to pay Plan expenses or to reduce employer contributions in a non-discriminatory manner at the discretion of the Plan administrator, as defined in the Plan agreement. As of December 31, 2024, and December 31, 2023, forfeited non-vested accounts totaled \$11 and \$11,028, respectively. Forfeitures of terminated employees' non-vested accounts totaled \$50,401 and \$70,399 during the years ended December 31, 2024, and December 31, 2023, respectively. During the years ended December 31, 2024, and December 31, 2023, \$61,460 and \$59,472, respectively, were utilized to reduce employer match contributions.

## **NOTE 2: SUMMARY OF ACCOUNTING POLICIES**

### *Basis of accounting*

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements of the Plan are prepared using the accrual method of accounting.

### *Use of estimates in financial statements*

The preparation of financial statements in conformity with GAAP requires the use of management estimates. These estimates are subjective in nature and involve assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of investment income and deductions during the years ended December 31, 2024, and December 31, 2023, respectively. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the period in which such adjustments are determined.

### *Plan termination*

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

### *Investment valuation and income recognition*

Investments in mutual funds (registered investment companies) and common/collective trusts are valued at fair value, as provided by the trustee. Net appreciation in the fair value of investments represents the change in fair value during the period, including realized and unrealized gains and losses. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at

the measurement date. See note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### *Basis of fair value measurements*

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investment assets measured at fair value:

*Mutual funds:* The fair value of the Plan's mutual funds is valued at the net asset value (NAV) of the shares held by the Plan at period-end. These mutual funds are actively traded, and therefore, the fair values are classified as Level 1 estimates.

*Common/collective trusts:* Units held in common/collective trusts ("CCT") are valued using the NAV practical expedient of the CCT as reported by the issuer of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without restrictions.

### *Contributions*

Participant and employer match contributions are recorded in the period the employer makes the payroll deductions.

### *Payment of benefits*

Benefits are recorded when paid. Excess participant contributions payable generally represent the distribution of certain assets to employees for the Plan to comply with ERISA nondiscrimination rules.

### NOTE 3: RISKS AND UNCERTAINTIES

The Plan provides for various investments in mutual funds and common/ collective trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the overall volatility in the financial markets, it is at least reasonably possible that changes will occur in the near term that could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as at December 31, 2024, and December 31, 2023, may not necessarily be indicative of amounts that could be realized in a current market exchange.

### NOTE 4: INFORMATION CERTIFIED BY RELIANCE TRUST COMPANY ("TRUSTEE") (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the trustee, except for comparing such information certified by Reliance Trust Company, to information included in the Plan's financial statements for the years ended December 31, 2024, and December 31, 2023, and supplemental schedule as of December 31, 2024:

**NOTE 8: INCOME TAX STATUS**

For the years ended December 31, 2024, and December 31, 2023, the Plan Sponsor entered into a non-standardized arrangement with ADP, LLC, *Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA*. ADP, LLC has received an opinion letter from the IRS dated October 06, 2020, which stated that the form of the non-standardized pre-approved plan and related trust was designed in accordance with applicable sections of the IRC. It is the opinion of the Plan trustee and the Plan's attorney that the Plan is in compliance with all applicable laws and regulations.

U.S. generally accepted accounting principles require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and December 31, 2023, there are no uncertain positions taken or expected to be taken.
