## Independent Auditors' Report

To the Plan Trustees and Management of the

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Required Supplementary Information**

Management has omitted the management's discussion and analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the financial statements. Such missing information, although not a part of the financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the financial statements in an appropriate operational, economic, or historical context. Our opinion on the financial statements is not affected by this missing information.

### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule Form 5500 Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1) Description of Plan**

The Big Rock Casino 401(k) Plan (the “Plan”) was established on January 1, 2004, and was adopted by Santa Clara Development Corporation (the “Sponsor”) and covers substantially all of its employees. In 2011, the name of the Plan was officially changed to Santa Clara Development Corporation 401(k) Plan. The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering employee of the Sponsor who are age 18 or older. Employees who are at least 18 years of age are eligible to make elective salary deferrals to the Plan. Each participant who is eligible to make elective deferrals will be eligible to receive the employer safe harbor matching contribution. Employees are eligible to receive employer safe harbor matching contributions on the first day of the calendar month after completing 30 days of service and are eligible to receive discretionary employer profit sharing contributions after one year where the employee worked at least 1,000 hours. The Plan is designed to comply with Section 401 and the regulations thereunder of the Internal Revenue Code (the “Code”), as amended. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, as defined by the Plan, participants may contribute up to the maximum annual limits defined by the IRS. Participants may also contribute rollover amounts in cash from other qualified plans, including plans described by IRC 401(a), 403(a), 403(b), and 457(b). The Plan has elected to be a safe harbor plan and the Plan Sponsor makes a safe harbor matching contribution equal to 100% of the first 4% of compensation deferred by the participant. Employees hired on or after April 1, 2018 who do not make a deferral election will be deemed to have made an elective deferral contribution election in the amount of 2%. Participants direct the investment of their elective deferrals and employer safe harbor matching contributions among investment options offered by the Plan. Additionally, profit sharing contributions and/or qualified non-elective contributions may be made at the option of the Sponsor’s board of directors and are invested in the Plan as directed by the participants. The amounts contributed may not exceed the maximum amounts prescribed by law.

#### Forfeited Accounts

Each Plan year, forfeitures could be used to pay administrative expenses or to reduce future employer contributions. There was \$1,054 and \$1,003 in forfeited nonvested accounts at December 31, 2024 and 2023, respectively.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (1) the employer's contributions, and (2) Plan earnings charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into several investment options offered by Fidelity Management Trust Company. Participants may change their investment options each business day. Participants automatically enrolled into the Plan will be placed into a target date plan based on the participants estimated year of retirement.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time. Under the terms of the Plan agreement, plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rate on outstanding loans ranged from 4.25% to 9.50% with various maturities through October 2029.

#### Vesting

Participants are immediately vested in their employee deferral and related earnings. Participants are also immediately vested in their employer safe harbor matching contributions.

The Plan utilizes a 6-year graded vesting schedule for employer non-elective (profit sharing) contributions as follows:

#### Payments of Benefits

On termination of service due to death, disability or retirement or other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The Plan allows participants to receive hardship distributions from their elective deferral accounts, subject to the safe harbor hardship rules as defined by the Internal Revenue Service. In-service distributions may be taken from the participant's elective deferral accounts once a participant reaches age 59½. Participants who have reached the age of 59½ and completed five years of service can take in-service distributions from accounts other than their elective deferral accounts. Upon termination of employment, participants whose vested account balances do not exceed \$1,000 will receive an automatic lump-sum distribution, and participants whose vested account balances are greater than \$1,000 but do not exceed \$5,000 will receive a distribution in the form of a direct rollover to an individual retirement plan designated by the Plan Administrator.

#### Plan Termination

Although it has not expressed an interest to do so, the Sponsor has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to ERISA provisions. In the event of Plan termination, participants will receive the full amount of their accounts.

#### Tax Status

On April 1, 2018 the Plan Sponsor adopted a volume submitter plan. On March 29, 2022, the Plan Sponsor adopted a volume submitter plan with another institution to replace the prior plan document. The Internal Revenue Service has determined and informed the prototype Sponsor by letters dated September 30, 2014, and April 2, 2012 that the prototype Plans and related trusts are designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the determination letters, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **2) Summary of Significant Accounting Policies**

#### Basis of Accounting

The financial statements presented have been prepared on the accrual basis of accounting based on the accounting standards promulgated by the Governmental Accounting Standards Board.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Payment of Benefits

Benefit payments are recorded when paid.

#### Investment Valuation and Income Recognition

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value. If available, quoted market prices are used to value investments. The investment contract is a fully benefit responsive investment contract for which contract value is equal to fair value. In accordance with valuing investments at fair value, the net unrealized appreciation or depreciation is presented in the statement of changes in net assets available for benefits.

#### Expenses

Expenses of maintaining the Plan are paid by the Sponsor. Participants are charged asset-based fees and third-party administrator service fees which are allocated pro rata to the participant's account balance.

#### **3) Information Prepared and Certified by the Custodian**

The following information, included in the accompanying financial statements and the Schedule of Assets (Held at End of Year) was obtained from data that has been prepared and certified as complete and accurate by the custodian of the Plan. Reliance Trust Company (“Reliance”) served as the custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- a. Total investments at fair value as shown in the accompanying statements of net assets available for benefits were \$3,247,774 and \$2,872,552 at December 31, 2024 and 2023, respectively.
- b. Notes receivable from participants of \$208,017 and \$172,635 at December 31, 2024 and 2023, respectively.
- c. Net appreciation in the fair value of investments as shown in the accompanying statement of changes in net assets available for benefits was \$313,211 for the year ended December 31, 2024.
- d. Interest and dividend income from plan investments as shown in the accompanying statement of changes in net assets available for benefits was \$87,191 for the year ended December 31, 2024.
- e. Interest income on notes receivable from participants of \$15,498 for the year ended December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

### 4) Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The hierarchy is measured in three levels based on the reliability of the inputs:

*Level 1 Fair Value Measurements* – Valuations based on unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.

*Level 2 Fair Value Measurements* – Valuations based on inputs other than quoted prices included within Level 1 that are observable for the asset, either directly and indirectly. Observable inputs include quoted prices for similar assets active or non-active markets.

*Level 3 Fair Value Measurements* – Valuations derived through the use of valuation models or methodologies using significant unobservable inputs. Level 3 valuations incorporate certain assumptions and projections that are not observable in the market and as a result significant professional judgment may be used in determining the fair values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Company Shares* – Valued at the net asset value of shares held by the Plan at the end of each day, which is determined by quoted prices in an active market.

#### 5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **6) Related Parties**

The Plan pays various service providers for record keeping, trust, and investment advisory services and as such these transactions qualify as party-in-interest transactions. Amounts paid directly to providers of services was \$41,362 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **7) Subsequent Events**

Management evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued. Events or transactions occurring after December 31, 2024, but prior to August 20, 2025, that provided additional evidence about conditions that existed at December 31, 2024 have been recognized in the financial statements for the year ended December 31, 2024. Events or transactions that provided evidence about conditions that did not exist at December 31, 2024 but arose before the financial statements were available to be issued, have not been recognized in the financial statements for the year ended December 31, 2024.
