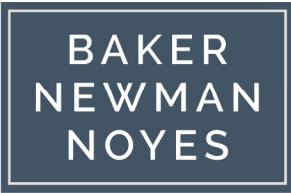

INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants
Franklin Savings Bank 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Franklin Savings Bank 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

1. Description of Plan

The following description of the Franklin Savings Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) plan covering substantially all employees of Franklin Savings Bank (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

ADP Retirement Services is the recordkeeper for the Plan. Reliance Trust Company is the trustee. Effective January 1, 2025, the trustee of the Plan changed to ADP Retirement Trust Services, LLC. State Street Bank and Trust Company serves as the sub-custodian for the Plan.

The Plan uses the Automatic Data Processing nonstandardized 401(k) plan, which includes the following provisions:

Eligibility and Participation

Employees are eligible to participate in the Plan after having completed 3 months of service and attaining age 21. A participant can enter the Plan on the first day of the month coinciding with or next following the date on which eligibility is established.

Contributions

A participant may elect to contribute pre-tax or post-tax (Roth) dollars to the Plan from 1 – 90% of eligible compensation, or up to the Internal Revenue Service maximum amount.

The Plan provides an automatic enrollment feature to defer 2% of eligible compensation for eligible employees that have not opted out.

On behalf of each participant who elects to contribute to the Plan, the Company will make a matching contribution in an amount equal to 15% of the amount contributed. The Company will match participant elective deferrals at each payroll period.

At the participant's option, contributions may be invested in any of the available investment options. As of December 31, 2024 and 2023, the options consisted of mutual funds and collective trusts offered through Invesco Trust Company and State Street Bank & Trust Company.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeitures of terminated participants' nonvested accounts may be used to pay Plan expenses or reduce future employer contributions to the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Benefits

The Plan provides benefits to participants upon death, disability, attainment of age 59 ½, retirement or termination of employment. Benefits will be paid to the participant in a lump-sum payment if the balance of the account is less than or equal to \$5,000. If the balance exceeds this amount, the participant may elect to receive the benefit as a lump-sum payment, partial withdrawal, an annuity, in installment payments or by rollover to another qualifying plan.

Participants are permitted to make hardship withdrawals from their account provided they meet certain criteria and the withdrawals are approved by the Plan Administrator.

Vesting

Participants are immediately vested in their contributions. Participants vest in the Company matching contributions as follows:

6 or more	100

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their balances.

Participant Loans

The Plan allows participants to borrow against their accounts. The minimum loan request is \$500 and is limited to 50% of the participant's vested account balance up to a maximum of \$50,000. A participant may only have two outstanding loans at any time. If a participant had an outstanding loan or loans during the twelve-month period ending the day before the new loan, the participant must reduce the \$50,000 limit by the highest outstanding loan balance during that period, less the outstanding balance on the day before the new loan is made, and a new loan when added to the outstanding balance of any existing loans cannot exceed this limit.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value based upon quoted market prices which represent the net asset value of shares held by the Plan. Investments in the collective trusts are stated at estimated fair value, which has been determined based on the unit values of the trusts. Unit values are determined by the trust by dividing the fund's net assets based on the fair value of the underlying investments by its units outstanding at each valuation date. Certain employer-initiated events may reduce the reported value of the investment in the collective trust. These events include discontinued operations, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan or other events. Such events are not expected to be probable to occur. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions

Employee contributions are recorded in the period in which payroll deductions are made; employer matching contributions are recorded in the same period as corresponding participant contributions.

Participant Loans

Participant loans are carried at the unpaid principal balance plus any accrued but unpaid interest, if material.

Administrative Expenses

Administrative expenses are paid by the Plan participants to the extent they are not paid by the Plan Sponsor. The Bank pays a majority of the Plan's expenses. Fees for recordkeeping services and investment management, are paid by the Plan participants indirectly through the Plan's investment return.

Benefit Payments

Benefit payments are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

2. **Summary of Significant Accounting Policies (Continued)**

Risks and Uncertainties

The Plan provides for investment options in mutual funds and collective trusts which invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through August 11, 2025, which is the date the financial statements were available to be issued.

3. **Investments and Notes Receivable**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Plan's trustee, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

The Plan's investments and notes receivable from participants, related dividends and interest income and investment and loan transactions, including net appreciation of investments were certified by Reliance Trust Company, the trustee of the Plan.

4. **Tax Status**

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The Plan is a non-standardized pre-approved defined contribution plan sponsored by ADP, LLC. This pre-approved non-standardized plan has received an opinion letter from the Internal Revenue Service dated October 6, 2020, as to the plan's qualified status. The Plan has subsequently been amended. The opinion letter has been relied upon by the Plan and the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

4. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

5. Related Party Transactions

Administrative fees consist of loan origination and distribution fees paid to the third-party administrator. These transactions qualify as party-in-interest transactions. In addition, related party loans qualify as party-in-interest transactions. The Plan's investment and transactions with the State Street Bank & Trust Company collective trust also qualify as party-in-interest transactions.

6. Fair Value Measurements

Valuation Hierarchy

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). For disclosures, a fair value hierarchy has been established that prioritizes the inputs to valuation techniques used to measure fair value into three levels:

- **Level 1** – Unadjusted quoted prices in active markets for identical assets.
- **Level 2** – Inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly.
- **Level 3** – Significant unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Invesco Stable Asset Trust’s investment objectives are to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates consistent with seeking to maintain required liquidity. The State Street Fund’s investment objectives are to seek an investment return that approximates the S&P 500 over the long term.
