To the Benefits Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Allen Boone Humphries Robinson LLP 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Allen Boone Humphries Robinson LLP 401(k) Plan (the “Plan”) provides only general information. The Plan is sponsored by Allen Boone Humphries Robinson LLP (the “Company”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Company except leased employees, temporary employees, summer associates, and summer interns. Employees are eligible to participate in the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

Effective March, 1 2024, Fidelity Management Trust Company (“Fidelity”) replaced Vanguard Fiduciary Trust Company (“Vanguard”) as the Plan’s trustee and custodian. Additionally, Fidelity Workplace Services replaced The Vanguard Group, Inc. as the Plan’s recordkeeper. A transition blackout period required for changing from the previous Vanguard plan to the Fidelity plan began on February 26, 2024, and was completed by March 31, 2024. The Plan adopted a new plan document provided by Fidelity. No changes were made to the Plan provisions as a result of the adoption of the Fidelity plan document except as noted below.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan in the form of a dollar amount or percentage of the participant’s eligible compensation, subject to certain limitations. Eligible employees are automatically enrolled in the Plan at a pre-tax salary deferral rate of 4% unless they opt out or elect a different percentage. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for rollover contributions from qualified plans including after-tax contributions subject to certain conditions.

The Company may, at its discretion, contribute for each participant a matching contribution equal to a percentage of the participant’s elective contributions. The Company matched 100% of each participant’s contribution up to 4% of eligible compensation on a pay-period basis in 2024. The Company may also make profit-sharing contributions based on a discretionary formula. For each plan year, the Company may contribute an amount to be determined from year to year. The amount will be allocated pro rata to allocation groups as defined in the Plan based on total eligible compensation of all qualifying participants. In order to be eligible for profit-sharing contributions, the participant must complete at least 1,000 hours of service in a plan year and the participant must be an employee of the Company on the last day of the plan year. The Company’s total contributions to the Plan may not exceed the amount deductible by the Company under statutory provisions. The Company made profit-sharing contributions of approximately \$1,187,000 in 2024.

The Plan is participant-directed, and participants may change their contribution rates and investment options at any time.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions and the participant's allocation of the Company's contributions and earnings, including realized and unrealized gains and losses, and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Participants vest in the Company matching and profit-sharing contribution portions of their accounts plus earnings thereon based on years of service. Participants vest 20% per year after one year of service and are 100% vested after five years of service. A participant shall be immediately vested upon death, retirement, or incurrence of a disability, as defined in the Plan document.

Payment of Benefits

Normal retirement age under the Plan is 65. Upon death, retirement, disability, or termination of employment, the vested funds in the participant's account may be distributed in a lump-sum, partial, or installment payment. The Plan also allows hardship withdrawals from a participant's deferral and Roth accounts. Hardship withdrawals are also allowed from vested Company matching and profit-sharing contributions, and in-service withdrawals are allowed at the age of 59½. A participant can withdraw the portion of his/her account attributable to rollovers at any time.

Forfeitures

Forfeitures of nonvested Company matching or profit-sharing contributions may be used to reduce future Company contributions or to pay Plan expenses. The balance in the forfeiture account was \$78,869 and \$29,811 at December 31, 2024 and 2023, respectively. Forfeitures of \$38,752 were used to reduce Company contributions in 2024. No forfeitures were used to pay Plan expenses in 2024.

Notes Receivable from Participants

Plan participants may borrow a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess, if any, of the participant's highest outstanding note balance from the Plan during a one-year period prior to the date of the note. Notes are paid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. Effective March 1, 2024, notes for a primary residence can range up to 10 years. The notes bear interest at 2% over the prime interest rate at the time of the note. Effective March 1, 2024, the notes bear interest at reasonable rates as determined by the plan administrator. Participants may only have one note outstanding at any time.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Contributions

Contributions from Plan participants and Company matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. Profit-sharing contributions are recorded in the plan year in which the Company determines a profit-sharing contribution will be made.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to service fees, notes receivable from participants, and certain transactions are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 3 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan from March 1, 2024 through December 31, 2024, and Vanguard, the trustee of the Plan as of December 31, 2023 and through February 29, 2024, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Collective Investment Trust Fund: Valued at NAV based on the underlying unit value reported by the trustee based on the fair value of the underlying investments less liabilities. The collective investment trust fund consists of the Vanguard Retirement Savings Trust III, which is invested in investment contracts issued by insurance companies, banks, or other financial institutions. The fund seeks to achieve its objective by diversifying among high credit-quality investments and investment contracts which are structured to smooth market gains and losses over time. The collective investment trust fund held by the Plan provides for daily redemptions by the Plan's participants with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest of the Plan include Vanguard, Fidelity, and Plan participants. Certain investments in mutual funds and a collective investment trust fund are managed by affiliates of Vanguard. Vanguard was the trustee of the Plan through February 29, 2024. Therefore, these investments are considered party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA.

NOTE 6 - TAX STATUS

The Plan has adopted a pre-approved, non-standardized plan, which obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.
