INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Delta Centrifugal (the "Company") Employee Salary Reduction Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have attained twelve months of service, are eighteen or older, and who are not either leased or H2-b Visa employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Employee Contributions

Pursuant to Section 401(k) of the Internal Revenue Code (the "IRC"), participants may contribute up to the lesser of 100% of their compensation or \$23,200 and \$22,500 for 2024 and 2023, respectively. Employees who are age 50 or older may also make catch-up contributions of up to \$7,500 and \$7,500 for 2024 and 2023, respectively. All participants' contributions are fully vested at all times. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Plan has elected safe harbor status under the IRC. In order to maintain the safe harbor status, the Company makes certain matching contributions to the Plan, which automatically satisfy the nondiscrimination testing requirements under the IRC section 401(k). For the years ended December 31, 2024 and 2023, the Company made matching contributions in the amount of \$214,520 and \$207,500, respectively.

Receivables of \$214,520 and \$207,500 are recorded as of December 31, 2024 and 2023, respectively, for employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching safe harbor contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Per the Plan document, participants are always 100% vested in accounts attributable to the following contributions, and the earnings thereon: salary deferrals including 401(k) Roth deferrals, catch-up contributions, safe harbor contributions, employer matching contributions, employer discretionary profit-sharing contributions, and rollover contributions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement on or after normal retirement age, a participant becomes 100% vested in all their accounts under the Plan. If a participant's vested interest in his or her account is less than \$5,000, the participant will have their account automatically distributed in a single lump-sum payment. If their vested balance exceeds \$5,000, then the benefit will be distributed to the participant in either a single lump-sum payment or installments with respect to minimum required distributions, as soon as practicable following the event that entitles the participant to a distribution upon the participant's consent.

Forfeitures

A forfeiture is the non-vested portion of a terminated participant's account balance. The forfeited amount remains in the Plan and may first be used to pay administrative expenses or to reduce subsequent employer contributions. As participants are 100% vested in their account balance as soon as they are eligible to participate in the plan, there are no Plan forfeitures.

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The maximum number of loans that a participant may have outstanding at one time is one. The notes are secured by the balance in the participants' accounts and bear interest at a rate from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions over a period not to exceed 5 years unless it is a residential type loan.

Investment Options

The assets of the Plan are allocated to the various funds at the direction of the participant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts ("FBRIC"). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to a FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities, and changes therein, at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded on the Schedule H of the 5500. Under generally accepted accounting principles, the defaulted loan will remain a note receivable from participant until a distributable event occurs. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for FBRIC's, which are reported at contract value as previously stated in the Basis of Accounting paragraph). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion on fair value measurements.

The fixed account is fully benefit-responsive and is reported at contract value. Contract value represents the accumulated contributions plus accrued net earnings, less distributions. See Note 5 for discussion on the investment contract with the insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

The daily operating expenses of maintaining the Plan are paid by the Plan and are reflected in the financial statements as administrative expenses. Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Certain administrative expenses are paid directly by the Plan, such as recordkeeping, trustee, legal and accounting fees. Investment related expenses are included in net appreciation of fair value of investments. All other expenses of the Plan are paid directly by the Company.

Payment of Benefits

Benefits are recorded when paid.

3. ASSET INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

At December 31, 2024 and 2023, the Plan's investments were held by Empower Annuity Insurance Company of America (the "Trustee").

The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The value of investments at December 31, 2024 and 2023, as reported by the Trustee, is summarized as follows:

During 2024, the Plan's investments (including gains and losses on investments bought, sold, as well as held during the year), appreciated in value by \$783,141.

4. FAIR VALUE MEASUREMENTS

As required by Accounting Standards Codification 820-10, *Fair Value Measurement and Disclosures*, the Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for similar assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair values using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies and approaches used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA") – valued based upon the market value of the underlying net assets in each separate account. The underlying net assets have observable quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. These are classified as level 2 in the fair value hierarchy table. The redemption frequency of each PSA is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan's investment in PSAs.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers into or out of Level 3.

5. GROUP ANNUITY CONTRACT

The Plan offers the option to invest in a group annuity contract ("Fixed Account") with Empower Annuity Insurance Company of America who maintains the contribution in a general account. The Fixed Account contract is considered fully benefit-responsive and is reported in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. This investment option offers a guaranteed minimum rate of return for the period of time specified in the contract.

Because the Fixed Account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Fixed Account. As such, the Fixed Account is presented on the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the Fixed Account at December 31, 2024 and 2023 was \$2,467,243 and \$2,421,758, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The declared interest rate as of December 31, 2024 and 2023 was 3% and 3%, respectively.

Certain events might limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. These events may be different under each contract, but examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or any required prohibited transaction exemption under ERISA
- Premature termination of the contract
- Complete or partial Plan termination or merger
- Changes to the Plan's prohibition or competing investment options
- Bankruptcy of the Company or other events (divestitures, spinoffs, etc.) that significantly affect the Plan's normal operations and/or cause a significant withdrawal from the Plan

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. Additionally, the guaranteed funds do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the Trustee. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$49,813 and \$43,545 for the years ended December 31, 2024 and 2023, respectively.

8. TAX STATUS

The Plan obtained its latest determination letter on June 2, 2021, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations three years after filing.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

10. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

11. SUBSEQUENT EVENTS

For the year-ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through August 29, 2025, the date of financial statement issuance. No events requiring disclosure were noted.
