NOTE 1 DESCRIPTION OF PLAN

The following description of the Whitewood Industries, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Whitewood Industries, Inc. (the Company) established the Plan on July 1, 2017. The Plan has been amended throughout the years and last amended effective December 15, 2022. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan covers all employees of the Company who have completed the eligibility requirements including the completion of one year of service and attainment of age 21. The Plan excludes employees who are classified as independent contractors, leased employees, nonresident aliens and employees whose employment is governed by a collective bargaining agreement. An eligible employee will begin participation on January 1 or July 1 following the completion of the eligibility requirements. The Plan is designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common stock using the proceeds of notes payable to the Company and holds the stock in a trust established under the Plan (see Note 5). As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The Company's borrowings are collateralized by the Plan's unallocated shares of Whitewood Industries, Inc. common stock. As the Plan makes principal and interest payments, an appropriate percentage of stock is allocated to eligible participant's accounts. Shares are allocated to each participant's account based upon the individual participant's annual compensation, as defined, in relation to the total compensation for all participants. The lender has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (a) The account of employees with vested rights in allocated common stock (Allocated)
and
- (b) Common stock not yet allocated to employees (Unallocated)

Contributions

Each year, the Company may contribute to the Plan up to 25% of covered compensation as determined annually by the Company's Board of Directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company contributions, a participant must complete 1,000 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability or retirement. Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the Company contributions and investment income or losses. Company contributions are allocated proportionately based on eligible compensation of all eligible participants. Income is allocated annually based on each participant's share of the fund. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's account attributable to Company discretionary contributions becomes fully vested after six years of credited service with the Company, under a graded vesting schedule. A participant's account attributable to the Profit Sharing Contribution transferred from the affiliated Whitewood Industries, Inc. 401(k) Plan in 2017 becomes fully vested after three years of credited service with the Company, under a grading vesting schedule.

Notwithstanding the above, participants shall, however, become 100% vested in the account upon attaining normal retirement age of 65, their death, or becoming permanently disabled.

Distributions

Distributions from the Plan will be made after a participant retires, dies, becomes disabled, or otherwise terminates employment. If a participant terminates employment and the participant's vested benefit under the Plan does not exceed \$1,000, then the benefit must be distributed in a single lump-sum payment. If the vested benefit under the Plan exceeds \$1,000 the benefit will be paid in annual installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancies) of the participant and any beneficiary. A participant may elect to receive the vested portion of any transferred Profit Sharing Account in the form of a single lump sum after the end of the Plan year in which separation from service occurs.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. Participants who elect to diversify receive a cash distribution. Participants will be eligible to diversify following the December 31, 2026 Plan year-end.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Forfeited Accounts

Allocations of forfeited nonvested accounts for the Plan years ended December 31, 2024 and 2023 totaled \$30,904 and \$3,735, respectively. These amounts are allocated to participants who have completed a year of service and are employed on the last day of the Plan year or terminated employment due to death, disability, or normal retirement age. There were no unallocated forfeiture accounts at December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in common stock are reported at estimated fair value and other investments are reported at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Company pays all administrative expenses on behalf of the Plan.

Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

The Plan's initial investment in Company securities consisted of 218,182 shares of the outstanding common stock of Whitewood Industries, Inc. The shares were acquired on December 29, 2017 for \$12,000,000 (\$55.00 per share). Shares in the amount of 29,587 were acquired in 2017 with funds transferred from the Whitewood Industries 401(k) Plan and are allocated to participants as a Profit Sharing Transfer Account. The remaining 188,595 were acquired with notes payable. The estimated fair market value, determined by an independent appraisal as of December 31, 2024 and 2023 was \$77.81 and \$75.55 per share, respectively. During the Plan years ended December 31, 2024 and 2023, 6,874 and 6,978 shares, respectively, were released and allocated to participants.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at the daily closing price as reported by the fund which is \$1.00.

Company Common Stock: The fair value of the Company common stock held by the Plan is valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

NOTE 5 NOTE PAYABLE

On December 29, 2017, the Plan entered into a \$6,872,719 term loan agreement with the Company. Also, on December 29, 2017, the Plan entered into term loan agreements in the amount of \$3,500,000 directly with the selling shareholders. The proceeds of the loans were used to purchase the Company's common stock. On January 29, 2018, the term note agreements with the Company and the selling shareholders were refinanced into a single term note with the Company in the amount of \$10,372,719. The Plan has a note payable related to the purchase of Company common stock on December 31, 2024 and 2023 as follows:

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Prior to August 1, 2023, the Plan's assets, which consist primarily of Company common shares, are held by Alerus Financial, N.A, the Plan's trustee. Effective August 1, 2023, the Plan's assets, which consist primarily of Company common shares, are held by Summit Fiduciary Group, LLC, the Plan's trustee. Company contributions are held and managed by the trustee, who invests cash received as a result of cash contributions and interest income, and makes distributions to participants.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

The Plan is administered by the Company and certain administrative functions are outsourced to a third-party administrator. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan provides for investment primarily in Company common stock. In general, these investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. The stock of the Company is valued annually by an independent third-party valuation specialist. Because of the inherent subjectivity in any valuation, those estimated values may differ significantly from the values that would have been used had a ready market for the securities existed, and the differences could be material. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 PLAN TAX STATUS

The IRS has determined and informed the Company by a letter dated August 16, 2018, that the Plan is qualified and the trust established under the Plan is tax exempt under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
