**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hol-Mac Corporation Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hol-Mac Corporation Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Opinion**

NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Hol-Mac Corporation Retirement Savings Plan (the Plan) is provided for general information purposes only. The Plan covers employees of Hol-Mac Corporation, ANEL Corporation, and Keith Huber Corporation collectively, the "Company". Participants should refer to the Plan agreement for more complete information.

- A. *General.* The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have met certain service and eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. *Contributions.* Each year, participants may contribute up to applicable IRS limits of pre-tax and after-tax annual compensation, as defined in the Plan. The Company may elect to match a portion of the participants' contributions for the year by an amount determined each year by the Company's Board of Directors. At the discretion of the Company's Board of Directors, the Company may make additional contributions or suspend or reduce its contributions to the Plan for any Plan year or portion thereof. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. Effective March 2019, the Plan initiated an automatic increase of 1 percent each year up to a maximum of 6 percent to a participant's automatic enrollment percentage.
- C. *Participant Accounts.* Each participant's account is credited with the participant's contribution and allocations of the Company's matching contribution, if any, and plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. *Vesting.* Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service.
- E. *Payment of Benefits.* Upon normal retirement age 65, death or disability, if earlier, retirement or termination of employment, the participant's vested benefits are paid to the participant or his or her beneficiary in the form of a lump-sum distribution. Participants may borrow against the vested balance in their accounts.

## NOTES TO FINANCIAL STATEMENTS - (Continued)

### NOTE 1. DESCRIPTION OF PLAN - (Continued)

- F. *Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$ 500 up to a maximum equal to the lesser of \$ 50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined monthly at 1 percent above the prime rate for loans initiated prior to July 1, 2016, 3 percent above the prime rate for loans initiated after July 1, 2016. Principal and interest is paid ratably through monthly payroll deductions.
- G. *Forfeited Accounts.* At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$ 63,220 and \$ 47,685, respectively. These accounts may be used to reduce future employer contributions, pay plan expenses, or act as additional employer contributions. During 2024, the Plan used forfeitures to reduce employer contributions and pay plan expenses by \$ 14,914.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- A. *Basis of Accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.
- B. *Valuation of Investments.* The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees, and insurance company. See Note 3 for discussion of fair value measurements.
- C. *Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- D. *Payment of Benefits.* Benefits are recorded when paid.
- E. *Administrative Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.
- F. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default in accordance with the Plan's Loan Policy, the participant loan balance is reduced and a benefit payment is recorded.

NOTES TO FINANCIAL STATEMENTS - (Continued)

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued)

- G. *Subsequent Events.* In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 and the methodologies used for assets measured at fair value are described as follows:

*Level 1.* Fair value inputs include unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

*Level 2.* Fair value inputs include significant other observable inputs other than Level 1 inputs such as quoted prices for similar assets, quoted prices in markets that are not active or other observable inputs that can be corroborated by observable market data. There were no Plan investments valued using Level 2 inputs.

*Level 3.* Fair value inputs include unobservable inputs that are supported by little or no market activity such as pricing models, discounted cash flow methodologies or similar techniques. Level 3 inputs have the lowest priority. There were no Plan investments valued using Level 3 inputs.

**NOTE 4. CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and group annuity contract income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees of the plan.

NOTES TO FINANCIAL STATEMENTS - (Continued)

**NOTE 5. FEDERAL INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, Plan management is of the opinion that the Plan meets the Internal Revenue Service requirements as to both design and operation and, therefore, continues to be tax exempt. Therefore no provision for income taxes has been included in the plan's financial statements.

The Plan's Form 5500 information returns are subject to examination by the Department of Labor generally for three years after they are filed. Management has evaluated the tax positions taken, and has not identified any positions that are not more likely than not to be sustained upon examination.

**NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 9. GUARANTEED INVESTMENT CONTRACTS

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment. The contract issuer, Empower Annuity Insurance Company of America is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting.

The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower Annuity Insurance Company of America. Examples of such events include the following:

1. Plan termination or merger.
2. Plan amendments or operation of the Plan in a manner which is unacceptable to issuer.
3. The Plan fails to qualify or becomes disqualified under Code section 401(a).
4. Total amount of contributions received in the preceding 12 months is less than \$25,000.
5. The sum of all Participant Annuity Account Values falls below \$25,000.
6. Premature termination of the contract.

The Plan considers that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### NOTE 10. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America is also the issuer of the guaranteed investment contract held by the Plan. These transactions qualify as party in interest transactions as Empower Annuity Insurance Company of America and Empower Trust Company, LLC are also the trustees, as defined by the Plan. The plan made direct payments to the third party administrator of \$ 115,197 in 2024, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the plan's operations.
