INDEPENDENT AUDITOR'S REPORT

To the Trustees of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of A3 Technology, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)[ERISA Section 103(a)(3) (C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of A3 Technology, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The A3 Technology, Inc. 401(K) Plan (the “Plan”) was established January 1, 2002. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of A3 Technology, Inc. (“the Company” or “Employer”) who have completed one hour of service within the eligibility requirements of the Plan Document. The Plan Trustee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may elect to contribute a maximum of 100% of their annual compensation, as defined in the Plan, on a pre-tax or after-tax (Roth) basis or the annual limitation established by Internal Revenue Code (the “Code”); whichever is less. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing contributions from other qualified plans (rollover contributions).

The Company makes safe harbor contributions equal to 100% of the participant’s elective match deferral contributions up to 3% of eligible compensation, plus 50% of the participant’s elective match deferral contributions that are between 3% and 5% of eligible compensation. Annually, the Company may also make a discretionary profit-sharing contribution at the option of the Company’s Board of Directors. Employees must have completed 1,000 hours of service during the year and be employed by the Company on the last day of the Plan year to be eligible for discretionary profit-sharing contributions. Contributions are subject to the IRS limitations.

All contributions are held in trust and invested by the Plan’s custodian in accordance with options elected by the participants (i.e. all investments are participant-directed).

Participant Accounts

Each participant’s account is maintained separately within the Plan and is credited with their elective deferrals, employer contributions and earnings. Participants may elect to have contributions invested in any or all of the funds of the Plan. Investment income and related management expenses are allocated to the participants’ accounts regularly. Allocation of employer contributions, investment income and administrative expenses are based on a participant’s compensation or account balance as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct all contributions in a variety of investment choices as more fully described in the Plan’s literature.

Vesting

Participants are immediately vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of service. A participant is 100% vested after six years of credited service.

Payment of Benefits and Withdrawals

The Plan is designed to provide benefits at the time of retirement. However, if employment with the Company is terminated because of death, disability, or any other reason, a request for distribution of a participant's account balance is allowed. If a participant dies while classified as an active member of the Plan, the participant's beneficiary or beneficiaries are entitled to receive the entire participant's vested account balance. Should a participant become totally and permanently disabled while employed by the Company, the full value of the participant's account balance may be distributed upon request.

Upon termination of employment, the vested amount of the participant's account will be distributed to the participant in a lump-sum cash payment if the participant's vested account balance is less than \$1,000. If the account balance is greater than \$1,000, the participant's written consent will be required for any distribution including the election of rollover distributions to a new qualified plan or installment payments. Otherwise, the Plan administrator will direct the Trustee to begin distribution no later than April 1 of the calendar year after the participant attains the age of 73. Upon reaching age 59 ½, participants may elect to take distributions from their accounts without any tax penalty in accordance with the Code.

Subject to certain limitations prescribed by the Plan and the Code, participants may elect hardship withdrawals. In accordance with the Code, a 10% premature distribution penalty tax may also be imposed on such withdrawals from a participant's account.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based on the terms of the plan document.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. If one-half of the vested account balance is less than \$10,000, the participant may borrow up to \$10,000. The loans bear a rate of interest based on prevailing interest rates as of the date of the loan application and are secured by the balance in the participant's account. Loans are repaid through payroll deductions in equal payments over the term of the loan (up to five years, or 30 years if for a principal residence). A participant may have no more than two outstanding loans from the Plan at any time which cannot be refinanced through the Plan. Upon termination of service, the principal and accrued interest shall be immediately due and payable. Participant loans at December 31, 2024 and 2023 totaled \$392,436 and \$232,804, respectively.

Forfeitures

Forfeited accounts are amounts forfeited by participants who have terminated their employment and are not fully vested in their employer account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,810 and \$1, respectively. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investments, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchase and sale of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative fees incurred in connection with loans and participant activity charges are borne by the individual and deducted from their respective account. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates due to risks and uncertainties.

Income Taxes

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. As of December 31, 2024 the Plan's tax returns generally remain subject to examination by major tax jurisdictions for the previous three years.

Subsequent Events Evaluation by Management

For the year ended December 31, 2024, the Plan evaluated subsequent events for potential recognition and disclosures through August 28, 2025, the date of financial statement issuance.

NOTE 4 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

The Plan invests in a general account backed group annuity contract that has been issued by Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in the custodial guaranteed interest contract. Participants who choose to invest in these options make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Balances in the general account backed group annuity contracts at December 31, 2024 and 2023 were \$2,268,141 and \$2,524,601, respectively.

As described in Note 2, because the investment contract with Principal Life Insurance Company is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this investment contract.

The investment contract issuer is contractually obligated to repay the principal and a specified interest rate, that is guaranteed to the Plan. The Principal Life Insurance Company may declare additional amounts on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month declaration year; they are not guaranteed for future years. The interest rate credited to participants for the benefit-responsive portion of the investment contract for the Plan resets semiannually. The following are the interest rates credited covering the periods January 1, 2023 to December 31, 2024:

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events which would limit the Plan's ability to transact at contract value with participants are not considered probable.

The investment contract does not permit Principal Life Insurance Company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds – These investments are public investment vehicles valued using the Net Asset Value (“NAV”) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of outstanding shares. The NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Pooled Separate Account – These assets are not available in an exchange or an active market; however, as a practical expedient, the fair value is determined based on the NAV of the underlying assets as traded in an exchange or active market. The Principal Life Insurance Company Pooled separate accounts are measured at fair value using the NAV per share as a practical expedient and has not been classified under the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Certain investments were managed by Principal Trust Company. Principal Trust Company was the recordkeeper and custodian as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions as defined by ERISA. The Plan paid fees during the year for investment advisement, investment management and other services rendered by parties in interest. Participant loans are also considered party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become one hundred percent vested in their employer contributions.

NOTE 8 – TAX STATUS

The Company has adopted an approved volume submitter plan which received an Internal Revenue Service (“IRS”) advisory opinion letter dated June 30, 2020 which indicated that the form of the Plan satisfied the qualification requirements of the Internal Revenue Code. Although the Plan has been amended since receiving that advisory opinion letter, the Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities and insurance contracts. There are no reserves against the insurance contracts for credit risks of the contract issuer or otherwise. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statement of net assets available for benefits.
