## Independent Auditors' Report

To the Plan Administrator  
of FramERICA Corporation 401(k) Retirement Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of FramERICA Corporation 401(k) Retirement Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 DESCRIPTION OF PLAN**

The following description of the FramERICA Corporation 401(k) Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of FramERICA Corporation (the "Company") who have completed six months of service and are age 20½ or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was restated effective September 1, 2021. This is an amendment and restatement to bring the Plan into compliance with the requirements of the 2017 Cumulative List. The Cumulative Lists identify changes in the qualification requirements of the Internal Revenue Code (IRC) that are required to be taken into account in a pre-approved plan document submitted under the pre-approved plan program administered by the Internal Revenue Service (IRS) and that will be considered by the IRS for purposes of issuing opinion letters.

**Contributions**

Each year, participants may contribute up to 15 percent of pre-tax annual compensation to traditional or roth contributions, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various collective investment trust accounts and an insurance investment contract as investment options for participants. The Company contributed 33-⅓ of the first six percent of base compensation that a participant contributed to the Plan through May 15, 2009, at which time the Company suspended its discretionary matching contributions due to financial hardship. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors and may be invested in a portfolio of investments as directed by the Company. No such discretionary profit-sharing contributions were made in 2024. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 25 percent vested after two years, 50 percent vested after three years, 75 percent vested after four years, and 100 percent vested after five years of credited service.

**Notes Receivable from Participants**

Participants are not permitted by the Plan to borrow from their accounts.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant will be automatically 100 percent vested and may elect to receive either a lump sum amount or distributions under a systematic withdrawal plan. For termination of service due to other reasons, a participant (or their beneficiary in the case of death) may receive the value of the vested interest in his or her account as a lump sum distribution. Any portion of a participant's account which is not vested will be treated as a forfeiture.

**Forfeited Accounts**

At December 31, 2024, there was a forfeited account of \$7,368. These accounts may be used to reduce future Company contributions. During the years ended December 31, 2024 and 2023, no accumulated forfeited non-vested participant accounts were available to reduce the Company's contributions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by investment advisors, custodians, and insurance companies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants on July 9, 2025 and May 17, 2024, respectively. The 2024 excess contributions were late as they were due on March 15, 2025. Because of this, the Plan was required to file a Form 5330 and pay a 10% penalty of \$1,902 that was paid on May 28, 2025.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of distributions are charged to the participant's account and are included in administrative expenses. Investment related expenses are also included in administrative expenses.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:**

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Investment Trust:**

Collective investment trust is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Pooled Separate Accounts:**

Pooled separate accounts are valued at quoted market prices of the underlying mutual funds and then adjusted by an expense factor as disclosed in each pooled account. This information is provided by the issuer of the pooled separate accounts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

We have not provided a fair value table by level classification as none of the investments are required to be classified as such. The following table sets forth the Plan's assets at fair value as of December 31:

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Plan has a fully benefit-responsive investment contract with Empower Life & Annuity Company of New York ("ELA"). ELA maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The investment contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus transfers to the fund and credited interest, less participant withdrawals, transfers out of the fund and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)**

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The crediting rate was 1.56% and 1.30% for 2024 and 2023, respectively. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include, but are not limited to the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax exempt under Section 501(a) of the IRC
- Premature termination of the contracts
- Plan termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations

The investment contract does not have any restrictions that impact the ability of the Plan to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. ELA may not terminate the contract at any amount less than the contract value.

**NOTE 6 EXCESS CONTRIBUTIONS PAYABLE**

Subsequent to December 31, 2024 and 2023, certain participant contributions were deemed to be excess contributions under the IRC. Such contributions, and the related investment earnings thereon, were refunded to Plan participants in 2025 and 2024, respectively. A liability for excess contributions in the amount of \$19,018 and \$25,363 was recorded in the Plan's financial statements at December 31, 2024 and 2023, respectively.

**NOTE 7 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are insurance contracts managed by ELA in 2024 and 2023. ELA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Interest income received by the Plan on the insurance contracts was \$9,945 for the year ended December 31, 2024. Fees paid by the Plan for the investment management services amounted to \$37,445 for the year ended December 31, 2024. Such fees included recordkeeper fees in the amount of \$31,957 paid to Empower Life & Annuity Insurance Co, investment advisor fees in the amount of \$4,013 paid to Leafhouse Financial Advisors, and investment management fees in the amount of \$1,475 paid to Empower Advisory Group, LLC.

**NOTE 8 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 9 TAX STATUS**

On June 30, 2020, the IRS stated that the non-standardized pre-approved profit-sharing/money purchase/CODA opinion letter adopted by the Plan, as then designed, qualifies under IRC Section 401. The Plan has not received a determination letter specified to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
