Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of Bernhardt Furniture Company Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bernhardt Furniture Company Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

December 31, 2024 and 2023

(1) Plan Description

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of Bernhardt Furniture Company ("Company"). Effective January 1, 2001, the Plan was amended to provide all employees with 30 days of employment an opportunity to contribute to the Plan and after twelve consecutive months of employment to begin receiving matching contributions. The Plan offers two options for saving, the "K" option, which is pretax dollars, and the "Roth K" option, which is in after-tax dollars. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors is responsible for the oversight of the Plan. The Company's investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

The Plan allows participants to contribute up to fifty percent of their compensation as defined by the Plan. In addition, the Company matches a percentage based upon years of service. Effective May 1, 2011, the board approved the match to be 25% of the first 6% of contributions. Effective May 1, 2020, the Plan Sponsor suspended matching contributions. Effective September 1, 2020, matching contributions were reinstated. Participants may also contribute amounts representing distributions from other qualified plans. The Plan allows automatic enrollment into the Plan for any employee who meets the eligibility requirements and who fails to affirmatively make any deferral election. These employees shall be deemed to have elected to defer two percent of compensation. Total contributions to the Plan cannot exceed the maximum amount deductible under section 404(a)(3) of the Internal Revenue Code of 1986, as amended. Other contributions consist of distribution funds from the Invesco Fair Fund U.S. Securities and Exchange Commission Administrative Proceedings.

(c) Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, matching contribution, and Plan earnings and charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Plan Description, Continued

(d) Vesting

Participants are fully vested in their accounts at all times.

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates determined by the Plan administrator.

(f) Payment of Benefits

Upon death, the value of the participant's account will be paid to the spouse or other beneficiary. If a participant terminates service before death or retirement, the value of the account will be paid directly to the participant on a deferred basis, normally in the year following the year of termination. If the participant retires, becomes disabled, dies, or resigns before retirement, payment will be made in a lump-sum. Benefit payments are recorded as expenses when they have been approved for payment and paid by the Plan.

(g) Administrative Expenses

Administrative expenses of the Plan are paid by either the Plan or the Company, as provided in the Plan document.

(h) Investment Options

Upon enrollment in the Plan, a participant may direct contributions into various investment options, as defined by the Plan.

(i) Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provision set forth in ERISA.

(j) Unallocated forfeitures

Unallocated forfeitures at December 31, 2024 and 2023, were \$3,648 and \$0, respectively. Forfeitures may be used to reduce company contributions or reallocated to plan participants. Non-vested forfeitures used to reduce the employer's contribution for the years ended December 31, 2024 and 2023, were \$0 and \$5,517, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the loan balance is reduced and a benefit payment is recorded.

(2) Summary of Significant Accounting Policies, Continued

(e) Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Bank.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(3) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. These are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These investments are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

(4) Group Annuity Contract with New York Life Insurance Company

In 2005, the Plan entered into a benefit-responsive group annuity contract with New York Life Insurance Company (New York Life). New York Life maintains the contributions in two distinct accounts, the Stable Value Account and the Pooled Separate Account No. 25. The Stable Value Account represents the guarantee that New York Life is making to the plan sponsors participating in the group annuity contract. The assets in the Pooled Separate Account No. 25 are invested primarily in fixed income securities, which are owned by New York Life. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. In accordance with ASU 2015-07, the group annuity contract is presented in the financial statements at its contract value. Contract value, as reported to the Plan by New York Life, represents the contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal and transfer of all or a portion of their investment at contract value.

(4) Group Annuity Contract with New York Life Insurance Company, Continued

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$8,223,279 and \$9,329,237, respectively. Interest is accrued daily and credited monthly to the Stable Value Account and reflects the investment experience of Pooled Separate Account No. 25. Interest rates are guaranteed by New York Life to be no less than zero percent, before any deduction for expenses.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

At contract termination, the Plan may receive a book value distribution of the Plan's interest in the Stable Value Account, provided the plan sponsor provides twelve months' advance written notice to New York Life.

(5) Distributions Payable

There were no distributions payable as of December 31, 2024 and 2023.

(6) Tax Status

Effective June 1, 2013, the Plan adopted a non-standard form of a prototype plan sponsored by Charles Schwab Bank. The prototype plan was amended and restated effective May 1, 2021. The current prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status dated September 21, 2020. The prototype plan opinion letter has been relied upon by this Plan. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

(6) Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related Party Transactions

Certain Plan investments are shares of mutual funds and units of participation in common trust funds managed by the custodian. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were \$157,506 and \$124,351 for the years ended December 31, 2024 and 2023, respectively.

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

(9) Subsequent Events

The Company has evaluated subsequent events through August 20, 2025, the date which the financial statements were available to be issued. There were no significant subsequent events identified which require disclosure in the financial statements or footnotes.
