Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the International Dairy Queen, Inc. Retirement Savings Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan covering substantially all employees of International Dairy Queen, Inc. (the “Plan Sponsor”) and participating affiliates (collectively “the Company”). The Plan was adopted on February 1, 1985. The Plan is sponsored and administered by the Company, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Empower Trust Company, LLC (the “Trustee”) serves as the trustee and custodian of the Plan.

Participation—Employees of the Company age 21 or older are eligible to participate in the Plan upon satisfying established service hour eligibility requirements. Employees who are full-time and do not meet the part-time, temporary and seasonal exclusion become eligible on the first day of the month following 30 days from hire date. All part-time employees who do not meet the full-time requirement are eligible after completing 1,000 hours in a 12-month period. The Plan has an automatic enrollment feature for new and existing employees at a deferral rate of 6% of eligible compensation with an automatic increase of 1% of eligible compensation per year until the participant reaches a deferral rate of 10%. Employees may opt-out of automatic enrollment and automatic annual increase at any time.

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, and (iii) participant rollovers from another qualified plan. Participating employees voluntarily contribute to the Plan in 1% increments of their eligible compensation, as defined in the Plan document. Such contributions may be pretax to a regular 401(k) account or post-tax to a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company makes a matching contribution to the Plan to employees who are eligible on the first day of the month following 30 days from hire date. For the Plan year ended December 31, 2024, the qualified matching contribution was 100% of the first 2% deferral and 50% of the next 1% to 4% of deferrals for a maximum of 4% of eligible compensation made by the participant.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related matching and Plan earnings. Participant accounts are also charged with withdrawals, expenses, and an allocation of plan losses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants may direct the investment of their contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

The Company's matching contribution is automatically invested in the same investment option as the participant's contributions.

Vesting—Participants are immediately vested in both participant and Company match contributions, plus actual earnings thereon.

Notes Receivable from Participants—Participants may borrow from their accounts an amount from \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years, and principal residence loans must be repaid in 10 years. As of December 31, 2024, participant loans have maturities through 2029 at interest rates between 4.25% and 9.50%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. In the event of the death of the participant, benefits will be paid to the participant's beneficiary.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships with the approval of the trustees. Participants are also eligible to make in-service withdrawals who have reached at the age of 59.5. If the value of a participant's vested account balance is less than \$7,000 upon termination of employment, the entire balance will be distributed to the participant in a lump sum. Effective April 1, 2024, the value increased from \$5,000 in accordance with SECURE 2.0 Act of 2022.

Forfeited Accounts—The Plan Sponsor has elected to use forfeitures to reduce future safe harbor employer contributions and plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Concentrations of Investments—Based on market factors and performance, certain investment fund balances in the Plan can represent more than 10% of total investments in the statements of net assets available for benefits. There was a total of four and two individual investment fund balances representing more than 10% of total investments as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Administrative Expenses—Recordkeeping fees of the Plan are paid by Plan participants through a reduction in their account balances. Investment advisor fees and other expenses of the Plan are paid by the Plan Sponsor. Participants pay administrative costs for loans, distributions, and qualified domestic relation orders.

The Plan has a revenue sharing agreement whereby certain investment managers return a portion of the investment fees back to the participant accounts that invest in those investment funds to offset the Plan's administrative expenses. For the year ended December 31, 2024, \$19,954 was returned to participant accounts to offset administrative expenses under the revenue sharing agreement.

Fees paid for investment management services were included as a reduction of the return earned on each fund.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid at December 31, 2024 or 2023.

Subsequent Events—Subsequent events were evaluated through September 4, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan became subject to provisions requiring increased catch-up contributions for participants ages 60 to 63, in accordance with the SECURE 2.0 Act of 2022. The Plan Sponsor intends to implement applicable SECURE 2.0 provisions in accordance with regulatory guidance and the prescribed amendment deadlines.

3. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Empower Trust Company, LLC.

4. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Certain investments are measured at fair value on a recurring basis in the statements of net assets available for benefits. The following methods and assumptions were used to estimate the fair values:

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts—Accounts primarily consist of money market funds that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

Collective Trust Funds—Valued at the net asset value of units of a bank collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

International Dairy Queen, Inc. is the Plan sponsor and Empower Trust Company, LLC is the trustee and recordkeeper, as defined by the Plan. Empower Trust Company, LLC also manages certain investment options available to Plan participants. Therefore, these transactions qualify as exempt party-in-interest transactions.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts. These transactions qualify as exempt party-in-interest transactions. As of December 31, 2024 and 2023, notes receivable from participants, which qualify as party-in-interest transactions, totaled \$574,645 and \$581,098, respectively.

The Plan paid \$152,763 in total administrative expenses during the year ended December 31, 2024. These expenses include fees paid to Empower Trust Company, LLC (the Plan's trustee and recordkeeper), Empower Annuity Insurance Company of America, and other affiliates.

6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants will remain 100% vested in their accounts.

7. FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated November 14, 2022, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
