Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

Note 1: Description of the Plan

The following description of the Lakepoint 401(k) Plan (the Plan) provides only general information. Refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, established January 1, 2023, covering employees of Lakepoint Augusta, LLC d/b/a Lakepoint (the Company). Employees are eligible to begin deferring contributions and receiving the company matching contributions on the first day of the quarter after attaining age 21 and completion of six months of service. Employees must be employed on the last day of the Plan year to receive a profit sharing contribution, unless termination is due to retirement, death or disability. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions - Self Directed

Participating employees are automatically enrolled into the Plan at 3% with an automatic increase of participant deferrals by 1% of compensation per paycheck up to a maximum rate of 10% on the first day of each Plan year. Participants may elect to contribute a percentage up to the maximum allowed by law of their annual compensation, as defined in the Plan document, to the Plan on a tax-deferred basis. Participants are eligible to make after tax (Roth) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Rollovers from qualified plans are allowed under the provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and one money market fund to plan participants.

Employer Contributions

Each year, the Company may choose to make a discretionary match. For the years ended December 31, 2024 and 2023, the Company paid a match of \$131,282 and \$64,849, respectively. For this plan year, the Company elected to match 100% of salary deferrals that do not exceed 3% of the employees' compensation. To be eligible for the employer matching contribution the participant must have attained age 21 and have completed six months of service.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make profit-sharing contributions, as defined in the Plan document. Profit-sharing contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. To be eligible for the profit-sharing contributions, the participants must be employed on the last day of the Plan year and have completed six months of service. The Company has elected not to provide a profit sharing contribution for the 2024 and 2023 plan years. Company contributions, both matching and profit-sharing, are invested in the participant directed accounts in the same manner as the employee deferrals.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution and allocations of the employer's matching contribution, any employer discretionary profit-sharing contribution and plan earnings. Participants' accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan provides vesting in the employer's discretionary matching and profit sharing contributions of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service. An employee who becomes disabled or dies will become 100% vested in employer's contributions.

Participant Loans

The Plan does not permit participants to borrow against their accounts.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. Under the current plan, distributions for terminated participants with account balances less than \$5,000 will be made upon termination. Participant consent is required if the balance exceeds \$5,000. For automatic distributions of participant account balances greater than \$1,000 up to \$5,000, the accounts are rolled directly to individual retirement accounts. The Plan also allows for in-service and hardship distributions subject to plan provisions.

Forfeitures

Forfeitures represent the non-vested portion of participant account balances upon termination. Forfeitures of company matching funds are used to pay administrative expenses and reduce employer contributions to the Plan for the following plan year. Amounts forfeited during the years ended December 31, 2024 and 2023 were \$4,841 and \$489, respectively. In 2024 and 2023, forfeitures used to reduce employer contributions and pay plan expenses were \$4,364 and \$489, respectively. The forfeiture account balance at December 31, 2024 and 2023 was \$477 and \$0, respectively.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expenses are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employees' payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions of a participant requesting distribution but not receiving it until the subsequent year.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by Ascensus, LLC (the Custodian) as of the Plan's year end. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access as of the measurement date.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Money Market Fund

Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Related Parties and Parties in Interest

The Company absorbs a portion of the Plan's administrative fees, the cost of audit fees related to the Plan and the cost of fidelity bonds. As the Plan does not reimburse the Plan Sponsor for the costs of such services, they are not included in these financial statements.

Investment related expenses are included in the administrative expenses. Ascensus, LLC performed the duties of third party administrator and recordkeeper during 2024 and 2023. These transactions qualify as exempt party-in-interest transactions.

Administrative functions are performed by officers or employees of the Plan Sponsor. Additional party-in-interest transactions include the audit fees paid to Varney & Associates, CPAs, LLC and advisor fees paid to Gallagher Fiduciary Advisors, LLC, and administrative fees paid to Meadowlark Hills. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020 for Ascensus, LLC on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code. Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
