Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nexstar Media Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Nexstar Media Group, Inc. 401(k) Plan (“the Plan”), formerly the Nexstar Broadcasting Group, Inc. 401(k) Plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan sponsored by Nexstar Media Group, Inc., (“the Company” or “Plan Sponsor”), formerly Nexstar Broadcasting Group, Inc. for the benefit of its employees. The original effective date of the Plan was January 1, 1997. The Plan was amended and restated effective June 17, 2024.

Times Mirror ESOP

Certain Plan participants who were formerly employees of The Times Mirror Company, the Los Angeles Times, Matthew Bender & Company, Inc., Achieve Global, Inc., The Morning Call, Inc., Newsday and Times Mirror Magazines, Inc. have accounts in the Plan that hold investments attributable to The Times Mirror Employee Stock Ownership Plan (the “Times Mirror ESOP”).

Benefits under the Times Mirror ESOP are coordinated with participants’ defined-pension benefits held in the Tribune Media Company Retirement Plan (“Retirement Plan”). Under this arrangement, a participant receives a pension benefit equal to the greater of his or her applicable pension benefit amount or the annuity equivalent of the participant’s Times Mirror ESOP account balance. At retirement, if a participant does not affirmatively elect to receive his Times Mirror ESOP account balance as a lump sum distribution, the participant’s Times Mirror ESOP account balance will automatically be transferred to the Retirement Plan in accordance with procedures established by the Plan administrator. Transfers of assets represent Times Mirror ESOP account balances that were transferred from the Plan to the Retirement Plan of which \$747,097 was transferred in 2024 and \$2,837,568 will be transferred in 2025 but are related to account balances as of December 31, 2024.

Eligibility

Employees are eligible to participate in the Plan upon reaching the age of twenty-one and completing service requirements as defined in the Plan literature. Employees can join the Plan as an active participant on the first day of each calendar month, following their completion of the service requirement. Employees covered under collective bargaining agreements, who meet the conditions of eligibility to participate as defined by the Plan literature are also eligible to participate in the Plan. Service for purposes of eligibility and vesting, as provided by the Plan, includes service with certain predecessor employers described in detail in the Plan literature. The Plan also contains an automatic enrollment feature. The Plan’s automatic enrollment contribution feature will begin for newly eligible participants 30 days after a participant’s date of hire. A participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an increase of 1% each year until it reaches a maximum 10%.

Contributions

Participants may elect to contribute up to 90% of their annual compensation, as defined by the Plan, subject to IRS limitations. Participants are permitted to contribute pre-tax or “Roth” contributions into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who are eligible to make catch-up contributions may elect to contribute up to 100% of their annual compensation, as defined by the Plan, subject to IRS limitation. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS

As of December 31, 2024 and 2023, and for the Year Ended December 31, 2024

The Company, at its discretion, may elect to match participant contributions. Participants are eligible to receive employer matching contributions based on the service requirements as defined by the Plan literature. For the year ended December 31, 2024, the Company made contributions equal to 50% of the first 6% of compensation that a participant contributed to the Plan. The Plan also provides that the Company may make additional non-elective employer contributions on a discretionary basis. No such contributions were made during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions. Earnings and losses are credited to each participant's account based on the performance of the underlying investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants can direct contributions into a variety of investment options offered by the Plan. Participants also have the option of investing in a self-directed brokerage account.

Vesting

Participants are always fully vested in their elective contributions and any earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest in the Company's contributions over five years at a rate of 20% each year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans may have a maximum repayment period of five years, unless the loan is used to purchase a participant's principal residence which has a maximum repayment period of ten years. Participants may have up to two loans outstanding at one time. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan at a rate determined by the plan administrator. The interest rates on notes receivable from participants outstanding at December 31, 2024 and 2023 ranged from 3.25% to 9.5%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to all or a portion of the value of the participant's vested interest in his or her account in the form of a lump sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, subject to minimum balance distribution requirements, or installment payments if the participant's balance exceeds \$5,000. A participant may withdraw part of the vested interest in his or her account upon attainment of age 59 1/2, subject to Plan provisions. Upon separation with the Company, participants with account balances less than \$5,000, a single lump sum payment will be made automatically into an individual retirement account of the plan administrator's choosing. The Plan document further stipulates that account balances less than \$1,000 are to be automatically paid to the participant, without consent. In addition, the Plan permits hardship distributions to participants that can demonstrate an immediate and heavy financial need.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts available to reduce future expenses and offset employer match contributions totaled \$2,740,261 and \$1,804,416, respectively. During the year ended December 31, 2024, participants forfeited \$1,656,601 in previously contributed non-vested amounts. During the year ended December 31, 2024, \$875,230 of forfeited amounts were used to reduce Plan expenses and employer match contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. Refer to Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in appreciation (depreciation) of fair value of investments.

Administrative expenses are reported net of \$423,506 in revenue credits. The revenue credit relates to a portion of fees paid by certain investment managers and is shared with the Plan record keeper and used to offset the normal costs of general Plan recordkeeping and administration. When those shared fees exceed the normal recordkeeping and administration costs, the record keeper returns those funds to the Plan in the form of a revenue credit, which may be used to pay for certain qualified expenses.

3. Information Certified by the Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

4. Fair Value Measurements

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end money market fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value ("NAV") and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are

required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued based on the fair value of the underlying investments of each collective trust. The Funds are valued using NAV as provided by the investment account manager as a practical expedient. The collective trusts provide for daily redemptions at reported net asset values per share, with no advance notice requirement.

Self-directed brokerage: Self-directed brokerage account consists of cash, common stocks and mutual funds which are traded at the last available traded price on a securities exchange or other regulated market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds, common collective trusts and a money market fund managed by Fidelity Management Trust Company or an affiliate thereof. Fidelity Management Trust Company is the Plan's trustee and, therefore, these transactions qualify as party-in-interest transactions; however they are exempt from the prohibited transactions rules under ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, the Plan also made direct payments to the advisor of \$218,256 through revenue sharing. These costs incurred by the Plan are included in administrative expense on the statement of changes in net assets available for benefits. The Plan Sponsor pays directly certain legal fees related to the Plan's operations.

6. Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA, upon written notice to the participants. In the event of plan termination, participants' account balances will become fully vested and non-forfeitable.

7. Tax Status

The Plan adopted a volume submitter profit sharing plan with cash or deferral arrangement sponsored by Fidelity Management & Research Co. ("Fidelity"), which received a favorable opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the volume submitter, as then designed, was acceptable under Section 401(a) of the Code ("IRC"). The Plan itself has not received a determination letter from the IRS. However, Plan management believes the Plan, as adopted and amended, is operating within the guidelines of the IRC. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits taken by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.
