### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits*

We have performed audits of the financial statements of the Mizuno USA, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### *Opinion*

## Notes to the Financial Statements

December 31, 2024 and 2023

### (1) Description of plan

The following description of the Mizuno USA, Inc. 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted on April 1, 1990, to provide retirement benefits for employees of Mizuno USA, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees who are age twenty-one or older and have completed 90 days of service (participants). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### (b) Contributions

Participants may voluntarily make contributions up to 50% of their eligible compensation to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code (IRC). Participants may also make contributions in the form of an after-tax Roth contribution as well as contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor elected to make safe harbor matching contributions of 100% of each participant's contribution, up to a maximum of 6% of the participant's total annual compensation. The Plan Sponsor's contributions are allocated in the same manner as those of the participant's elective contributions. The Plan Sponsor may also elect to make discretionary contributions to the Plan; however, no discretionary contributions have been made to the Plan in 2024 or 2023.

Plan Sponsor and participant contributions may not exceed the maximum amount deductible for federal income tax purposes.

#### (c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, Plan Sponsor contributions, investment earnings (losses), and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**(d) Vesting**

Participants are immediately vested in their elective salary deferral contributions and Plan Sponsor safe harbor matching contributions plus actual earnings (losses) thereon.

Plan Sponsor non-safe harbor matching contributions and any discretionary contributions are subject to a five-year graded vesting schedule at 20% per year based upon the number of years of service, as defined in the plan document.

**(e) Participant notes receivable**

Each participant may borrow from his or her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The notes are secured by the balances in the respective participants' accounts and bear interest at fixed rates ranging from 4.16% to 9.50% as of December 31, 2024, which are determined at the time of the borrowing by the plan administrator and are commensurate with local prevailing rates. Principal and interest are collected through payroll deductions.

**(f) Payment of benefits**

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive either a lump-sum payment or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document and to those participants that have attained age 59½.

**(g) Forfeited accounts**

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor non-safe harbor matching and discretionary contribution portion of their accounts. Such forfeitures may be used to pay plan expenses or reduce the Plan Sponsor's safe harbor matching contributions to the Plan. On December 1, 2024, an amendment was signed that allowed the Plan Sponsor to use forfeitures to reduce all employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$24,771 and \$29,539, respectively. In 2024, Plan Sponsor contributions were reduced by \$15,425 from forfeited nonvested accounts. There were no forfeitures utilized in 2023.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's salary deferral contributions, vested Plan Sponsor contributions and earnings (losses).

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor which are excluded from these financial statements. Fees related to the administration of participant notes receivable, benefit payments, and recordkeeper maintenance are charged directly to the applicable participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined by utilizing information provided by the investment advisers and Empower Annuity Insurance Company of America and Empower Trust Company, LLC, (collectively, "Empower"). See Notes 4 and 5 for discussion of fair value and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

(c) Participant notes receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024, and September 2, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

The fair value and contract value of investments and participant notes receivable held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, dividend and interest income, and interest on participant notes receivable for the years ended December 31, 2024 and 2023, as reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower.

(4) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 and Level 3 are not applicable to the Plan.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values (NAV) of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Investment contract with insurance company

The Plan offers an investment option with Empower Annuity Insurance Company of America, the guaranteed interest fund. The contract underlying this investment option is considered to be fully benefit-responsive. The insurance company maintains the Plan's contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The interest crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The interest crediting rate is reset quarterly. As of December 31, 2024 and 2023, the contract value of the investment in the guaranteed interest fund was \$1,240,134 and \$1,251,067, respectively.

The underlying contract has no restrictions on the use of plan assets and there are no valuation reserves recorded to adjust contract amounts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to plan documents (including a complete or partial plan merger with another plan), (ii) changes to the Plan's prohibition on competing investment options; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed interest fund does not permit Empower to terminate the agreement prior to the scheduled maturity date.

#### (6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) on November 14, 2022, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (7) Related party and party-in-interest transactions

Certain plan assets are a mutual fund and a guaranteed interest fund managed by Empower, and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds participant notes receivable which also qualify as party-in-interest transactions.
