INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of the Horizon Resources Co-op 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Horizon Resources Co-op 401(k) Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. 1. DESCRIPTION OF THE PLAN

The following description of the Horizon Resources Co-op 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted in 1995 with an effective date of January 1, 1995. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a profit sharing plan covering substantially all employees of Horizon Resources (the Company or Plan Sponsor) except for union employees and non-resident alien employees.

Employees not otherwise excluded become eligible after obtaining age 21 and completing one year of service and 1,000 hours. Employees may enter the Plan on the first day of the calendar quarter subsequent to satisfying the eligibility requirements.

The Plan was restated effective January 1, 2021 pursuant to the cycle three restatement period and current SECURE and CARES Acts legislation.

Plan Administration

The Plan is administered by the Trustees, who have engaged an independent third-party administration firm to perform recordkeeping services. The Trustees have also retained an independent investment consultant to provide investment advisory services. All Plan assets are held in trust for the exclusive benefit of participants and their beneficiaries.

Contributions

Participants may contribute pre-tax elective deferrals into the Plan. Effective October 1, 2023, the Plan was amended to allow participants to contribute Roth elective deferrals into the Plan. All newly eligible participants that do not make a retirement savings election, shall be deemed to make a pre-tax contribution of three percent per pay period. Participants may contribute up to 50% of defined earnings, as limited by §402(g) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants can also contribute amounts representing rollover distributions from certain other tax-qualified retirement plans. Rollover contributions were \$0 and \$56,304 for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan.

A safe harbor basic matching contribution will be made to eligible employees equal to 100% of the participant's elective deferrals that do not exceed 3% of compensation, plus 50% of the participant's elective deferrals that exceed 3% of compensation but do not exceed 5% of compensation. Safe harbor basic matching contributions were \$351,936 and \$323,077 for the years ended December 31, 2024 and 2023, respectively. In addition, the Plan allows for discretionary profit sharing contributions that would be determined by the Company each year, if made.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions into any of a variety of funds made available through the Plan. The Plan Sponsor may change the investment options offered at any time, as deemed appropriate. Participants have access to their account information through the Internet and may make allocation changes, subject to the Securities & Exchange Commission restrictions on excess trading.

The fund offerings are intended to provide participants with a variety of investment options over the usual range of asset classes with varying risk categories from conservative to aggressive. The prospectuses of the various funds offer detailed information on the characteristics, operations, management and expenses of the investments offered.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Loan terms range from one to five years or up to thirty years for the purchase of a primary residence. A participant may have no more than one loan outstanding at a time. The loan is secured by the balance in the participant's account and bears interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor matching contributions, and employer profit sharing contributions, plus actual earnings thereon. All participant accounts are currently 100% vested.

Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount. A participant may only elect to receive partial withdrawals or installments with respect to required minimum distributions, over a period of not more than the participant's assumed life expectancy. A mandatory distribution is required if the account balance is less than \$1,000.

The Plan also allows hardship distributions from employee deferral and rollover accounts.

Forfeitures

Forfeitures can be used to offset employer contributions. There were no forfeitures for the years ended December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis.

Investment Valuation and Income Recognition

The Co-op 401(k) Trust ("the Trust") was established in 1995, to hold the investment assets of plans in part sponsored by Horizon Resources. Investments, and the income thereon, are allocated to participating plans based on each plan's participation in investment options within the trust. Accordingly, the Plan's investment gains (losses) for the years ended December 31, 2024 and 2023, includes its allocable share of the trust's interest and dividends and net appreciation (depreciation) in fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan entered into a fully benefit-responsive traditional group annuity contract primarily with an insurance carrier. This contract, the Co-op 401(k) Stable Value Fund, is fully benefit-responsive. A fully benefit-responsive contract provides for a stated return on principal invested over a specified period and permits withdrawals at contract value for benefit payments, loans, or transfers. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Accordingly, the fully benefit-responsive group annuity contract is included in the financial statements at contract value.

Investments, other than the stable value fund, are based on the issuer's assumptions about the investments value, and are held in the trust and stated at fair value. The registered investment company funds are quoted at market prices, which represent the net asset value underlying investments held by the registered investment company.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from eligible compensation.

Administrative Expenses

Investment related administrative fees are paid by the Plan as direct expenses and are also included in net appreciation (depreciation) of the fair value of the investments, as indirect compensation. Participants may be charged distribution fees upon withdrawal of their accounts. All other fees associated with the Plan are paid by the Plan Sponsor.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles generally requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. INTEREST IN CO-OP 401(k)

The Plan's investments are in the Trust which was established for the investment of assets of the Plan and several other Cooperative company sponsored retirement plans. Each participating retirement plan has an undivided interest in the Trust. The assets of the Trust are held at Charles Schwab Trust Company (Trustee). The Trust year ended December 31, 2024. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Trust was approximately 1.80% and 1.83%, respectively. Investment income and administrative expenses relating to the Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

4. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) developed the Accounting Standards Codification (ASC) 820, "Fair Value Measurements," to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under the "Fair Value Measurements" guidance are described as follows:

Level 1 - observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets that the Plan has the ability to access.

Level 2 - observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Registered investment companies: Valued at the net asset value of shares held by the Plan at year end. Registered investment companies held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INVESTMENT CONTRACT

The Plan's trust holds a portfolio of investment contracts that comprises synthetic investment contracts and a guaranteed investment contract separate account. These contracts meet the fully benefit-responsive criteria and therefore are reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the disaggregate of contract value between types of investment contracts held by the Plan.

A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan.

The synthetic investment contracts held by the Plan include wrapper contracts that provide a guarantee that the credit rate will not fall below zero percent. Cash flow volatility (for example, timing of benefit payments) as well as asset under performance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

6. TAX STATUS

The Plan is a non-standardized pre-approved profit sharing plan, which obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan Sponsor believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no such tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the assets will be distributed to participants in proportion to their respective account balances.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. PARTY-IN-INTEREST TRANSACTIONS

The Plan permits the payment of expenses which are incurred by or attributable to a particular individual based on the use of a particular plan feature to be assessed against an individual participant's account. Examples of these are loan fees, expenses related to qualified domestic relations orders (QDROs) and distributions. A portion of the fees incurred by the Plan for Trustee services are included in net appreciation (depreciation) in the fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid administration fees to Milliman, Inc. of \$42,664 and \$42,296 for the years ended December 31, 2024 and 2023, respectively. The Plan paid investment advising fees to Agri-Invest, LLC of \$7,484 and \$6,598 for the years ended December 31, 2024 and 2023, respectively.

The Plan Sponsor pays directly any other fees related to the Plan's operations.
