We have performed audits of the financial statements of Weinbrenner Shoe Company Savings Plan for Collectively Bargained Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1: Description of Plan

The following description of the Weinbrenner Shoe Company Savings Plan for Collectively Bargained Employees (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan was established January 29, 1988, and was restated effective July 7, 2022. It is a defined contribution plan covering all employees of Weinbrenner Shoe Company, Inc. (the "Company") who are members of the collective bargaining unit and are not employees who normally work less than six months during a plan year or non-resident aliens. Employees are eligible to participate on January 1, April 1, July 1, or October 1, on or after their six-month employment anniversary. The Plan allows for automatic enrollment of 8% of eligible pretax compensation if no election or waiver is made by the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Contributions

Each year, participants may contribute pretax compensation or Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The collective bargaining agreement negotiated between the Company and representatives of the collective bargaining unit covering employees of the Company requires the Company to make a matching contribution equal to each participant's contribution up to 6% of the participant's base salary. Rollovers are not matched. The Company's matching contribution was \$406,650 for the year ended December 31, 2024.

### **Note 1: Description of Plan** (Continued)

#### **Contributions** (Continued)

The Company may also contribute a discretionary nonelective contribution to be determined in its sole judgment with respect to each plan year. This contribution is allocated in proportion to all eligible participants' compensation to each participant who has completed at least 1,000 hours of service during the plan year and is employed by the Company on the last day of the plan year. There were no discretionary nonelective contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Plan's matching contribution, and an allocation of (a) the Plan's discretionary nonelective contribution, and (b) plan earnings (losses), and charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in all participant and Company contributions plus actual earnings (losses) thereon.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.00%. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Benefits may be paid to a participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. A participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, installments, or ad-hoc distributions if the account balance is greater than \$7,000. If the participant's vested account balance does not exceed \$7,000, it can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's elective deferral contributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through August 13, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 3: Fair Value Measurements (Continued)

*Collective investment trust funds* - Valued at the NAV of the underlying investments held by the collective investment trust, as reported by the fund house or other investment provider. The underlying investments are valued and published daily and transact at that price.

*Collective trust - Galliard Stable Return Fund J*: Fair value of the collective trust fund is estimated using NAV as a practical expedient, exclusive of the adjustment to contract value. The Fund is 100% invested in the Galliard Stable Return Fund Core, which invests in investment contracts and security-backed contracts. The fund seeks to provide investors with a moderate level of stable income without principal volatility. The use of NAV as fair value is deemed appropriate because the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

### **Note 4: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Custodian of the Plan.

### **Note 5: Tax Status**

The Company adopted a nonstandard prototype document with an IRS opinion letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **Note 8: Party-in-Interest Transactions**

Plan investments are managed by the Custodian, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fee incurred and paid by the Plan to its investment advisors, Empower Advisory Group, LLC and Whalen Capital, also qualify as party-in-interest transactions.

### **Note 8: Party-in-Interest Transactions** (Continued)

The Plan also paid administrative fees to Empower Trust Company, LLC, the Custodian of the Plan, and Corporate Retirement Solutions, LLC, the third-party administrator of the Plan; therefore, these transactions also qualify as party-in-interest transactions.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
