## **INDEPENDENT AUDITOR'S REPORT**

To the Administrative Committee of

### **Opinion**

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor’s Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Emphasis of Matter**

As discussed in Note 2, investments amounting to \$4,559,094 as of December 31, 2024 and \$5,436,396 as of December 31, 2023 have been valued at estimated fair value as determined by independent appraisals that have been reviewed and approved by Plan’s management. This amount represents 99.40% and 99.50% of the Plan’s net assets available for benefits as of December 31, 2024 and 2023, respectively. Our opinion is not modified with respect to this matter.

## Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The schedule of assets (held at end of year) as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF PLAN**

The following description of the Die-Matic Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Die-Matic Corporation (the Company) that have one year of service providing they worked at least 1,000 hours during such plan year and are age 21 or older. Participants who do not have at least 1,000 hours of service during such plan year, have not reached age 21, or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions for such year. Effective January 1, 2024, the Plan was amended to waive the 1,000 hour and being employed on the last day of the plan year requirements for participants who die, become disabled, terminate employment due to becoming disabled, or terminate employment after attaining normal retirement age during the plan year. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (IRC), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan purchased Company common shares of stock using the proceeds of a borrowing guaranteed by the Company and held the stock in a trust established under the Plan. The borrowing was repaid over a period of ten years by fully tax-deductible Company contributions to the trust fund. As the Plan made each payment of principal, an appropriate percentage of stock was allocated to eligible participants' accounts in accordance with applicable regulations under the Code. The loan is paid in full and all shares have been fully allocated.

Contributions

The Company is obligated to make contributions in cash to the Plan that, when aggregated with the Plan's interest earnings, equals the amount necessary to enable the Plan to fund current year distributions. Contributions are subject to certain limitations as mandated by the IRC. The Plan does not allow for voluntary contributions by employees.

Participant Accounts

A separate individual account is established for each participant, with each participant's account credited as of the last day of each plan year with an allocation of (a) any Company contributions, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. All shares held by the Plan are allocated to participant accounts and there were no unallocated assets or liabilities as of December 31, 2024 and 2023.

Voting Rights

The shares of Company stock held in the Plan will be voted by the trustees. However, in the event of a stockholder vote with respect to a major corporate event such as a corporate merger or consolidation, recapitalization, liquidation, or sale of substantially all of the corporate assets, the participant is entitled to direct the trustee on how to vote the shares of Company stock allocated to their account. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, employer stock that is held by the Plan and its participants which is not readily tradable on an established market, or is subject to trading limitations, must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits

Distributions will not be made until a participant retires, dies (in which payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share.

Payment of Benefits (Continued)

Effective January 1, 2024, the Plan was amended to allow in-service distributions to active participants who have accrued 5 years of plan participation by January 1 of the current plan year and are or will attain age 65 by December 31 of the current plan year. Eligible participants who elect to receive an in-service distribution of their full account balance will not be eligible to receive any additional allocations of employer contributions in the year of distribution or any future years.

The Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan. For the years ended December 31, 2024 and 2023, the Plan distributed 6,947.09 and 2,788.94 shares, respectively (excludes forfeited shares reallocated).

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the balance in their stock account, less any amounts previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify can receive a cash distribution or roll over amounts into another qualified account.

Vesting

Participants' vesting of their account is based on years of service for any reason other than retirement, disability or death. A year of service consists of 1,000 hours in a calendar year. Participants become vested in their accounts based upon years of service as follows:

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (US GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The investment in Die-Matic Corporation common shares is valued as of December 31, 2024 and 2023 at \$4,559,094 (\$126.80 per share) and \$5,436,396 (\$151.20 per share), respectively, based upon an appraisal performed by an independent valuation firm, and approved by management. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor (DOL). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the years ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

**3. ADMINISTRATION OF TRUST ASSETS**

The Plan's assets, which consist principally of Die-Matic Corporation common stock, are held by the trustee of the Plan. Company contributions are held and managed by the trustee, which invests cash or stock received, interest, and makes distributions to participants. The Plan is administered by an administrative committee comprised of individuals appointed by the Company's Board of Directors and administers the Plan for the exclusive benefit of participants and their beneficiaries.

Certain administrative functions are performed by officers or employees of the Company who make up the administrative committee. No such officer or employee receives compensation from the Plan or trust. Administrative expenses for the trustee's fees are paid as determined by the Company's Board of Directors and are excluded from the Plan's financial statements.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,

- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Demand deposit accounts:* Valued at the deposit account balances, payable on demand.

*Common stock:* Investments in the Company common stock are valued by an independent appraisal as of the last day of each annual reporting period. In approaching the valuation, a variety of factors are taken into consideration, including:

- a. The nature and history of the business, its current position, and its outlook,
- b. The general and relevant economic conditions prevailing at the time of the appraisal; and
- c. The current conditions and outlook in the market in which the subject company competes.

The approach to determining fair value of the common stock involved the following:

- a. Determine estimated fair value of shares of common stock using the Adjusted Net Asset Value Method. This approach uses various methods that consider the value of each individual asset and liability. These values are then ‘substituted’ for the values of the assets and liabilities on the Company’s balance sheet, and the net asset value by subtracting the liabilities from the assets.
- b. Determine estimated fair value of shares of common stock using the Discounted Future Net Cash Flows Method. Discounted Cash Flow Method values a company based on projected cash flows.
- c. Weighted the various methods to reflect the relevance of the method to the Company’s situation. 70% was weighted for indicated value from the Discounted Future Net Cash Flows Method and 30% was weighted for the indicated value from the Adjusted Net Asset Value Method.

These policies and procedures are reassessed annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions and terminate the Plan at any time, subject to provisions or ERISA. In the event of plan termination, participants would become 100% vested in the value of their account and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

**7. TAX STATUS**

The Company adopted a non-standardized pre-approved plan document, which received an opinion letter dated June 30, 2020, in which the IRS stated that the non-standardized pre-approved plan document was in compliance with applicable requirements of the Code. The Plan has not received a determination letter specific to the Plan itself and has been amended since adopting the non-standardized pre-approved plan document; however, the plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the Code.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Plan investments, which include 35,955 shares of the Company's common stock, are held by the Trustees of the Plan. Transactions involving the funds administered by the Company are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Certain administrative expenses are paid by the Plan or the Company. These transactions qualified as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

**9. RISKS AND UNCERTAINTIES**

The Plan invests primarily in Company stock. These securities are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the stock, it is at least reasonably possible that changes in their value will occur in the near term and that such changes could materially affect the participants' account balances, the amounts reported in the statements of net assets available for benefits.

**10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 4, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
