### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Joerns Healthcare LLC Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter- Plan Partial Termination**

As discussed in Note 1, the Company exited a majority of its rental business resulting in a partial plan termination. Our opinion is not modified with respect to this matter.

#### **1. Description of Plan**

The following description of Joerns Healthcare LLC Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

##### ***General***

The Plan is a defined contribution plan covering substantially all employees of Joerns Healthcare, LLC (the "Company" or "Plan sponsor"); other than union, leased, non-resident aliens with no earned income in the U.S., and intern/co-op students. The Plan was adopted effective January 1, 2008. It is a spin-off from the Sunrise Medical, Inc. Profit Sharing/Savings Plan (the "Sunrise Plan"), which was adopted by the Company on December 24, 2007. Employees become eligible to participate in the Plan after completing 3 months of service, except part-time, temporary, and seasonal employees, who become eligible to participate in the plan on the first day of the calendar month following the completion of a 12-month period of employment during which he or she is credited with at least 1,000 hours of service. Under the SECURE Act of 2019, any employees who are age 21 and complete 500-999 hours in three consecutive 12-month periods, become eligible to make employee deferrals effective January 1, 2024. Secure 2.0 Act of 2022 shortens that period to two consecutive 12-month periods effective January 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In late 2023 and early 2024, Joerns, LLC exited the majority of its rental business. This led to large reductions in the Company workforce. In some markets, small portions of the business were sold to DME Express, MasVida and others. All impacted participants were made 100 percent vested in any unvested accounts. Additionally, on March 29, 2024, the Company foreclosed on its parent company Joerns Woundco Holdings, Inc. and some other subsidiaries, and the remainder of the capital business and a small portion of the remaining rental business was restructured under Joerns Healthcare, LLC, which is the Plan Sponsor effective as of May 22, 2023.

##### ***Contributions***

Each year, participants may make pre-tax and Roth contributions up to 90 percent of compensation not to exceed the annual maximum allowed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company provides a safe harbor matching contribution equal to 100 percent of the first 3 percent then 50 percent of the next 2 percent, not to exceed 5 percent of participant's compensation during 2024. The Company may also contribute discretionary non-elective contributions equal to a percentage determined by the Company's Board of Directors. To be eligible for the discretionary non-elective contributions, a participant must have been credited with 1,000 hours of service during the plan year and be employed on the last day of the plan year. Allocation of non-elective contributions are to be made in proportion to all eligible participants' compensation. There were no discretionary non-elective contributions for the year ended December 31, 2024. All contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with participant contributions, the Company's safe harbor matching contribution, and allocations of discretionary employer non-elective contributions, and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various collective investment trust funds, mutual funds, self directed brokerage accounts, and a guaranteed investment contract as investment options for participants.

#### ***Vesting***

Participants are fully vested in their salary deferral, safe harbor employer contributions, any matching contributions made after January 1, 2017, and rollover contributions plus actual earnings (losses) thereon.

Participants with an employment date prior to January 1, 2008, are fully vested in Company matching contributions, plus actual earnings (losses) thereon. All other participants hired after December 31, 2007 vest at a rate of 25 percent after two years of service and are 100 percent vested in the Company's discretionary non-elective contributions and discretionary matching contributions made before January 1, 2017, after five years of service. Legacy RecoverCare and Joerns, LLC employees vest 20 percent per year after one year of service and are 100 percent vested after five years of service on all contributions made prior to January 1, 2017.

#### ***Notes Receivables from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. Loans may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2 percent. The interest rates on existing loans range from 5.25 percent to 10.50 percent. Principal and interest are paid ratably through payroll deductions.

#### ***Benefit Payments***

Upon termination of service due to death, disability, or retirement, a participant or their beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions out of the participant's elective deferral and rollover contributions accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

#### ***Forfeited Accounts***

At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$79,625 and \$75,842 respectively. No forfeitures were used during 2024.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value except for the group annuity contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded once there is a distributable event. During 2024, the Plan deemed \$4,232 in loans to be distributed for tax purposes.

***Benefits Paid to Participants***

Benefits are recorded when paid.

***Administrative Expenses***

The Company absorbs various plan expenses. Certain plan administrative expenses are paid by the Plan and may be offset with plan forfeitures. Loan and distribution fees as well as per capita recordkeeping fees are charged directly to the participant's account. The Plan participates in an agreement with TransAmerica Life Insurance Company ("TLIC"), where excess revenue and plan credits may be returned and deposited into an unallocated ERISA Budget Account ("EBA") held within the Plan. The amounts in the unallocated EBA may be used to pay reasonable and necessary Plan expenses. There were \$130,903 and \$126,940 of unallocated funds in the EBA as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the Plan used approximately \$35,400 from the EBA to pay for advisory costs.

**3. Unaudited Information**

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to related information in the financial statements and supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1-** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2-** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3-** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Registered investments are mutual funds which are valued at the daily closing price as reported by the funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

*Collective Investment Trust Funds:* Valued based on the unit value as reported by the custodian, which is determined as of the close of each business day. Participants' units are issued and redeemed at unit value at the end of each day. These investments are recorded at their net asset value as a practical expedient.

*Self Directed Brokerage Accounts:* Participants may invest in mutual funds through a brokerage window in the Plan. Those mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **7. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **8. Tax Status**

The Plan has received an opinion letter dated June 30, 2020, that the Plan Document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has since been amended; however, the Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

#### **9. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are mutual funds, collective investment trust funds, and a stable value contract managed by Reliance Trust Company and TLIC. Therefore, transactions with these parties qualify as party-in-interest transactions. The Plan paid \$120,868 in fees to these parties during the plan year.

#### **10. Group Annuity Contract**

The Plan invests in a fully benefit-responsive investment contract with Transamerica, where Transamerica maintains the contributions in a general account ("Stable Fund"). Transamerica credits the account with participant contributions and earnings and charges the account for participant withdrawals and administrative expenses. The issuer contractually must repay the principal and a specified interest rate that the issuer guarantees to the Plan.

The Stable Fund consists of stable fund segments based on the date the Stable Fund receives contributions. Transamerica establishes a guaranteed rate of interest for each segment and credits a rate of interest at least equal to the guaranteed rate for that Stable Fund segment until the Stable Fund segment maturity date. On the Stable Fund segment maturity date, the guaranteed rate of interest for that Stable Fund segment will expire. Stable Fund segments mature at the end of each calendar year. Upon written notice Transamerica will transfer the amount in that Stable Fund segment to any of the investment funds maintained under the contract. If Transamerica does not receive written notice from the contract holder prior to the Stable Fund segment maturity date, Transamerica will automatically transfer the amount in the Stable Fund segment to a successor Stable Fund segment. Quarterly, Transamerica declares an interest rate for the Stable Fund segment established for contributions received during the quarter and guarantees the interest rate until the end of the calendar year. At the end of the year, the Stable Fund combines the quarterly segments into one segment for that year. Annually, Transamerica declares an interest rate for the Stable Fund segments for each prior year that still has a balance.

The Stable Fund is reported at contract value because it meets the criteria of a fully benefit-responsive contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Transfers from the Stable Fund elected by the Plan are subject to a market value adjustment. However, transfers from the Stable Fund at a Stable Fund segment maturity date will not be subject to a market value adjustment. Certain events may limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include (1) the Plan no longer constituting a tax qualified plan according to Section 401(a) or 404(a) of the Code; (2) Transamerica determining that it can no longer continue to provide benefits under the contract because of a change in the Plan; (3) Transamerica does not receive deposits as described in the contract for three consecutive contract years; (4) Transamerica receives direction from the Plan to transfer assets outside of the contract, and such outside fund or funding vehicle is not available under the entities listed in the attachment to the contract; (5) deposits are made to any fund that is not included in the contract or is not available under the entities listed in the attachment to the contract; (6) Transamerica is informed that Transamerica Retirement Solutions has received, or has given, notice that Transamerica Retirement Solutions will no longer be providing services to the Plan; or (7) in the opinion of Transamerica, the Plan violates any provision of the contract. The Company does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

Either the Plan or Transamerica may suspend the contract by giving written notice. Upon receipt of such written notice, the contract is immediately suspended. Transamerica is not permitted to pay or transfer the value of the contract, without consent from the Plan, prior to the scheduled maturity date. Upon suspension of the contract the Plan shall elect, prior to the date of transfer, one of two options regarding payment of the value of the Stable Fund:(a) Transamerica will pay the value of each Stable Fund segment on each applicable Stable Fund segment maturity date or (b) Transamerica will pay the balance of the Stable Fund to the contract holder or designated payee in a single sum. Any such payment may be subject to a market value adjustment.
