Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Monarch Enterprises, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Monarch Enterprises, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Monarch Enterprises, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is being operated to cover all employees who have obtained the age of eighteen and completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is sponsored by Monarch Enterprises, Inc. (the Company) and covers various subsidiaries.

The effective date of the plan was January 1, 1992. It was restated effective November 1, 2008, with the adoption of the Fidelity Management Trust Company prototype plan. Plan amendment No. 1 was executed January 8, 2010 adopting provisions of Fidelity's volume submitter defined contribution plan (Fidelity Basic Plan Document No. 14).

The Plan was amended in November 2019 to reflect the statutory changes related to the Disaster Tax Relief and Airport and Airway Extension Act of 2017 (Disaster Relief Act), the Tax Cuts and Jobs Act of 2017 (TCJA), the Bipartisan Budget Act of 2018 (BBA), and Code Sections 401(k) and 401(m) 2019 Final Hardship Regulations and any related guidance.

Contributions

Participants may elect to defer a percentage or flat dollar amount of their eligible compensation, not to exceed an amount determined under Section 415(d) of the Internal Revenue Code (IRC) each year. Participants may elect either pre-tax or taxable (Roth) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company contributes 25 cents of every dollar of deferred compensation up to 3% of eligible compensation. Effective January 1, 2024, the Company increased this rate to 35 cents of every dollar of deferred compensation up to 3% of eligible compensation.

Discretionary Company Contribution - Profit Sharing

The Company may also make discretionary contributions on behalf of certain groups of participants. Discretionary profit sharing contributions generally will be allocated to participants based on the ratio of the individual participant's compensation to compensation for all participants in the applicable group. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Participant accounts are credited with participant contributions, allocations of the Company's matching and discretionary contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferral and rollover contributions plus actual earnings. The vesting schedule for the Company's contributions and discretionary contributions and related earnings is as follows:

A year of service is defined as a plan year which the employee has twelve months of service. Benefits are 100% vested upon death or obtaining normal retirement age of 65.

Forfeitures

Participant forfeitures may be used to pay the Plan's administrative expenses. Any excess may then be used to reduce certain Company contributions. Forfeiture balances as of December 31, 2024 and 2023 were \$7,055 and \$4,412, respectively. Forfeitures used to pay the administration expenses of the Plan during 2024 were \$1,786.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Loan terms may range from one to five years or longer for the purchase of a primary residence. The loans mature at various dates through July 2029. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment Of Benefits

Upon separation of service due to termination of employment, death, disability, or retirement, participants or beneficiaries may receive their benefits in the form of a lump-sum payment, systematic withdrawals, or direct rollover to another qualified plan. Account balances under \$5,000 will be automatically distributed by Fidelity to the participant.

Hardship Withdrawals

Hardship withdrawals are available only to the extent that the participant has no other financial resources to meet a financial need as defined in the Plan and established IRC provisions. The minimum withdrawal amount is \$500 and is limited to the participant's salary deferral and rollover contributions and earnings thereon and cannot exceed the amount needed.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions made on their behalf among various investment options. Participants may change their contribution investment options and transfer balances at any time.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. The Company paid certain administrative expenses during 2024. Investment related expenses are included in net appreciation of fair value of investments.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America. Contributions and realized investment earnings are recognized when earned and expenses are recognized when resources are used and a liability is incurred.

Investment Valuation And Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest incomes is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate that will not be collected. This assessment considers historical experience, current conditions, and when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Excess contributions payable for the years ended December 31, 2024 and 2023 were \$9,133 and \$14,596, respectively.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds And Money Market Fund

Valued at the daily closing price as reported by the fund. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Security and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Income Tax Status

The IRS has determined and informed the Plan by a letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving this letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes the plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
