Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2023 Financial Statements

We have performed audits of the accompanying financial statements of Diversified Trust Company, Inc. 401(k) Profit Sharing and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Diversified Trust Company, Inc. 401(k) Profit Sharing and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Diversified Trust Company, Inc. 401(k) Profit Sharing and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Diversified Trust Company, Inc. 401(k) Profit Sharing and Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees who are twenty-one years of age or older. Employees can participate in employee deferrals and employer’s Safe Harbor nonelective contributions immediately upon hire, if they meet the age requirement. Employees must complete twelve (12) consecutive months of service to qualify for discretionary matching and profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for participant and employer contributions. Participants may contribute up to 100% of compensation either as pre-tax 401(k) deferrals or Roth 401(k) deferrals, subject to Internal Revenue Code limitations. Participants who are 50 years of age or older during the Plan year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for safe harbor nonelective contributions equal to 3% of compensation. The Company may also make discretionary matching and profit-sharing contributions to the Plan in amounts determined by the Company. For the year ending December 31, 2024 and 2023, the plan has no other matching or profit-sharing contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings. Allocations are based on a participant’s earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the allocation of their investments among the options provided by the Plan.

Notes Receivable from Participants

The Plan includes a loan feature, which allows a participant to borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment periods range from one to five years. A participant may have no more than two loans outstanding at any time. The loans are collateralized by the balance in the participant’s vested account and bear interest at one percent over the prime interest rate. The interest rate established at the time of the loan remains consistent during the entire term of the loan.

Forfeitures

Forfeited accounts of non-vested terminated participants are first used to pay Plan’s administrative costs and any remaining is then used to reduce employer contributions. There were no unused forfeitures as of December 31, 2024 and 2023. No forfeitures were used for the year ended December 31, 2024.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination, the participant will receive one lump-sum payment equal to the vested interest in his or her account. Normal retirement age is 65. Partial withdrawals by a participant while employed are limited to those requested upon the attainment of age 59 ½ as defined by the plan document and those requested due to events of financial hardship as defined by the plan documents.

Vesting

Participants are immediately vested in all employee and safe harbor non-elective contributions plus actual earnings thereon. Vesting in any employer matching and profit-sharing contributions portion of their accounts thereon is based on years of service as follows:

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Recordkeeping and other administrative fees may be charged directly to the participant's account and are included in administrative expenses. Additional fees are charged to participants based on their use of certain Plan features. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual basis of accounting.

The Plan's investments are stated at fair market value as defined by generally accepted accounting principles. See Note 3 for disclosure of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains or losses, and the unrealized appreciation (depreciation) on investments.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed loan distributions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefits are recorded when paid.

Date of Management's Review

The plan sponsor evaluated the Plan's December 31, 2024 financial statements for subsequent events through September 2, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at net asset value of shares held by the plan at year end.

Limited partnerships: Valued at the Plan’s proportional share of the net asset value (NAV) reported by the underlying entities. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

These investments consist of eleven limited partnerships; each formed to pool funds for investment in private equity investments. The investment manager is required to pursue an investment strategy of selecting funds in the private equity categories of venture capital, buyout, and opportunistic.

NOTE 4 – PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Plan assets will be used solely to provide benefits for participants.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Diversified Trust Company, Inc, the Plan Sponsor, serves as investment manager for private equity funds in the amounts of \$2,959,082 and \$2,830,361 as of December 31, 2024 and 2023, respectively. Certain other investments are managed by John Hancock Life Insurance Company, the recordkeeper and asset custodian. Therefore, these transactions qualify as party-in-interest transactions. Certain plan expenses that are paid directly by the plan sponsor also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of certain investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 7 – TAX STATUS

The IRS issued an opinion letter on June 30, 2020, stating that Non-Standardized Pre-Approved Profit-Sharing Plan with CODA, which the Plan adopted, qualifies under Section 401(a) of the Internal Revenue Code (IRC). Although the Plan has been amended, the Company has not applied for a determination letter from the IRC regarding the qualification of the Plan as it applies to the Company, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with requirements of the IRC and should qualify for tax-exempt status as of the financial statement date. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

NOTE 8 – SUMMARY OF INFORMATION CERTIFIED BY ASSET CUSTODIAN
