## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Marker Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Marker Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of The Marker Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of The Marker Group, Inc. and Marker Business Records, L.L.C. (together the “Company”) except union employees and nonresident aliens. Employees are eligible to participate on the first day of the quarter coinciding with, or following, the completion of one year of service and the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may elect to make pre-tax salary deferral contributions to the Plan of up to 100% of their eligible compensation, subject to certain limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for participants in a former employer’s qualified plan to contribute direct rollovers to the Plan.

The Company may make a discretionary matching contribution. For the year ended December 31, 2024, the Company elected to match 40% of each participant’s salary deferral contribution up to 4% of the participant’s eligible compensation each payroll period. The Company may also make a discretionary nonelective contribution to the Plan. For 2024, the Company did not make a discretionary nonelective contribution.

The Plan is participant directed and participants may change their contribution rates quarterly and investment options at any time.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as allocations of Plan earnings, and is charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are at all times fully vested in their participant and rollover contribution accounts and the appreciation or depreciation thereon. Vesting in the Company’s contributions portion of their accounts plus earnings thereon is based on years of service. Participants vest 20% per year after two years of service and are 100% vested after six years of service.

**Benefit Payments**

A participant shall be immediately vested upon death, retirement, or termination of employment due to permanent and total disability. Normal retirement age under the Plan is 65. Upon a participant's termination or retirement, the vested funds in the participant's account are available to be distributed in a lump-sum payment. The Plan also allows in-service and hardship distributions.

**Forfeitures**

Forfeitures of nonvested employer contributions are used to pay Plan administrative expenses or reduce employer contributions. The forfeiture balance at December 31, 2024 and 2023 was \$7,403 and \$5,454, respectively. Forfeitures in the amount of \$810 were used during 2024 to offset employer contributions.

Plan participants may borrow from their account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Notes are repaid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. The notes bear interest at the prime rate plus 2% at the date of the note and are secured by the participant's vested account balance to the extent of the principal amount of the note plus accrued interest.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all accounts and would receive benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investments**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from participants and employer contributions are recorded in the plan year in which participant contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, distributions, and investment management are charged directly to the participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE 3 - CONTRACT WITH INSURANCE COMPANY**

The Plan maintains a fully benefit responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya), the Voya Fixed Account. Voya maintains the contributions in a general account. The contract is included in the statements of net assets available for benefits at contract value, as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participants' withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (i) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

**NOTE 3 - CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The Voya Fixed Account does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets, and the amortization of any capital gains and/or losses realized on the sale of invested assets. The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts.

As of December 31, 2024 and 2023, the contract value of the investment in the Voya Fixed Account was \$211,981 and \$161,920, respectively. The crediting interest rate is based on a formula agreed upon with Voya, but may not be less than 1%.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Pooled Separate Accounts:* Valued at fair value based on account unit value (AUV) pricing as calculated by the annuity provider according to formulas described in the annuity contract. The pooled separate accounts own and hold the underlying mutual fund or collective trust shares, which are reported at their net asset value (NAV). The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported AUV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the accounts.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, an insurance company, certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year), except for participant loans, as of December 31, 2024, and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are in accounts managed by Voya. Voya investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - INCOME TAX STATUS**

The Plan has adopted a volume submitter profit sharing plan, which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the prototype document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - SUBSEQUENT EVENTS**

On June 17, 2025, the Plan was amended to allow participants to designate all or a portion of their deferral contributions as Roth elective deferrals.

Management has evaluated subsequent events through July 9, 2025, the date the financial statements were available to be issued.
