The following brief description of the CommunityBanc, Inc. Profit Sharing 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more comprehensive description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering the employees of CommunityBanc, Inc. (the “Company”). Employees are eligible for the plan the first day of the month coinciding or next following completion of age 18 or 90 days of service. The Plan includes a 401(k) before-tax savings feature, which permits participants to defer compensation under Section 401(k) of the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan’s Trustees are responsible for oversight of the Plan. The 401(k) Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Company’s Board of Directors.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, but may not exceed the dollar limit set by law, which was \$23,000 for the year ended 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan, including the Company’s common stock. The Company matches 100 percent of the first 5 percent of base compensation that a participant contributes to the Plan. The Company may also make a discretionary contribution, as determined on an annual basis, and may be an amount equal to either a percentage of compensation or a dollar amount. During the year ended December 31, 2024, there were no discretionary contributions made by the Company.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon units accumulated by each participant’s account. Units are apportioned based upon participant earnings. The benefit to which each participant is entitled is that which can be provided from the participant’s vested account.

Vesting – Safe Harbor Matching Contributions

Participants are 100% vested on all Safe Harbor matching contributions.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting – Discretionary Profit-Sharing Contributions

Vesting in the Company’s Discretionary Profit-Sharing Contribution is based on completion of credited service years. A credited service year is considered one in which the participant completed at least 1,000 hours of service. Participants become 20 percent vested after the second year of service and 20 percent for each of the succeeding four years. Participants become 100 percent vested after six years of credited service. At the Plan’s normal retirement age of 65, or in the event a Participant becomes disabled or dies, then the contributions become immediately 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant’s account and bear interest at a rate that is commensurate with the prime rate plus 1.0 percent at time of origination. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants must consent to any distribution when their vested account balance exceeds \$5,000. The value of the participant’s vested account balance shall exclude rollover contributions that were made to the Plan. Upon termination, if the participant does not make a timely election with respect to a cash-out distribution in an amount greater than \$1,000 but less than or equal to \$5,000, a direct rollover will be made. In addition, if the amount is under \$1,000, unless the participant instructs the rollover, the participant will receive payment less the applicable 20 percent federal income tax withholding.

Forfeitures

Forfeitures will be used to reduce any employer contribution, including employer contributions that are qualified nonelective contributions, qualified matching contributions, and ADP safe harbor contributions. At December 31, 2024 and 2023, there was no balance in the forfeiture nonvested account. During the year ended December 31, 2024, there were no forfeitures used to reduce employee contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Accounting Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

Subsequent Events

No subsequent events were identified through September 5, 2025, the date these financial statements were issued.

NOTE 3 – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

The following is a summary of certain information related to investments and notes receivable from participants as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, which were prepared by or derived from information provided by Ascensus Trust Company (custodian) and the Company's Accounting Department, and were furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following investments is complete and accurate. Such certification does not cover the CommunityBanc, Inc. common stock held by the Plan. The independent auditors performed auditing procedures with respect to these investments held by the Plan, which appear throughout the financial statements and supplemental schedule.

NOTE 3 – INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS (Continued)

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following investments and notes receivable from participants:

The custodian also certified the completeness and accuracy of \$287,911 of net appreciation in fair value of investments, \$199,079 of interest and dividend income, \$335,928 of capital gains, and \$6,462 of interest income on notes receivable from participants for the year ended December 31, 2024. CommunityBanc, Inc. common stock totaled \$782,100 and \$838,457 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, the net appreciation in fair value of CommunityBanc, Inc. common stock was \$45,582, and \$10,223 of interest and dividends related to the common stock, were not certified by the custodian.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their employer contributions.

NOTE 5 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan Administrator that the Plan and related trust are designed in accordance with applicable sections of the IRC by letter dated January 27, 2015. The letter states that the prototype and related trust are designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under the DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Participant loans held by the Plan reflect party-in-interest transactions. Additionally, certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Certain administrative costs, legal fees, and accounting fees are paid by the Company. In 2024, those fees total \$16,049.

At December 31, 2024 and 2023, the Plan held 17,189 and 19,499 shares of CommunityBanc, Inc. common stock, respectively, which is the common stock of the Plan Sponsor and is, therefore, a party in interest. Dividends in the amount of \$10,213 were received on shares of this stock for the year ended December 31, 2024.

NOTE 7 – FAIR VALUE MEASUREMENTS

The following disclosures show the hierarchal disclosure framework associated with the level of pricing observations utilized in measuring assets and liabilities at fair value. The three broad levels of pricing observations are as follows:

- Level I: Quoted prices are available in active markets for identical assets or liabilities as of the reported date.
- Level II: Pricing inputs are other than the quoted prices in active markets, which are either directly or indirectly observable as of the reported date. The nature of these assets and liabilities includes items for which quoted prices are available but traded less frequently and items that are fair-valued using other financial instruments, the parameters of which can be directly observed.
- Level III: Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

This hierarchy requires the use of observable market data, when available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash and Cash Equivalents

Cash and cash equivalents are comprised of cash and money market mutual funds that invest in short-term money market instruments. The Plan measures its cash and cash equivalent funds that are exchange-traded using the funds that are exchange-traded using the fund's quoted price, which is an active market.

CommunityBanc, Inc. Common Stock

The common stock is traded through a market maker. If the stock is traded on the valuation date, then it is valued at the price at which shares were last traded. If the stock was not traded on the valuation date, then it is valued at its bid price next preceding the close of business on the valuation date. At December 31, 2024, there was trading activity near the valuation date; therefore the stock was valued based on the price at the close of business at December 31, 2024. At December 31, 2023, there was trading activity near the valuation date; therefore the stock was valued based on the price at the close of business at December 31, 2023.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
