Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of New Mexico Mutual 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of New Mexico Mutual 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of New Mexico Mutual 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTE 1 DESCRIPTION OF PLAN

The following description of the New Mexico Mutual (the Company, Employer, Plan Sponsor, or Plan administrator) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

General and Eligibility

The Plan is a defined contribution 401(k) salary deferral and profit sharing plan covering substantially all employees of the Company upon reaching age 21 and completing one month of service during a Plan year. Upon meeting the requirements, employees are eligible to participate in salary deferrals, the Company matching contributions, and discretionary profit sharing contributions. The Plan covers the employees of New Mexico Casualty Company and Integrion Group as members of a controlled group. The Plan is subject to the provisions of ERISA. The Plan was restated effective January 1, 2023 to reduce the age of eligibility from age 21 to age 18.

Contributions

Participants may contribute either a whole percentage or dollar amount of their compensation either on a before-tax or after-tax Roth basis. However, the Internal Revenue Service (IRS) limits each participant's contributions to the Plan to \$23,000 for 2024. Participants who have attained age 50 by year-end may also make an additional catch-up contribution of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement arrangements.

The Company also contributes a safe harbor matching contribution of 100% of each qualified participant's elective deferral up to 4% and 50% on the next 2% of eligible compensation. Additional discretionary profit sharing amounts may be contributed at the option of the Company. The participant must be employed on Plan year-end to qualify for the discretionary profit sharing contribution. Employer contributions and participant compensation for matching purposes may be limited by the Internal Revenue Code (IRC).

The Company did not make any discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant has a Participant's Elective Account, with respect to their interest resulting from salary deferrals, the safe harbor matching contribution and the discretionary profit sharing contribution, and a Participant's Account, with respect to their interest resulting from other qualified nonelective contributions. Participant accounts are also credited or charged, when applicable, with net earnings, gains, losses, forfeitures, expenses, and appreciation or depreciation on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will be used to offset employer discretionary contributions, reduce Plan administrative expenses, and any remaining amount will be allocated as a match in the same Plan year. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,897 and \$-0-, respectively. Forfeitures for the year ended December 31, 2024, were \$1,882. Additionally, forfeitures of \$13 were used for payment of Plan administrative expenses.

Investment Options

Upon enrollment in the Plan, participants may direct their investments to several registered investment company (mutual funds) options. Participants may change their investment options periodically.

Payment of Benefits

Normal retirement age is 65 or the fifth anniversary of joining the Plan, if later. Upon retirement, disability or death, the participant or beneficiary is entitled to receive the full amount of the participant's account. Upon termination for any other reason, the participant is entitled to the amount of their nonforfeitable interest. The normal benefit form is a lump-sum distribution. In-service withdrawals, hardship withdrawals, and withdrawals for participants who have attained age 59½ are permitted. See Note 8 regarding money purchase plan distributions.

For terminating participants with vested balances less than \$1,000, such amounts are immediately distributed in cash. If the vested balance is over \$1,000 and less than \$5,000, such amounts are distributed to an IRA. If the vested balance is over \$5,000, a participant can elect payment in cash or a rollover into an individual retirement account (IRA) or the qualified plan of their new employer. If a terminating participant's vested balance is greater than \$5,000, the participant must consent to any distribution to be made. Effective January 1, 2024, the threshold for distributions without consent increased to \$7,000 in accordance with the provisions of the SECURE 2.0 Act.

Vesting

The balance in each Participant's Elective Account and safe harbor Employer match is fully vested at all times. Each participant has the following nonforfeitable interest for Employer discretionary profit sharing contributions in their Participant's Account:

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Valuation of Investments

The Plan values its investments at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices, when available, are used to value investments. Accordingly, the net unrealized appreciation or depreciation for the year is presented in the statement of changes in net assets available for benefits. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held during the year. The fair market value of investments is subject to ongoing fluctuation. The amount ultimately realized upon disposition may differ from the amounts reported in these financial statements.

Benefit Payments

Deductions for benefit distributions are recognized upon payment to the participant or beneficiary.

Operating Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Contributions

Contributions from participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events

The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued. Management believes that there are no material subsequent events that have arisen that would require accrual or disclosure in the accompanying financial statements.

NOTE 3 PLAN TERMINATION

Although it has not expressed an intention to do so, the Company may terminate the Plan for any reason, at any time, subject to the provisions of ERISA. If the Plan were terminated, the participants would become fully vested in their account balances.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value for assets and liabilities subject to a fair value measurement. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The IRS has determined and informed the Company by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC under the Volume Submitter Program. Although the Plan has been amended and restated since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

NOTE 5 TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by BOKF, NA; therefore, these transactions qualify as parties-in-interest transactions. Investment and management fees paid by the Plan to BOKF, NA for the year ended December 31, 2024, totaled \$33,753.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

NOTE 7 INFORMATION PREPARED AND CERTIFIED BY BOKF, NA

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

BOKF, NA, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and accrued income reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the investment information in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 8 MONEY PURCHASE PLAN

On December 31, 2004, the New Mexico Mutual Casualty Company Money Purchase Plan was merged into the New Mexico Mutual 401(k) Plan. The transferred net assets were recognized in the accounts of the Plan as of December 31, 2004, at their balances as previously carried in the account of the Money Purchase Plan.

Net asset records for the transferred Money Purchase Plan assets, by participants, will be maintained in order to comply with certain ERISA provisions. Those provisions are primarily related to Money Purchase Plan vesting components as follows:

Participants are subjected to a six-year graded vesting schedule. However, all participants have met the vesting requirements.

NOTE 8 MONEY PURCHASE PLAN (CONTINUED)

Upon retirement, or becoming permanently disabled, participants with a vested balance of \$5,000 or less will receive a lump-sum distribution. Participants with vested account balances in excess of \$5,000 will be distributed as monthly annuity payments, unless special consent and/or election is made otherwise within the provisions of the Plan. Upon death, the surviving spouse is designated by law to receive 50% of the deceased participant's vested balance, unless the surviving spouse elected otherwise, and will receive the death benefit payments in the form of an annuity. The remaining 50% can be designated to the surviving spouse or designated to a nonspouse designee. If a designated beneficiary other than the surviving spouse is named, the distribution will be made in a lump-sum.
